Forms received less than fifteen (15) business days prior to the defense date will not have the defense information included on the College of Graduate Studies website. If the defense will include any proprietary or potentially patentable subject matter, it should not be open to the public and should not be advertised as such. This form must accompany the *Intellectual Protection and Patent Sign-off* form.
