Biographical/Historical Sketch

Carol Bresnahan, previously known as Carol Menning, was hired as a faculty member in the University of Toledo's History Department in 1985. Before working at UT, she earned her AB from Smith College and went on to earn her AM and Ph.D. from Brown University. Then she briefly worked on the American Council on Education at the University of Illinois.

While at UT, Bresnahan was a professor of history, chair of the Faculty Senate, and the vice president for policies and programs. She held these positions until 2007, when she left the University. Currently, as of 2008, she is provost and vice president for academic affairs at Rollins College in Florida.
