Professional Development Program

Professional Development Program

Student Instructions

The College of Law designed the Professional Development Program to help you build your professional identity and network throughout your legal education career. Each year you will be required to complete certain mandatory activities. Additionally, throughout law school you will be required to attend networking and skills events, complete pro bono awareness tasks, and participate in career exploration activities. Inside your designated class folder will include the activity categories and numbers of activities required for each class year. This Professional Development Program is a floor, not a ceiling; OPD encourages you participate in as many of the activities as your schedule allows.

How it works:

Mandatory Activities: Mandatory activities include class level specific programming required by the Office of Professional Development. These meetings will be announced in the OPD newsletter and/or via emails sent by OPD staff. Some activities may be "on-demand" or web-based. Additionally, these activities will likely require pre- or post-work such as filling out a professional identity assessment or updating your application documents.

Networking and Skills Events: These are events sponsored, or co-sponsored by OPD, and generally involve participation by Toledo Law alumni or friends of the law school. OPD staff will publicize notice of events that qualify under this category in the OPD newsletter and/or by email.

Pro Bono Awareness Tasks: Ohio, along with many other states, encourages pro bono work as part of a lawyer's professional duties to the public and justice system. Therefore, these tasks are not only a resume builder, but they will help kick-start a commitment to your professional duty as lawyers. The Ohio Supreme court states in the Preamble to the Ohio Rules of Professional Conduct: "...[A]ll lawyers should devote professional time and resources and use civic influence to ensure equal access to our system of justice for those who because of economic or social barrier cannot afford or secure legal counsel." It is your responsibility to find pro bono clinics and volunteer to help, or find an attorney to work with or shadow. OPD is happy to help in your search but will not be responsible for placement in these opportunities. OPD may advertise pro bono projects and other opportunities via the newsletter or emails.

Professional Exploration: Professional exploration tasks will aid in determining your professional identity and long-term career path. Exploring the profession can be done on a large scale, by attending a legal conference, for example. Or on a smaller scale, such as a one-on-one informational interview. It is your responsibility to find outside events related to your areas of interest, set up informational interviews, or arrange observation of a legal proceeding. OPD is happy to help in your search.

Tracking: This webcourse should be used tracking your completed activities. You are responsible for reporting the activities that you completed. The Office of Professional Development will track attendance at all mandatory *in-person* activities. Note, if you complete a mandatory activity on-demand, you are responsible for tracking it in the "2019-2020 Professional Development Program (PDP)" webcourse.

Turn-in: You are required to report each Networking and Skills, Pro Bono Awareness, and Professional Exploration activity by end of the semester in which you complete the number of credits for each class level. This is your "reporting period." Reporting is done via the "2019-2020 Professional Development Program (PDP)" webcourse, and should be done in the appropriate drop-box or questionnaire for each activity.

For example, if you are a full-time 1L student who started in August 2019 and completed 30 hours by the end of Spring 2020, you would report your 1L activities by the end of the Spring 2020 semester for the "1L reporting period." If you are a part-time 1L student who started in August 2019 and completed 30 hours by the end of Spring 2021, you would report your activities by the end of the Spring 2021 semester.

2-year JD students will only complete the first and second reporting periods.

PUBLIC SERVICE COMMENDATION ANNOUNCEMENT

The Office of Professional Development has made changes for Spring 2020 Commendation due to the COVID-19 Pandemic.

For students graduating in Spring 2020, completing 25+ hours of unpaid law-related public service work will earn the Spring 2020 Commendation.

Students not graduating in Spring 2020, and who worked less than 30 hours, can combine their spring hours with unpaid law-related public service work in summer-fall 2020 to earn the Fall 2020 Public Interest Commendation. All eligible students who completed 30 hours or more of unpaid law-related public service work in the spring may still earn the Spring 2020 Commendation. Students who need to combine spring -summer-fall 2020 hours should still submit their spring time reports as soon as possible for tracking.



The Shumaker Diversity Scholarship provides, in Shumaker, Loop & Kendrick, LLP's discretion, a \$7,500.00 scholarship to one (i) or two (2) outstanding first or second year law students who are enrolled at an ASA accredited law school and who participate in the firm's summer associate program, to assist in offsetting his or her law school expenses. The scholarship is in addition to the salary paid to the student for his or her Summer Associate position.

The Shumaker Diversity Scholarship is available to students who are members of underrepresented or minority groups. Applicants must have outstanding undergraduate and law school academic <u>resdentials</u>, and demonstrated leadership abilities and community involvement. Mike Eidson Scholarship

The American Association for Justice (AAJ) promotes justice and fairness for injured persons, safeguards victims' rights—particularly the right to trial by jury—and strengthens the civil justice system through education and disclosure of information critical to public health and safety. AAJ fights daily to protect the civil justice system against corporations and powerful individuals.

The Mike Eidson Scholarship Fund was established by the AAJ Women for Justice Education Fund in 2008, in honor of AAJ past President Mike Eidson, whose vision and generosity inspired it. RULES FOR THE 2020 BROWN AWARD OF \$10,000 FOR EXCELLENCE IN LEGAL WRITING

The Judge John R. Brown Scholarship Foundation is pleased to announce the twenty-seventh annual Brown Award. The Award honors excellence in legal writing in American law schools. Any law student currently enrolled in an accredited law school in the United States seeking a J.D. or LL.B degree is eligible to submit a paper for the Award. The amounts awarded for 2020 will be as follows:

\$10,000 First Place, \$5,000 Second Place, \$3,000 Third Place, \$1,000 Finalist, \$1,000 Finalist, and

\$5,000 to the Scholarship Fund selected by the Dean of the law school in which the First Place candidate is enrolled.

In order to be considered, two copies of a current legal writing must be submitted to the Foundation c/o Kenneth G. Engerrand, Brown Sims, P.C., Tenth Floor, 1177 West Loop South, Houston, Texas 77027-9007. The article must be accompanied by a letter of recommendation from a law school faculty member or legal professional other than the author of the paper. Only one paper may be submitted on behalf of any student, and only one paper may be sponsored by any faculty member or legal professional. The submission must be postmarked no later than May 29, 2020. The submission must contain a separate sheet containing the title of the paper; the name, physical address, telephone number, and email address of the student; and the name, title, physical address, and email address of the student's sponsor. There is no page limitation or restriction on the topic except that the writing must be on a legal subject. Papers that have been submitted to a law review for publication are eligible, but the submission must be of the paper in its form before it was edited by anyone other than the author.

The Foundation will appoint a final judging panel consisting of a law school dean, a federal judge, and a law school professor. The Foundation will not return any material submitted to the Foundation. The 2020 recipient of the Brown Award will be notified by December 4, 2020, and listed with the other finalists at the website

Professor Boske became known and beloved world-over for his publication of The Alternative Newsletter, a resource guide on ADR published quarterly. It was in its tenth year when Professor Boskey die in 1999. The publication provided a comprehensive yet very accessible window into the diverdimensions of the ADR field. In many respects, Professor Boskey-through the alternative newsletter-was the voice of the ADR community.

Purpose of the Boskey ADR Writing Competition

The purpose of the competition is to create greater interest in the field of dispute resolution among law students.

The essay may address any aspect of dispute resolution practice, theory or research that the contestant chooses. Essays must be limited to 15-30 typewritten pages, including footnotes or endnotes. The text of the essay must be double-spaced, with twelve-point font and one inch margins.
