Professional Development Program

Purpose of the Professional Development Program

The College of Law designed the Professional Development Program to help you build your professional identity and network throughout your legal education career. Each year you will be required to complete certain mandatory activities. Additionally, throughout law school you will be required to attend networking and skills events, complete pro bono awareness tasks, and participate in career exploration activities. Inside your designated reporting cycle folder will include the activity categories and numbers of activities required for each reporting cycle. The Professional Development Program is a floor, not a ceiling; OPD encourages you participate in as many of the activities as your schedule allows.

How it works

Reporting cycles are based on the number of credits you have earned at the end of the semester. For example, you must have completed all activities listed in the "0 – 30 Credits Reporting Cycle" between the time you start law school and the semester in which you earned your 30th credit. For the "31 – 60 Credit Reporting Cycle" complete all activities listed between the semester you earned your 31st credit and your 60th credit. And for the "61+ Credits Reporting Cycle" between the semester you earned your 61st credit and the semester that you graduate. For some students, cycles may overlap. You may begin working on the next reporting

cycle once you've completed the last one if your semester bridges the reporting cycle. I.e. you start a semester with 27 credits and end it with 42 credits, you can finish the 0-30 reporting cycle, then start working on the 31-60 reporting cycle activities.

Mandatory Activities: Mandatory activities include class level specific programming required by the Office of Professional Development. These meetings will be announced in the OPD newsletter, emails sent by OPD staff, and/or on TLCN. Activities may be web-based or in-person if safety standards allow. Additionally, many of these activities require pre- or post-work such as updating application documents or certify completion of an on-demand video.

<u>Networking and Skills Events:</u> These events are often sponsored or co-sponsored by the Office of Professional Development, Alumni Affairs, or a Bar Association. They are designed to help you build your networking skills. Events can take place virtually or in person (when allowed).

<u>Professional Exploration</u>: Professional exploration tasks will aid in determining your professional identity and long-term career path. Exploring the profession can be done on a large scale, by attending an in-person or virtual legal conference, for example. Or on a smaller scale, such as a one-on-one informational interview. It is your responsibility to find outside events related to your areas of interest, set up informational interviews, or arrange observation of a legal proceeding. OPD is happy to help in your search.

Pro Bono Awareness Tasks: Ohio, along with many other states, encourages pro bono work as part of a lawyer's professional duties to the public and justice system. Therefore, these tasks are not only a resume builder, but they will help kick-start a commitment to your professional duty as lawyers. The Ohio Supreme court states in the Preamble to the Ohio Rules of Professional Conduct: "...[A]II lawyers should devote professional time and resources and use civic influence to ensure equal access to our system of justice for those who because of economic or social barrier cannot afford or secure legal counsel." It is your responsibility to find pro bono clinics and volunteer to help, or find an attorney to work with or shadow. OPD is happy to help in your search but will not be responsible for placement in these opportunities. OPD may advertise pro bono projects and other opportunities via the newsletter or emails. Students in the 0 – 30 credit reporting cycle are not required to complete a Pro Bono Awareness Task. Students in the 31 – 60, or 61+ reporting cycle may report participation in one of the listed legal clinics. Note: the Public Service and Corporate Counsel Externship Clinics do not count.



The NBPA, established in 1983, is a professional member organization comprised of over 800 prosecutors. Our mission is to recruit, train, and advance the careers of minority attorneys as prosecutors at all levels of government. Our annual convention serves not only as a job fair forum, but as a comprehensive legal training program for prosecutors. The 37th Annual Conference will run from August 15, 2021 – August 21, 2021.

The Job Fair begins at 8:00 am with registration and check-in; interviews commence at 9:00 am. There is no registration fee for law students and 2021 law school graduates during the general registration period. The general registration fee is \$25 for experienced attorneys. On July 1, 2021, the registration fee increases to \$50 for law students and 2021 law school graduates, and \$100 for experienced attorneys. Registration closes on July 23, 2021.

2021 Equal Justice Works Conference and Career Fair October 21-23, 2021

The Equal Justice Works Conference and Career Fair is the largest national public interest legal career fair, bringing together more than 200 public interest employers to conduct interviews for full-time positions and internships.

More than 1,500 law students from over 160 law schools attend the event to participate in workshops and informal "table talk" discussions, receive résumé advice, and network with fellow law students and legal professionals.

Registration

Student registration for the 2021 Conference and Career Fair will open on Wednesday, August 11. The base registration fee for all three days of the event will be \$25.00 (this is a non-refundable fee). Attendees will be required to register for the event before applying for available job opportunities. The event will be hosted on our virtual event platform, Pathable.

Deadline for Applying to Prescheduled Interviews

Students must apply for prescheduled interviews by Monday, September 13 at 11:59 p.m. ET. Employers will then have until Thursday, September 23 to submit their interview selections.

Prescheduled Interview Sign-Up

Students will have been notified of their status for prescheduled interviews (unless otherwise contacted) and will be able to sign-up for specific interview times beginning on Friday, September 24. Interview times must be finalized by Monday, October 4 at 11:59 p.m. ET.

DOOLIN PRIZE FOR UNDERGRADUATE STUDENTS, GRADUATE STUDENTS, LAW STUDENTS AND GRADUATE LAW STUDENTS

This competition is open to any student enrolled in an accredited college, in a graduate or undergraduate program, First, second, and third prizes in the amounts of \$1,000, \$750 and \$500.00 will be awarded. The winning entry will be published in the 2021 Symposium book. Second and third place entries will be published if space permits.

HARGRAVE PRIZE FOR WRITINGS BY THE SOVEREIGNTY SYMPOSIUM FACULTY

Cash awards will be given in the amounts of \$1,500, \$1,000 and \$750.00 for the best three original and previously unpublished papers included in the Symposium publication.

HAGER PRIZE FOR UNDERGRADUATE STUDENTS, GRADUATE STUDENTS, LAW STUDENTS AND GRADUATE LAW STUDENTS

The Hager Prize of \$1,000 will be awarded for the best writing on the ICWA or any legal issue concerning Native American juveniles. The winning entry will also be published in the 2021 Symposium book.

REQUIREMENTS

The entries in the writing competitions must not be more than fifty (50) single-spaced pages in length. The paper used shall be 8-1/2" x 11" in size. The title of the paper, the name of the author and a current mailing address and telephone number must be placed on a cover page. Only the title of the paper should appear at the top of the first page of the text. The author's name should appear on the cover page only. Papers must be submitted in Word or Word Perfect format. E-mail the formatted version to kyle.shifflett@oscn.net. Use a 12-point font in Times New Roman format. Again, the document should be single spaced. The left and right margins must be 2"; the top and bottom margins must be 1.5".

Law School Diversity Scholarship Eligibility Requirements

Applicants must meet the following criteria:

- Recipient is a member of an ethnic or racial minority or any individual who demonstrates a defined commitment to issues of diversity within their academic career.
- Recipient is a U.S. citizen currently attending an accredited law school within the United States.
- Academic achievement as reflected by a minimum 3.0 GPA and have completed at least one semester of classes at an accredited law school.

Law School Diversity Scholarship Applications Requirements

In order to apply for the Buckfire & Buckfire, P.C. 2021 Law School Diversity Scholarship Program an applicant must submit the following items on or before Oct. 1, 2021:

- A completed scholarship application form. (Located <u>here</u>)
- A one-page typed essay describing how you have utilized your time promoting ethnic diversity within your community. Alternatively, you may write about how you will use your law degree to promote ethnic diversity in the future.

A certified, official copy of law school transcript.

Application Requirements:

In order to apply for the 2021 Boyk Law Veteran Scholarship, an applicant must submit the following items:

- An up-to-date resume with current contact information
- 750-1,000 word essay addressing at least two (2) of the following questions:

- Tell us the story of YOU. What is driving you to go to college and what would you like to do with your degree?
- How has being a Veteran or the child of a Veteran affected your life?
- If you could give advice on joining the Armed Forces or advice to other children of Veterans, what would that advice be?
- A certified copy of college or university transcript.
- We would prefer (but do not require) the applicant to be from/currently living in the state of Ohio

The winner of the 2021 Boyk Law Veteran Scholarship will be announced by Veteran's Day, November 11, 2021.

One student will receive one \$2,000 scholarship to be used exclusively toward college or university tuition or school-related expenses. The winner will be notified by phone on November 11, 2021. A check will be made out to the winning student's college or university.
