## **Reminders/Announcements**

May Graduates: As part of your graduation processing requirements, you must complete the Office of Professional Development Graduate Exit Survey between Monday April 4, 2022 and Friday, April 22, 2022. You can do the survey either in-person at OPD (Suite 1030) or via WebEx. To schedule an appointment via WebEx, email Laura, Katie or OPD. The survey should take approximately 15-20 minutes to complete. Summer graduates will complete this requirement in July 2022.

- Clinics and Externships: Please note that even though scheduling will soon be open for the entire academic year, clinics and externships are not included in this registration cycle and will still occur each semester after the application deadline passes and placements are confirmed.
- **NCBE** price increase: Effective July 1, 2022, the investigative services fee will be \$275 for law students (currently \$250).

### **Professional Development Program**

### Purpose of the Professional Development Program

The College of Law designed the Professional Development Program to help you build your professional identity and network throughout your legal education career. Each year you will be required to complete certain mandatory activities. Additionally, throughout law school you will be required to attend networking and skills events, complete pro bono awareness tasks, and participate in career exploration activities. Inside your designated reporting cycle folder will include the activity categories and numbers of activities required for each reporting cycle. The Professional Development Program is a floor, not a ceiling; OPD encourages you participate in as many of the activities as your schedule allows.

#### How it works

Reporting cycles are based on the number of credits you have earned at the end of the semester. For example, you must have completed all activities listed in the "0 – 30 Credits Reporting Cycle" between the time you start law school and the semester in which you earned your 30th credit. For the "31 – 60 Credit Reporting Cycle" complete all activities listed between the semester you earned your 31st credit and your 60th credit. And for the "61+ Credits Reporting Cycle" between the semester you earned your 61st credit and the semester that you graduate. For

some students, cycles may overlap. You may begin working on the next reporting cycle once you've completed the last one if your semester bridges the reporting cycle. I.e. you start a semester with 27 credits and end it with 42 credits, you can finish the 0-30 reporting cycle, then start working on the 31-60 reporting cycle activities.

<u>Mandatory Activities</u>: Mandatory activities include class level specific programming required by the Office of Professional Development. These meetings will be announced in the OPD newsletter, emails sent by OPD staff, and/or on TLCN. Activities may be web-based or in-person if safety standards allow. Additionally, many of these activities require pre- or post-work such as updating application documents or certify completion of an on-demand video.

<u>Networking and Skills Events:</u> These events are often sponsored or co-sponsored by the Office of Professional Development, Alumni Affairs, or a Bar Association. They are designed to help you build your networking skills. Events can take place virtually or in person (when allowed).

<u>Professional Exploration</u>: Professional exploration tasks will aid in determining your professional identity and long-term career path. Exploring the profession can be done on a large scale, by attending an in-person or virtual legal conference, for example. Or on a smaller scale, such as a one-on-one informational interview. It is your responsibility to find outside events related to your areas of interest, set up informational interviews, or arrange observation of a legal proceeding. OPD is happy to help in your search.

Pro Bono Awareness Tasks: Ohio, along with many other states, encourages pro bono work as part of a lawyer's professional duties to the public and justice system. Therefore, these tasks are not only a resume builder, but they will help kick-start a commitment to your professional duty as lawyers. The Ohio Supreme court states in the Preamble to the Ohio Rules of Professional Conduct: "...[A]II lawyers should devote professional time and resources and use civic influence to ensure equal access to our system of justice for those who because of economic or social barrier cannot afford or secure legal counsel." It is your responsibility to find pro bono clinics and volunteer to help, or find an attorney to work with or shadow. OPD is happy to help in your search but will not be responsible for placement in these opportunities. OPD may advertise pro bono projects and other opportunities via the newsletter or emails. Students in the 0 – 30 credit reporting cycle are not required to complete a Pro Bono Awareness Task.

Students in the 31 - 60, or 61+ reporting cycle may report participation in one of the listed legal clinics.

Michigan Immigrant Rights Center and partners seek <u>pro bono attorneys and law students to help file asylum applications for Afghans who were evacuated from Afghanistan after the Taliban takeover of Kabul.</u>

Training and technical assistance will be provided to any attorneys who are able to volunteer. Interested attorneys and law students should <u>register</u> to attend the virtual <u>Pro Bono Afghan Asylum Kick-Off</u> event happening online **Tuesday March 22 at 1 p.m**.

The U.S. government evacuated thousands of Afghans to the United States, but has not provided a clear path to permanent legal status. Unless Congress passes the Afghan Adjustment Act, the best way for most Afghan evacuees to gain permanent status is to file for asylum, which must be submitted within one year of their arrival (unless an individual qualifies for an exception).

The Michigan Immigrant Rights Center (MIRC), Michigan Chapter of the American Immigration Lawyers Association (AILA), and the State of Michigan Office of Global Michigan (OGM), along with other non-profit legal service providers, have partnered together to establish a statewide coalition of pro bono legal services for the preparation and filing of asylum applications for Afghan arrivals. MIRC leads the coordination of the pro bono legal services, with Michigan AILA providing additional immigration law support and mentoring, and OGM securing and administering resources for training, pro bono coordination, and language access. Non-profit legal service providers are organizing workshops and many attorneys around the state are providing pro bono legal services. MIRC is partnering with Lighthouse Immigration Advocates, Southwest Detroit Immigrant and Refugee Center, and other non-profit legal service organizations in a statewide effort to ensure that all 1,734 of the Afghan evacuees resettled in Michigan have access to legal assistance to help them file for asylum before the one-year deadline.

**No immigration experience required.** Law students and BIA accredited representatives are welcome. There are many ways to get involved, including taking cases in-office, volunteering at asylum workshops, and being a mentor to other attorneys.

Cannon Lecture Series - "Both Sides: Reproductive Rights and Justice Beyond Roe v Wade"
Wednesday, April 13
Noon - 1:00pm

Dr. Felicia Kornbluh will discuss how *Roe v. Wade* has had an outsized place in the understanding of reproductive rights. She will draw upon the findings in her new book, "A Woman's Life is a Human Life: My Mother, Our Neighbor, and Reproductive Rights and Justice—New York and the Nation" (Grove Atlantic Press, forthcoming). The book is a history of reproductive politics that starts with a

pair of neighbors on the eighth floor of a New York City apartment building. Kornbluh's research has followed her mother and her neighbor, Dr. Helen Rodríguez-Trías, into the feminist law-reform campaigns in which they made their most renowned contributions, efforts to decriminalize abortion in New York State that succeeded three years before Roe, and a campaign to regulate surgical sterilization in New York City that resulted in national regulations from the federal Department of Health, Education and Welfare (today, Health and Human Services). She argues that an over-emphasis on Roe has prevented us all from understanding the history of reproductive rights and the pertinacity of political fights over those rights. #### PRO BONO OPPORTUNITIES

The Toledo Bar Association offers a variety of pro bono opportunities. The following clinics are currently available for law students:

#### Clinics

- 1. <u>Juvenile Clinic</u>- you will observe attorneys assisting individuals who are filling out court documents in Juvenile Court to file pro se. If you are comfortable after observing, you may have the opportunity to assist with educational information only. This clinic is held the first and third Thursday of each month at the Lucas Co Juvenile Court from 11:00-1:00. You will need to arrive 15 minutes early so we can go over the forms with you.
- 2. **Pro Se Divorce Clinic** this is an opportunity for you to observe a volunteer attorney assisting folks who are filing for divorce pro se. This clinic is normally held twice a month on Friday afternoons from 1:30-3:30 at the Law Library (905 Jackson St.). Again, you will need to arrive 15 minutes early so we can go over the forms with you.
- 3. <u>VA Brief Advice Clinic</u>- law students will be paired with an attorney to observe providing brief advice on a variety of legal topics. This clinic is held on the first Thursday of the month at the Toledo VA (1200 S. Detroit) from 8:30-11:00.
- 4. **Justice Bus Brief Advice Clinics:** law students will be paired with an attorney to observe providing brief advice. These clinics will be on specific topics, and will be held at Toledo Lucas County Public Library locations.



### **Job Fairs**



The Cook County Bar Association ("CCBA") is pleased to invite minority law students to participate in the **39th Annual Minority Law Student Job Fair** (the "Job Fair"). In an effort to keep the student-to-employer ratio as low as possible, we are only inviting J.D. students in the classes of **2023 and 2024** (rising 3L and 2L students).

This year's Job Fair will be held on **Tuesday**, **July 19**, **2022**, from 8:30 a.m. to 5:00 p.m. The Job Fair will return to the **Embassy Suites Chicago** –

Downtown/Lakefront, located at 511 N. Columbus Drive, Chicago, Illinois 60611. The Embassy Suites is located two blocks from Chicago's Magnificent Mile shopping and entertainment district and is minutes from Navy Pier, Lake Michigan, and several world-class museums. The hotel's large suites are conducive to conducting formal interviews, as the sleeping area may be closed off while interviews are in progress. Moreover, the Embassy Suites Hotel is spacious enough to accommodate the growth of the Job Fair. The Job Fair typically attracts more than 500 students from the eligible law schools. Each year, law firms, corporations, and governmental agencies register for the Job Fair. These employers are located primarily in Illinois, Indiana, Minnesota, Missouri, Ohio, Wisconsin, and Washington D.C. In addition, we have had several employers registered from Colorado, lowa, Kentucky, Maryland, Massachusetts, Michigan, and Nebraska. The Job Fair Committee adheres to the definition of "minority" provided by NALP which includes students that are part of certain racial, ethnic, gender, and sexual orientation groups. It is our policy that all students from eligible law schools may register for our event. However, the employers registered for the Job Fair expect to be able to interview law students of color that are part of racial and ethnic minority groups.

Please be advised that we will not have any sort of on-site matching process.

Law Student registration opened on March 1, 2022. Please note that the student registration process will be completed via a multi-step process. First, each student must register as a participating student by entering his or her profile information on the Simplicity website. Second, each student must upload his or her resume by May 1, 2022 at 11:59 p.m. Central Standard Time (NO EXCEPTIONS).

Next, each student's registration will undergo the Job Fair Committee's approval process which includes the following steps:

- 1. Verification that each student's law school has registered for the Job Fair;
- 2. Confirmation from each student's Job Fair Liaison that the student meets all participation criteria:
  - 1. Each student must actually attend the school listed in his or her profile and resume;

- 2. Each student must actually be in the classes of **2024 or 2023** (rising 2Ls and 3Ls only no graduates may attend); and
- 3. Each student's projected graduation date must be correct.

The interview matching process will take place in June. Once the interview lottery has been conducted, students will receive an email notifying them that their initial interview schedule is now available through Simplicity. During the month of June, students will be given the opportunity to cancel individual, unwanted interviews or drop out of the Job Fair completely. Students may also be afforded the opportunity to pick up additional interviews with employers that have open interview time slots during that time.

## 2022 Loyola Patent Law Interview Program – Student Registration Currently Open

Loyola University Chicago School of Law is hosting the 2022 Patent Law Interview Program on **Thursday and Friday**, **July 21-22**. This nationwide interview program targets patent law employers and rising 2L and 3L students. The 2022 Patent Law Interview Program will be held IN PERSON\* at the Embassy Suites Chicago – Downtown/Lakefront. **In person interviews will still take place on Thursday and Friday**, **July 21-22**, **and virtual interviews will now take place on Monday**, **July 25**.

Last year roughly 150 employers, 190 law schools, and 1,300 law students from across the country participated in the program. The program is entirely preselected, which means that students submit application materials to apply to interviews with the employers they are interested in, and employers then review their materials and select the students they wish to interview at the program. Last year, approximately half of the participating students were selected for interviews.

Students with undergraduate or graduate degrees in engineering or a technical science should consider registering for the program. You do not need to be patent bar eligible to register, although the vast majority of employers participating in the program are seeking patent bar eligible students.


