#### **Conditions Governing Access**

#### **Biographical / Historical**

Harold J. Garner was born April 18, 1925. A native of Toledo, he graduated from Libbey High School and soon after graduation joined the Navy, where he served until he was honorably discharged in 1946. He later attended the University of Toledo, where he received a bachelors degree in Business Administration.

After working as a factory employee for such companies as Auto-Lite and Doehler-Jarvis, Garner became Administrative Assistant to the Superintendent of the Toledo Metropolitan Housing Authority. He served in this capacity from 1952-1956 before becoming the Minority Groups Representative - and later Local Office Manager - of the Ohio State Employment Service. While employed as an Assistant Plant Personnel Manager at General Mills, Garner was elected to Toledo City Council in 1969. He served two 2-year terms before retiring in 1973, citing his desire not to seek re-election. He died October 3, 1988.

## **Scope and Contents**

The Harold J. Garner City Council Papers consist mostly of correspondence to and from Councilman Garner discussing issues of local interest such as housing and urban renewal. Other correspondence pertains to various departments (law, safety, public welfare). Additional materials in the collection include a strategy statement for the Model Cities program and legislation for consumer protection.
