#### III. Executive Report: Patricia Case

Executive Committee last met April 30; discussed agendas for Tuesday council meeting (last one for 2020-2021 and first one for 2021-2022); nothing else to report.

#### IV. Faculty Senate Report: Patrick Lawrence

Faculty Senate last met April 27, last meeting for 2020-2021; no updates on constitution, pick up process in Fall; executive met with Provost regarding Vice Provost position search, FY22 budget process, new RCM model; executive met with President regarding RCM model and FY22 budget, concerns of implication of revenue/gifts; follow-up on campus response to Floyd case, concern of Ohio Bill 135; executive reported Dean evaluation postponed until Fall; reannounced graduation ceremonies 5/7 and 5/8, in-person and virtual options; Board announced approval of 70 tenure promotions, distinguished lecturer award winners and outstanding research award winners; Provost reported on on-going COVID vaccine clinics on campus and email survey on vaccinations; end-of-year reports given by curriculum committee, workforce committee and student athletics rep annual report; presentation given Teaching Center Taskforce (attached to meeting invite) and town hall invite/email discussed; end of 2020-2021 Faculty Senate; 2021-2022 Faculty Senate convened; election results announced.

#### V. Graduate Council Report: Patricia Case

Graduate Council last met May 4; updates provided on academic dishonesty policy, will go to 2021 members for comment before being sent to Provost; discussed student registration payment plan, plan on pause; no updates on Dean replacement; announced seats still available for graduation hooding ceremony; announced upcoming NSF career workshops being planned, check email for announcements; COGS task force working on final report, recommending change from college to service-oriented school, will be sent to members for review before being sent to Provost; reported graduate faculty applications status, recommended Deans endorse some candidates.

#### VI. Dean's Report: Dean Gilbert

Thanked council for their work this past year; submitted FY22 budget year, waiting to get information on how this budget year would have compared under new model; discussed plans to rebuild budget next year, prioritizing projects, being able to bring some back, some items restored with one-time monies; reported enrollment is holding steady, down 1% in confirmations, up 64.3% in orientation registrations, up 64% in transfers, working on getting students who left during pandemic back; provided update on diversity/inclusion/equity work and addressing structural racism, several suggestions were made in town hall event, creating four action steps (reading lists, study group, required curriculum, credit extra credit assignments), committee setup to begin discussion of action steps; reminded folks of awards ceremony and graduation, room still available; discussed Teaching Center taskforce on potential new model; discussed possibility of new flexible workplace policy, will provide updates when available; oncampus resumes June 1, tenure clock extension deadline June 30; question raised about consideration of mandatory vaccinations for students, none as of now.

#### VII. Curriculum Committee Report: Linda Rouillard

Curriculum Committee met regarding two items, detailed documents previously sent out via email.

- One program modification ENGL Minor (change to 12 credits maximum). One program modification submitted for approval; motion to approve, second. Vote -Approve 37, Not Approved 0, Abstain 0. One program modification approved.
- One new course proposal ENGL4610 Latinx Nineteenth Century. One new course proposal submitted for approval; motion to approve, second. Vote - Approve 37, Not Approved 0, Abstain 0. One new course proposal approved.
