In compliance with the "Timely Warning" provisions of the federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998 the University Police are investigating a report of sexual assault.

Please note, Timely Warnings are advisories distributed via email and will not include a text message version. UT Alert text messages are reserved for active emergencies.

#### SYNOPSIS

The University of Toledo Police Department is investigating a report of a sexual assault. A female student reported she was assaulted by a known male acquaintance.

When: early morning hours of November 19th 2016  
Where: Ottawa East Residence Hall  
Reported to UTPD on November 19th at 3:12 am

The University would like to remind students:

- Sexual assault is non-consensual sexual activity, ranging from unwanted sexual touching to forced intercourse.
- Most perpetrators choose a victim they know.
- The University defines Sexual assault as unwelcome physical conduct of a sexual nature including unwanted kissing, touching, oral, vaginal, or anal sex which occurs in the absent of consent.
- UT's Sexual Misconduct, Student Code of Conduct, and Ohio law prohibit sexual assault.
- It is your responsibility to make sure your partner is truly consenting.
- True consent is willing, clearly communicated, specific, and not under the influence of alcohol or drugs.
- Rape is a felony of the first degree and punishable by imprisonment of 5 years to life

If you are the victim of a sexual assault, you have options and help available to you at The University of Toledo.

Call UT Police (530-2600) to report a police report for a sexual assault on campus.

Call 911 to file a police report for a sexual assault occurring off campus.

The University of Toledo is committed to educational and working environments that are free from sex discrimination, including sexual harassment, sexual assault, or retaliation. Title IX of the Education Amendments of 1972 (Title IX) is a federal law that prohibits sex discrimination, including sexual assault.
