# Toledo Bar Association, Pro Bono Legal Services Program

**Pro Se Juvenile Court Clinic**: This clinic runs every Thursday at the Juvenile Justice Center, 1801 Spielbusch, Toledo, OH. The clinic begins at 11:00 a.m. and ends when the last client leaves, usually around noon. Sometimes there are as few as 4 or 5 clients, and sometimes as many as 18-20. HRC Manor Care attorneys generally staff the clinic, but they are always glad to have assistance from law students.

**Pro Se Family Law Clinic**: This clinic runs every other Friday at the Family Court Center, 429 N. Michigan, Toledo, OH. The clinic begins at 1:15 p.m. and lasts until about 3:00 p.m. Students will assist Pro Se litigants to complete legal forms. Students will have an opportunity to tour the court after the clinic.

**Pro Se Expungement Clinic**: The clinic will provide assistance to those filing for an expungement of their record. This clinic runs the first Friday of every month at the Lucas County Law Library from 1:00 p.m. – 2:00 p.m. and the second Tuesday of each month at The Source downtown from 1:00 p.m. – 2:30 p.m.

<u>**Guardianship Clinic:**</u> This clinic which focuses on Guardianships within the Probate Court. Students will receive training and work on filling out Guardianship forms which will be supervised by an attorney. Students may have the opportunity to attend the guardianship hearing. This is scheduled on a periodic basis.

**Pro Se Divorce for Individuals With Children:** This new clinic will allow students to assist individuals complete the necessary documents to file for divorce in cases involving children. The clinic is currently scheduled on a periodic basis.
