<u>Elective Description/ Requirements:</u>	The student will become a part of the emergency team whose members handle all phases of emergency patient management ranging from triage to final disposition. The student will have the opportunity to examine patients and discuss his/her findings with the Emergency Medicine Attendings and Residents. Each acting intern must complete two on-line modules to prepare the acting intern for his/her role as teachers of junior medical students.
