Distinguish the relationship of ocular manifestations and systemic disease. 4. Establish treatment options for basic ophthalmic disease entities. 5. Management of ophthalmic disease in the pediatric and adult patient. 6. Management and treatment of emergent ophthalmic disorders. 7. Differentiate what conditions may be safely handled in a general practice vs. those which need to be referred to an ophthalmic specialist.
