Designed as a two-week supplement to Introduction to Diagnostic Radiology. This course will introduce key aspects of radiology essential for success as a pediatric intern. Students will complete an online module-based curriculum throughout the

Through the modules students will obtain an advanced understanding of:

- 1) radiation safety as it pertains to the pediatric patient
- 2) the most appropriate imaging modalities for evaluating a given differential diagnosis
- 3) radiographic features specific to various pediatric pathologies.

Modules REQUIRED for completion of the course include:

Introduction to the Pediatric Knowledge Techniques: Lines and Catheters, Radiation Safety

Cardiac: Acyanotic Congenital Heart Disease

Chest: Childhood Pneumonia, Neonatal Chest

Esophagus and Airway: Gastroesophageal Reflux

<u>GI</u>: Appendicitis, Intussusception, Malrotation and Midgut Volvulus, Hypertrophic Pyloric Stenosis, Newborn Jaundice, Newborn Low Intestinal Obstruction,

Pneumoperitoneum

<u>GU</u>: Testicular Torsion, Vesicoureteral Reflux, Neuroblastoma, Ganglioneuroblastoma, Ganglioneuroma, Posterior Urethral Valves, Wilms and Other Renal Tumors <u>Musculoskeletal</u>: Child Abuse: Skeletal Trauma, Childhood Fractures, Legg-Calvé-Perthes Disease, Slipped Capital Femoral Epiphysis, Developmental Dysplasia of the Hip, Septic Arthritis and Toxic Synovitis

<u>Neuroradiology</u>: Pediatric Brain Tumors, Spine: The Sacral Dimple, TORCH Infections
