<b><u>Elective Description/ Requirements:</u></b>	<p>Law and Medicine: Intercollegiate Seminar is an interdisciplinary case-based elective that will provide medical students the opportunity to join with law students to review, analyze, and discuss legal cases, statutes, and articles applying statutory and common law and their affect on healthcare provider behavior. Medical students will learn how to read and interpret legal cases and will develop an understanding of the academic and practice perspective differences of the medical and legal disciplines. Sample seminar topics: informed consent and death, dying, and decisionmaking.</p> <p>Students will be required to 1) attend and actively participate in class sessions at the COL and clinical/instructional experiences on the Health Science Campus; and, 2) complete oral and written assignments (e.g., case briefs, reflective papers, presentations).</p>
