<b><u>Elective Description/ Requirements:</u></b>	The student will acquire the clinical skills to identify, evaluate and initiate appropriate management of infectious diseases in both normal hosts and immune compromised patients. Because of the high frequency of infectious diseases in the pediatric population, this elective should be of considerable practical value to the student planning a career in primary care.
<b><u>Length of Clerkship:</u></b>	4 weeks
