<b><u>Elective Description/ Requirements:</u></b>	Students will be given an individualized opportunity to participate in the activities of the Division of Cardiothoracic Surgery. Opportunities may be available for clinical experience in the operating room, in management of adult and pediatric cardiac surgical patients, or in clinical research. The focus will be the development of an understanding of the basic and clinical sciences as they pertain to cardiovascular surgical procedures and pulmonary resection.
