

### **Mission Statement**

The University of Toledo Police Department (UTPD) is a professional police agency dedicated to providing excellence in service and safety while promoting a rich educational experience.

### **Vision Statement**

The vision of the UTPD is to become a formative leader and innovator in campus safety and law enforcement.

### About The University of Toledo Police Department-Law Enforcement Authority

The UTPD is located in the Transportation Center on the Main Campus. The UTPD provides 24-hour uniformed police services to all three campuses serving a daily population of more than 31,000 students, faculty, staff, employees, patients and visitors, making UTPD one of the most active police departments in northwest Ohio.

All UTPD officers are sworn State of Ohio Peace Officers commissioned by the Ohio Peace Officer Training Academy. Police Officers are entrusted through the Board of Trustees in accordance with Ohio Civil Service Law and Section 3345.04 of the Ohio Revised Code. University law enforcement officers have misdemeanor and felony arrest authority,

as well as all other enforcement powers granted to peace officers in the state of Ohio. UTPD officers are subject to all training and education requirements established by the Ohio Peace Officers' Training Council and The University of Toledo.

UTPD officers require a professional demeanor, exceptional judgment and the right disposition. Officers are carefully selected through a comprehensive hiring process and have demonstrated knowledge and skill through a rigorous field training period. In addition to providing excellent police services, officers continue to train and gain knowledge throughout their law enforcement career.

### **Mutual Aid and Public Safety Partnerships**

The UTPD maintains strong partnerships with local, state and federal public safety agencies. By virtue of concurrent jurisdiction and in some cases shared jurisdiction, a close working relationship is in place with the Toledo Police Department, Toledo Fire, Ottawa Hills Police Department, the Lucas County Sheriff<sup>1</sup>s Office, the Ohio State Highway Patrol, and the Federal Bureau of Investigation. The UTPD is an active member of several important public safety collaborations including: The Metro Toledo Criminal Justice Administrators, State University Law Enforcement Administrators, the Lucas County OVI Task Force, Toledo Metro Drug Task Force and the Northwest Ohio Joint Terrorism Task Force, Lucas County Domestic Task Force, Lucas County Sexual Assault Team, and the Lucas County Human Trafficking Coalition . The UTPD participates and holds several mutual aide agreements including the area Regional Law Enforcement Mutual Aid Agreement among participating Ohio Universities.

### **Community Policing**

UTPD officers are active in community policing, a philosophy promoting partnerships between law enforcement and the community served. Officers are assigned to specific areas of responsibility such as Parks Tower residence hall or the Student Recreation Center, and spend time becoming familiar with the students and staff and the unique challenges found in the area. Relationships are developed and the officer is viewed as a resource and educator on safe habits and practices. Officers attend meetings with students and staff and help develop solutions to problems. Programming such as theft prevention methods, alcohol/drug awareness and sexual assault prevention are also provided through community policing.



A UTPD police officer and a Toledo Police Department (TPD) officer partner to work a unique collaboration known as unit 618. The Officers are assigned fulltime to the unit which has been keeping the Bancroft Hills and Secor Gardens neighborhood safer for both students and permanent residents since 1994. During the academic year, the team policing unit is on duty Tuesday through Saturday, 8 p.m. to 4 a.m. The crew is dispatched through the TPD.



### **Dispatch Communications**

The UTPD Communications Center is the hub of all police communications, operating 24 hours a day, seven days a week. When a person activates an emergency Code Blue phone or calls extension 2600, a police dispatcher will answer and provide assistance. Dispatchers are well trained and certified in the use of the county-wide 911 computer aided dispatch system, as well as accessing a number of local, state and national law enforcement databases.

#### Investigations

Two full-time detectives are responsible for investigating serious crimes on campus. UTPD detectives also work with other area law enforcement agencies, including the Northwest Ohio Joint Terrorism Task Force, the U.S. Secret Service for dignitary visits, the FBI on cyber-crime cases, the Toledo Police Department, the Lucas County Sheriff's Office, and the Village of Ottawa Hills Police on various crimes related to the University.

In addition to conducting criminal investigations, Investigations also conduct extensive background investigations on all police personnel-including police officers and police dispatchers. These background investigations average several weeks of police records searches; past employer visits and interviews; neighborhood visits; in-home visits of the police officer/dispatcher candidate; in addition to several other interviews and associate checks of potential employees of the UTPD.

Members of our community who desire an escort to their destination on campus during evening hours may utilize the Night Watch service. Night Watch provides escorts to the campus community from one UT building to another. Night Watch provides a two-person team of trained students who assist members of the campus community requesting an escort. Employees are equipped with two-way radios and remain in constant contact with the police dispatcher. The service operates from dusk to early morning hours when school is in session. All members of the Night Watch staff are cleared by The University Police Department before being offered employment.

To request an escort, simply call 419-530-3024 (extension 3024 on campus) or stop at the walk up station inside the Carlson Library. A team of Night Watch members will be dispatched to your location and assist in getting you to your desired parking lot, building or campus. Depending on the distance of the escort, you may be accompanied on foot, or transported by golf cart or motor vehicle.

Plan ahead and be patient as this service is very popular and in high demand on the campuses.

The objective of A.L.i.C.E. is to teach the student survival options in active shooter situations. A.L.i.C.E. encourages members of the campus community to take an active role in his/her own survival and lead others to safety.

The A.L.i.C.E. Program is designed to give a person or group of people, who may find themselves in a potentially life threatening situation, some mental and physical tools that could play a vital role in survival.



### **Overview**

Uniformed, unarmed security officers provide an additional layer of safety and customer services for The University of Toledo Medical Center and clinical enterprise. Health Science Campus (HSC) security officers are carefully screened through a rigorous hiring process and extensive field training experience. Officers patrol the buildings and parking areas by bike, vehicle and foot and provide important services to persons on the Health Science Campus. The security department is also responsible for fire and intrusion alarm monitoring, security cameras, door access, lost and found, and patient valuables. Additionally, the department coordinates regular emergency preparedness drills and training with students and staff. The security office is located at 007 Mulford Library.

# **Public Safety Support Services**

### **Rocket Patrol**

Every year, approximately twenty-five (25) student employees of the Public Safety Support Services Office known as Rocket Patrol assist UTPD by enforcing parking regulations, responding to motorists needing assistance, securing buildings and providing support at major campus events. Rocket Patrol carries radios and serves as extra eyes and ears for the UTPD, reporting any suspicious individuals and activities to the police dispatcher. Rocket Patrol students can be identified by a polo style shirt patrolling the campus by vehicle and/ or on foot.

### **Environmental Health and Radiation Safety**

Many research activities occurring on University campuses involve hazardous and dangerous materials. Therefore training, monitoring and other safeguards need to be in place. The Mission of the Environmental Health and Radiation Safety Department is: "Too develop, implement and monitor programs of environmental and occupational safety and health as necessary to protect the health and/safety of faculty, staff, students and/campus visitors, and/to provide compliance with applicable regulations."

The Environmental Health and Radiation Safety Department is located at The University of Toledo Medical Center (UTMC), Room 0235 on the Health Science Campus and in the Transportation Center, Suite 1150-E on the Main Campus. The Radiation Safety Office is located in UTMC, Room 0259. The Environmental Health and Radiation Safety Department works diligently to make our campuses safer by developing, implementing and monitoring programs of environmental and occupational safety. The department is also very involved in emergency planning, training exercises, and actual events. The University conducts many exercises within a calendar year and each exercise or event is evaluated and improved action plans are developed to better respond to emergencies in the future.

### **Voluntary Reporting**

Crimes, suspicious activity, safety hazards, or campus emergencies (including medical and fire emergencies), should be reported promptly by dialing 419.530.2600 (or extension 2600 from any on-campus telephone); 9-1-1; or from any emergency telephone throughout the Main Campus, Health Science Campus, or Scott Park Campus. Most emergency telephones are labeled 'Emergency' and have a blue flashing light that flashes when activated. Elevators are also equipped with emergency telephones.

### Confidentiality

Ohio's public records law (Ohio Revised Code § 149.43) does not permit the University to promise confidentiality to those who report crimes to anyone except counselors at the University Counseling Center or, under certain circumstances, to a physician or nurse at the Student Medical Center or a hospital. Some off-campus reports also may be legally confidential–e.g. reports to clergy or health care professionals.

To protect privileged relationships, reports to persons operating in the role of a professional counselor, medical professional, or pastoral counselor remain confidential in all but legally recognized exceptions and therefore are not included in the annual crime statistics report.

### **False Reporting**

False reporting to a police department is a criminal offense and a very serious matter. A false report unnecessarily creates alarm in the community and direct police resources in inefficient ways, costing untold man hours. For these reasons, The UTPD pursues criminal charges in any verified case of false reporting. Never falsely report a crime or incident to a police department. Contact the UTPD if you believe an erroneous report has been provided to a police or a University official. Please remember, missing or lost property is not stolen property. Report honestly and responsibly.

FALSIFICATION WARNING—2921.12 – Ohio Revised Code – Any false statements to a police officer by an individual could be subject to criminal prosecution under this Ohio Revised Code statute. A violation of this statute is a Misdemeanor of the First Degree.

### **Anonymous Reporting**

The UTPD has an anonymous reporting tool on the UTPD website. Members of the campus community that wish to report crimes anonymously are encouraged to do so through the web tool. Reports received and corroborated with other evidence are included in the Annual Security Report. ### Reporting to a Campus Security Authority (CSA)

The UTPD is the primary department accepting information about criminal activity. In some circumstances, a person may prefer to report a crime to other University officials. A person defined as a Campus Security Authority (CSA) who receives in good faith a report of a Clery crime occurring within the University's Clery geography has a legal responsibility to make sure the crime is recorded and reported as a statistic, by the University. The Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act defines "Campus Security Authority" as: "An official of an institution who has significant responsibility for student and campus activities, including, but not limited to, student housing, student discipline, and campus judicial proceedings." An example would be a dean of students who oversees student housing, a student center, or student extra-curricular activities and has significant responsibility for student and campus activities. Similarly, a director of athletics, team coach, and faculty advisor to a student group also has significant responsibility for student and campus activities. A single teaching faculty member is unlikely to have significant responsibility for student and campus activities, and campus activities, except when serving as an advisor to a student group. Clerical staff, as well, is unlikely to have significant responsibility for student and campus activities.


#### Missing Student Reporting [419.530.2600—University of Toledo Police Department]

Beginning each fall semester, the Office of Residence Life will request each campus housing student to designate an emergency contact person or persons to be contacted in the event the student is determined missing by law enforcement. Missing person contact information is registered confidentially and accessible only to authorized campus officials and disclosed only to law enforcement personnel in the furtherance of a missing person investigation.


All missing person reports shall be reported to the UTPD. The Dean of Students or designee will attempt to notify the emergency contact person or persons no less than twenty-four (24) hours after the time the students have been determined missing by law enforcement.


### Jurisdiction and Reporting Areas: Main Campus

# **Safety Awareness Communications**

### **Overview**

An informed UT is a safer UT. We use a number of communication tools to notify students, faculty, staff, patients and visitors of events that may affect safety. Some alerts are legally required, consistent with the federal act known as the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. UT takes a broad approach to communication and provides information beyond what is legally required including significant incidents in student living areas off campus, as that information is made available.

Receiving alerts does not necessarily reflect an increase in crime, but is an outcome of UT's aggressive communicative philosophy. UT feels a broad and liberal distribution of safety information allows members of the campus community the opportunity to make more informed choices regarding personal safety.

In the event of an emergency, the UTPD will determine the appropriate emergency notification systems used to deliver emergency messages to the campus community. UT may use any or all communication resources to disseminate information depending on the nature of the emergency and the surrounding circumstances.

Information pertaining to incidents and emergencies on campus will be disseminated to the larger public via media organizations through University Communications or individuals involved in emergency response on campus, as designated.

### **Timely Warnings**

The Timely Warning is an alert designed to give students, faculty, and staff notification of a crime occurring on campus that constitutes a danger to the University of Toledo community. Such information is a valuable tool in heightening safety awareness and obtaining assistance from the community which may lead to an arrest and conviction of the perpetrator. Every effort is made to balance getting the alert out as quickly as possible, with ensuring the information being provided is accurate. The release of the Timely Warning alert is subject to the availability of facts concerning the incident.

The determination to issue a Timely Warning is the responsibility of the Office of Public Safety. The decision to issue the warning shall be decided on a case by case basis in light of all the facts surrounding a crime, including factors such as the nature of the crime, the continuing danger to the campus community, and the possible risk of compromising law enforcement efforts. In certain circumstances, a bulletin will also be distributed around the campus area and on bulletin boards.

### **Crime Awareness Bulletins**

For incidents that do not fit the requirements of a Timely Warning, UTPD may issue Crime Awareness Bulletins. The bulletins are aimed to educate the campus community on crime trends and seek the assistance of the campus community in identifying suspects or individuals involved in crimes. UTPD issues Crime Awareness Bulletins for incidents both on and off campus when occurring in student living areas. The information contained in these bulletins is subject to change as facts and circumstances arise. The bulletins are in no way intended to be a comprehensive record of all reported off campus incidents. To prepare bulletins on incidents off campus, the UTPD relies on reports from citizens and other law enforcement agencies. Crime Awareness Bulletins are posted on the UTPD web site and social media sites operated by UTPD and may additionally be included in the UT News e-mail update.

#### **Crime and Fire Log**

The Crime and Fire log is maintained by the UTPD in effort to provide members of the campus community a record of all criminal incidents as well as fires reported to police. This log provides for both the most recent incidents as well as an archive listing of past logs. Any logs prior to the online archive period may be requested from UTPD. #### Public Address Systems

A public address system is a quick and reliable way to communicate emergency information. The University of Toledo uses a state-of-the-art outdoor public address (PA) system to quickly inform the campus community of emergencies including weather events such as a tornado or other dangerous situations. The UTPD operates the PA system which uses loud tones to command your attention followed by "canned" prerecorded or live voice messages. The PA towers are located on the Main, Scott Park and Health Science Campuses and have been placed strategically to provide maximum coverage.

### **Code Blue Emergency Phones**

Emergency telephones are located along walkways, in parking lots, parking ramps (garages), elevators, and other common space areas, as well as major pedestrian routes, on the Main, Health Science, and Scott Park campuses. When activated, an emergency phone provides a direct, almost instantaneous link to the Police Dispatch Center. The dispatcher immediately knows the caller's location when the phone is activated.

Police respond to the activation of emergency telephones even if no words are spoken. Despite their name, emergency phones are not just for emergencies. They are the campus community's direct link to the police dispatcher, and can be used to request an escort, report a suspicious person or circumstance, obtain access to a building or room, request motorist assistance, report an elevator entrapment, etc.

### UT Alert Text Message Notification System

Sign up for UT Alert 1

UT Alert is the University's emergency text message notification system. Alerts containing information on weather closures or other campus emergencies affecting safety or campus operations can be sent directly to your cell phone. Students, faculty and staff may sign up to receive text message and email alerts free of charge (standard text message rates may apply). #### Rave Guardian Mobile Safetty-Ssmantphone Application

Rave Guardian is a personal safety app for iPhone and Android devices which offers the users several important safety features. The app contains a panic button which when activated, directly contacts campus police providing GPS location and your personal profile. The app also has a safety timer that notifies predetermined safety officials, family & friends if the safety timer is not deactivated before it expires. Finally, the app offers the ability to text anonymous or non-anonymous non-emergency crime tips, including images to the campus police. The app is offered free to UT students, faculty and staff. Download the app from your preferred app store provider.

### Sex Offender Alerts

Each year the UTPD sends an email to students, faculty and staff describing the process to follow to receive information and alerts on registered sex offenders in Lucas County. You will be able to search county and state records for convicted sex offenders as well as sign up for automated sex offender alerts. Please note, sex offender registries reflect convicted sex offenders, which are only a small percentage of actual sex offenders, and most sex offenders commit assaults against people they know, rather than strangers. ### EyeCitizen, the Active Blockwatch™ - (Alfree service courtessy of the City of Toledo)

The City of Toledo now offers a free service entitled EyeCitizen. This service alerts subscribing members of crime information by sending a text and/or email alert with the address and type of crime reported as soon as the 9-1-1 call is dispatched. The EyeCitizen notification enables members to be aware that a crime may be occurring 'real time,' thus, making members more cautious and aware of their surroundings. When a subscriber becomes an EyeCitizen member, s/he will be a member of the Active Blockwatch™ and be notified whenever a crime against property and/or person occurs within the selected monitoring area. Once registered, the subscriber will be able to select up to three (3) areas within the city of Toledo to monitor for criminal activity. ### **Emergency Preparedness**

#### **Overview**

The University of Toledo maintains an Emergency Operations Plan (EOP) developed from the International Association of Campus Law Enforcement Administrators (IACLEA) planning guide. The UT EOP is compliant with the National Incident Management System (NIMS) and utilizes the Incident Command System (ICS) and Hospital Incident Command System (HICS) to guide emergency management. The plan is managed and updated by the Office of Public Safety and may be viewed at the following link: <u>Emergency Operations Plan</u>.

### **Testing the Plan**

It is not good enough to just have a plan. It's equally important to regularly test the plan. Periodically, The University of Toledo will conduct an unannounced hazardous chemical release exercise at the Research 1 building (R1). Response to the mock incident involves several segments of The University of Toledo Office of Public Safety including police, dispatch operations, and environmental health and radiation safety; as well as the City of Toledo Fire and Rescue Department. This exercise, in combination with various others, is part of a rotating schedule to be tested annually. During 2014, the University participated in ten (10) drills, each testing a specific vulnerability as identified through the hazard vulnerability analysis (HVA). The University also responded to 5 real events including Lake Erie clean water contamination and snow emergencies.

### **Public Safety Response to Emergencies**

The University of Toledo Office of Public Safety responds to all reported emergency situations. Depending on the type of emergency, assistance

may be provided by other agencies such as Toledo Fire, Toledo Police, the Ohio State Highway Patrol, Ottawa Hills Police Department, the FBI, Secret Service, and/or other local, state, or federal agencies. In certain situations, command of the incident may be shared among responding agencies (unified command) or transferred to the agency with clear jurisdiction over a particular incident.

#### **Community Response to an Emergency**

It is important for all members of the community to know what to do in an emergency. The actions one takes may vary depending on the circumstances, but every action taken should be toward making you and others safer. The University's <u>Safety Video</u> discusses what to do in a violent intruder situation.


#### **Emergency Evacuation / Shelter in Place**

In certain emergency situations emergency responders may order the evacuation of certain offices or buildings, or instruct people in those facilities to shelter-in-place. It is possible that some emergency scenarios could result in one of these protective actions ordered for one part of campus and the other protective action for a different area of campus. When such actions are warranted, police, fire, safety or University officials will advise you of the appropriate action via UT Alert text message; radio and television stations; public address (PA) systems; loudspeakers; door-to-door notifications; and/ or any other appropriate means.

The University performs at least four (4) evacuation drills per year in each residence hall. Additional evacuation drills and shelter-in-place drills are conducted in academic and hospital buildings. Evacuation and shelter-in-place drills are coordinated by the emergency preparedness coordinator, with the assistance of UTPD. Evacuation and shelter-in-place drills provide training for emergency responders and better prepares students, faculty, and staff for life saving action during a true emergency including recognizing an alarm, listening for instruction, locating exits, and assisting others who may be in need of assistance.

### **Emergency Preparedness**

#### **Tornado Warnings**

Tornadoes represent a serious threat in Northwest Ohio during the spring and summer seasons. If a tornado warning is issued, the University PA sirens will be activated for 3 minutes followed by a voice message instructing persons to seek shelter. In addition to the outdoor PA system, the University utilizes a 'Mass Notification System' allowing the campus community to receive messages while inside University buildings. A UT Alert will also be sent out to registered members alerting the subscriber to the warning.

University policy requires normal activities to cease immediately including any classes or exams taking place. All persons should immediately seek shelter in the appropriate tornado safe waiting area. Each building has "Tornado Safe Waiting Areas" pre-determined and designated by signs. Members of the campus community should remain in the protected area until the tornado or severe weather has passed. The University PA will activate and provide an "all clear" message in addition to a UT Alert text message announcing the warning has been lifted. Classes and normal University business operations will resume as permitted by the impact of the severe weather. ### **Bomb Threats**

If you receive a bomb threat call, keep the caller on the line as long as possible. Ask the following questions:

What type of bomb is it? Where exactly is the bomb? What does the bomb look like? How will it detonate? Why are you doing this?

As soon as the caller hangs up, call University Police at 419.530.2600. If you are an employee, notify your supervisor and meet with and assist University Police personnel. Evacuate the building as directed and do not re-enter building until the "all clear" has been given by University Police or the Office of Environmental Health and Radiation Safety.

#### **Snow Emergencies/Class Cancelation**

Winter storms can present difficult driving conditions on the roadways of northwest Ohio. When conditions become dangerous, the University of Toledo may cancel classes and University sponsored events for the welfare and safety of everyone. Every effort will be made to notify the campus community in a timely manner of inclement weather closures.

The decision to cancel morning classes will be made by 6:00 a.m.; afternoon classes by 10:00 a.m.; and evening classes by 3:00 p.m. After an inclement weather situation is declared, University Communications shall notify the community through UT Alert, Email, website, the SNOW hotline 419.530.SNOW (7669) and local media. Employees deemed "essential employees" will still need to report to work. Essential employees are predetermined. Employees who have a question about their status should check with a supervisor. #### Violence Against Women Act – Sexual Misconduct, Domestic Violence, Dating Violence, and Stalking

In 2013, President Obama signed into law the Violence Against Women Reauthorization Act imposing new obligations for colleges and universities as it relates to the reporting, education, services, and procedures in incidents of sexual assault, domestic violence, dating violence and stalking. At the University of Toledo, sexual misconduct and relational violence of any kind is not tolerated and many resources exist for the survivor should an incident occur.

The University collects any reports incidents of datingviolence, domestic violence, sexual assault, and stalking occurring within the University's Clery geography and reported to a Campus Security Authority (CSA).

#### **Education and Programs**

- All members of the University community play a role in preventing sexual misconduct and relational violence. The University is committed to delivering annual sexual misconduct and relational violence primary prevention and awareness training to all new students and employees to:
- Promote healthy and respectful behavior.
- Increase awareness of what constitutes sexual misconduct and relational violence.
- Prevent circumstances that may lead to sexual misconduct or relational violence and empower bystanders to intervene in potential situations when safe to do so.
- Create an environment promoting reporting and instill confidence in the community that the University will provide a supportive, consistent and fair response to reports.
- Promote bystander intervention in sexual misconduct and relational violence situations.

#### **Primary Prevention Training**

Primary prevention focuses on stopping violence before it starts. The University provides all new students and employees with primary prevention training through an on-line module addressing the critical issues of sexual assault, relationship violence, and stalking and bystander intervention, which impact countless college students across the country.

#### Definitions

"Sexual Misconduct" is an umbrella term for a spectrum of unwanted or unwelcomed conduct of a sexual nature that may include sexual harassment, sexual assault or other forms of non-consensual sexual activity, or criminal forms of non -forcible sex offenses such as incest or statutory rape.

"Sexual Assault" is an umbrella term for actual or attempted sexual activity perpetrated upon a person without the consent of that person and against that person's will.

"Rape" is defined by the University as the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

#### **Definitions (continued)**

#### "Rape" (continued)

This definition includes any gender of victim or perpetrator. Sexual penetration means the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person. This definition also includes instances in which the victim is incapable of giving consent because of temporary or permanent mental or physical incapacity (including due to the influence of drugs or alcohol) or because of age. Physical resistance is not required on the part of the victim to demonstrate lack of consent.

In Ohio, Rape is a felony of the first degree and is punishable from 5 years to life imprisonment.

"Consent" is a voluntary positive agreement to engage in sexual activity; past consent does not imply present or future consent; someone who is incapacitated cannot consent; according to Ohio law, consent cannot be provided by someone whose ability to consent is substantially impaired; the responsibility for obtaining consent lies with the person initiating or escalating sexual activity in an atmosphere free from coercion; consent should be obtained verbally throughout sexual interaction; silence does not constitute consent; consent may be withdrawn at any point during sexual activity.

"Relational Violence" is an umbrella term that includes domestic violence, dating violence and stalking.

"Dating Violence" committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.

(1) The existence of such a relationship shall be determined based on the reporting party's statement and by the victim with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.

(2) For the purpose of this definition:

- (a) Dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse.
- (b) Dating violence does not include acts covered under the definition of domesticviolence.

"Bystander Intervention" is when individuals who are not directly involved but witness a violent or potentially violent situation and exercise the choice to get involved to discourage, prevent or interrupt the violence. Bystanders should feel empowered and equipped with the knowledge and skills to assist in the prevention of violence.

"Awareness Programs" are efforts the University undertakes to raise awareness to issues surrounding sexual misconduct and relational violence.

"Ongoing prevention and awareness programs" build on the University's primary prevention and initial awareness efforts. A single educational session or awareness campaign is not sufficient to make effective change within a culture. The University therefore develops a variety of methods throughout the year to prevent sexual misconduct, relational violence and stalking and bring awareness to the issue.

"Primary Prevention Programs" are the University's effort to prevent sexual misconduct, relational violence and stalking from happening in the first place. The focus of primary prevention is often on the perpetrator and changing behavioral patterns which may lead to sexual misconduct or relational violence.

"Risk Reduction" is defined as strategies or actions a person can employ to reduce the likelihood of becoming a victim of sexual assault, relational violence and stalking.

### **Definitions (continued)**

*"Domestic Violence"* is Ohio law that indicates "no person shall knowingly cause or attempt to cause physical harm to a family or household member. No person shall recklessly cause serious physical harm to a family or household member. No person, by threat of force, shall knowingly cause a family or household member to believe that the offender will cause imminent physical harm to the family or household member "[abbreviated]. The penalty for domestic violence is based on a several factors and can range from a 4th degree misdemeanor to a 3rd degree felony with mandatory prison sentence.

*"Stalking"* is engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for the person's safety or the safety of others; or suffer substantial emotional distress.

"Proceedings" is the formal action taken by the University to settle a complaint.

"Result" is the outcome of the proceedings.

#### **Reporting Sexual Misconduct, Relational Violence and Stalking**

The University strongly encourages any person with knowledge of a sexual misconduct or relational violence incident to immediately report the incident. In some case, bulletins or alerts may be issued however the names of victims are not included.

#### Police

The UTPD encourages anyone who is a victim sexual misconduct, relational violence or stalking occurring on campus to call 419.530.2600 and file a report. Even if the incident occurred off campus and the report will ultimately be filed in another jurisdiction, notifying UTPD will allow the University to render assistance to a victim and begin providing support resources and interim measures to better protect the survivor on campus. The victim may desire to pursue a court order of protection against the aggressor and UTPD will assist the victim through the court process.

For on campus incidents, the UTPD will collect evidence vital to the support of any subsequent complaint filed. Victims should not shower,

wash, clean, or dispose of clothes or other items containing blood or bodily fluid. Pictures of injuries should be taken as soon as possible. All written or electronic communication relative to the case including emails, text messages, phone logs, chats, social media posts, etc. should be saved.

### Police (continued)

The UTPD commits to adhering to the following promise when taking a sexual assault complaint:

### The UTPD Promise

We promise to:

- 1. Notify a sexual assault advocate to meet with the survivor.
- 2. Meet with the survivor privately, at the survivor's place of choice, to take a report.
- 3. Not release the survivor's name to the public or to the press.
- 4. Treat the survivor and the particular case with courtesy, sensitivity, dignity, understanding and professionalism.
- 5. Do our best to accommodate requests for a female or male officer.
- 6. Assist the survivor in arranging for any hospital treatment or other medical needs.

7. Fully investigate the case and help the survivor in achieving the best outcome. This may involve the arrest and full prosecution of the suspect responsible. The survivor will be kept up-to-date on the progress of the investigation and/or prosecution.

8. Continue to be available for the survivor, to answer questions, to explain the systems and processes involved (prosecutor, courts, etc.), and to be a listening ear if he/she so chooses.

#### Non-law enforcement complaint reporting options

A victim of sexual misconduct or relational violence also has reporting options through the University which will not necessarily trigger a police investigation. The following areas are preferred non-law enforcement reporting locations and all have administrative responsibility toward investigating and adjudicating cases of sexual misconduct and relational violence.

- Title IX Coordinator
- The Office of Student Conduct
- The Office of the Dean of Students
- Sexual Assault Education and Prevention Program

#### University Conduct Investigation

### **Investigation**

Upon receiving a complaint and before a final outcome, the University may take interim steps to address the harassment, which may include sexual assault, domestic violence, dating violence and stalking; affecting the student, staff, faculty, or member of the community. Upon learning of the harassment whether it be sexual misconduct, domestic violence, dating violence, or stalking the University implements interim measures and accommodations to help the affected individual. Interim measures and accommodations may involve housing, academic arrangements and or changes to work assignments – changes in shift or department, if such changes are reasonably available.

The complainant of sexual misconduct, domestic violence, dating violence, or stalking is empowered to work with specially trained advocates to determine all of their rights and options. The complainant can initiate an investigation and/or they can initiate a conduct hearing.



### **University Conduct Investigation (continued)**

#### Investigation (continued)

When a complaint is filed, the University will provide an impartial investigation and use a fair and timely hearing process as prescribed under the Student Code of Conduct or appropriate University policy/bargaining agreement to adjudicate the complaint. The investigation and hearing are conducted by persons who have received training in sexual misconduct and relational violence cases. The standard of evidence used to adjudicate conduct hearings including sexual misconduct, domestic violence, dating violence and stalking is a preponderance of evidence, or more likely than not a policy violation occurred. The University will simultaneously notify the complainant and the accused of information pertaining to the hearing including the right for both parties to have a University community member advisor of his or her choosing, the outcome, the process for appeals and the final outcome.

An investigation will be conducted whether the conduct occurred on or off campus. While the University does not wish to interfere with anyone's personal life, conduct away from the University community can still affect the community. Accordingly, the definitions and examples of sexual harassment apply to behavior during working hours and non-working hours, including University-sponsored programs, seminars, conferences, business trips or business related so-cial events, and conduct that occurs directly or indirectly via telephone or other electronic communications through internal or external mail system (including email) and other forms of communication. Additionally, this policy extends to behaviors which may occur in off campus professional practice assignments, clinical assignments, while attending activities as a representative of The University of Toledo, while representing the University in the community or at a University sanctioned or sponsored event. It also includes off-campus activities that are connected to the educational process of the University.

The University will have available and provide written information for both the complainant and the respondent of both on and off campus counseling services, medical services, and possible accommodation in terms of academic living, transportation and or employment; as well as a print copy of the Student Code of Conduct which outlines the entire procedure for the investigation, adjudication, results, and appeal portions of the student conduct process. If the complainant is a staff member a copy of the Sexual Harassment and other forms of Harassment policy is provided which outlines the investigation and disciplinary process for employees. If an investigation involves a staff member, the investigation will be conducted by the Deputy Title IX investigator for staff who has been certified by the Association of Title IX Administrators (ATIXA) and attends regular continuing education for Title IX. Employees will also be provided accommodations in terms of paid administrative leaves, employee assistance programs and/or interim changes to work assignments.

A summative report of information gathered through the investigation will be provided to both the complainant and the respondent with the notice of the hearing date, time, and location.

#### **Adjudication for Students**

A trained, non-bias panel of five faculty and/or staff members will consider all materials gathered through the investigation process to determine if the respondent will be held responsible for violating the Student Code of Conduct. The standard of evidence used to adjudicate all conduct hearings including sexual misconduct, dating violence, domestic violence and stalking is a preponderance of evidence, or more likely than not a policy violation occurred.

The complainant and the respondent will be treated equally throughout the process: rights provided to the respondent will be provided to the complainant and rights provided to the complainant will be provided to the respondent.



Rights of the Complainant and Respondent for cases involving sexual misconduct, sexual assault, dating violence, domestic violence, and/or stalking include:

- 1. The complainant and the respondent have the right to be informed of the charges in writing via UT email.
- 2. The hearing will be conducted in a fair manner as outlined in the Student Code of Conduct.
- 3. The complainant and the respondent have the right to request reasonable accommodations during the hearing (i.e. conference call or partition divider in room).
  - a. Requests must be made to the Student Conduct Officer at least one day prior to the scheduled hearing.
- 4. The complainant and the respondent have the right to be assisted by an adviser of his/her choice, who is not acting in the capacity of a lawyer or attorney. The adviser, upon the request of the respondent, may:
  - a. Advise and assist the complainant/respondent in the preparation and presentation of his/her defense;
  - b. Accompany the complainant/respondent at all conduct hearings; and
  - c. Advise and assist the complainant/respondent in the preparation and presentation of appeals.
- 5. The complainant and the respondent have the right to request a copy of the incident report.
- 6. The complainant and the respondent have the right to call a reasonable number of witnesses, who may be subject to questions from the hearing administrator.
  - a. Names and contact information of witnesses must be provided to the Student Conduct Officer at least two business days prior to the hearing.
- 7. The complainant and the respondent have the right not to appear or to remain silent at the hearing.
  - a. In the event that the complainant or respondent fails to appear at the hearing after proper notification, information related to the charges will be examined and considered in the determination of the outcome.

The University will simultaneously notify the complainant and the respondent of information pertaining to the hearing including the above listed rights, the hearing date, time and location. The outcome of the hearing, the process for appeals and the final outcome (if an appeal is submitted) will also be sent to both the complainant and respondent simultaneously.

### **Disciplinary Action for Employees**

After the investigation, if the respondent is an employee of the University a pre-disciplinary hearing is held with a trained, non-biased, pre-disciplinary hearing officer. The hearing officer will hear the facts of the investigation to determine if the respondent will be held responsible for violating the Standards of Conduct and any other applicable University policies. The hearing officer concludes whether there has been a policy violation and writes a recommendation for disciplinary action that is submitted to the appointing authority. The appointing authority then makes the ultimate decision whether to suspend or terminate an employee.

- The standard of evidence used in cases involving sexual misconduct, dating violence, domestic violence and stalking, where the respondent is an employee, is the preponderance of evidence, or more likely than not a policy violation occurred.
- The respondent receives notice of the hearing 72 hours prior to the hearing date.
- The respondent may request a union representative or professional staff association advocate to attend the predisciplinary hearing.
- The respondent receives a copy of the pre-disciplinary hearing report and recommendation from the hearing officer.
- The respondent reserves the right to appeal the appointing authority's decision through the collective bargaining grievance process.

### **Results for Students**

A student found responsible of violating University policy as it relates to sexual misconduct, sexual assault, dating violence, domestic violence, or stalking face sanctions ranging from formal reprimands to expulsion from the University. All possible sanctions that can be imposed to a student found responsible for sexual misconduct, sexual assault, dating violence, domestic violence, or stalking include:

Warning - A notice in writing to the student or student organization of a past or current violation of this Code.

Probation - A written reprimand for violation of specified regulations. Probation is for a designated period of time, during this probationary period, if the student or student organization is found to violate any policy additional more severe sanctions will result. Probation may include mandatory conditions.

- Loss of Privilege Denial of specified privileges for a designated period of time.
- Fines Previously established and published fines may be imposed.
- Restitution Compensation for loss, damage or injury caused by the conduct. This may include one or more of the following: appropriate service, monetary, or material replacement.
- Discretionary Sanctions Work assignments, essays, service to the University or community, or other related assignments
- Residence Hall Suspension Separation of the student from the residence halls for a definite period of time, after which the Student is eligible to return. Conditions for readmission may be specified.
- Residence Hall Expulsion Permanent separation of the student from the residence halls.
- Suspension Separation of the student from the University for a definite period of time, after which the student is eligible to return. Conditions for readmission may be specified.
- Expulsion Permanent separation of the student from the University.
- Revocation of Admission or Degree Admission to or a degree awarded from the University may be revoked for fraud, misrepresentation, or other violation of University standards in obtaining the degree, or for other serious violations committed by a student prior tograduation.
- Withholding Degree The University may withhold awarding a degree otherwise earned until the completion of the process set forth in this Student Code of Conduct, including the completion of all sanctions imposed, if any.

Both the complainant and the respondent have the right to an appeal. All appeals must be received within five business days, be in writing, and be based off one or more of the following reasons:

- To determine whether the student conduct board hearing was conducted fairly in light of the allegations and information presented, and in conformity with prescribed procedures giving the respondent a reasonable opportunity to prepare and present a response to those allegations. Deviations from designated procedures will not be a basis for sustaining an appeal unless significant prejudice results.
- To determine whether the sanction(s) imposed were appropriate for the violation of the Student Code of Conduct which the respondent was found to have committed.
- To consider new information, sufficient to alter a decision or other relevant facts not brought out in the original hearing, because such information or facts were not available at the time of the original student conduct board hearing.

The anticipated timeframe from the University receiving notice of a complaint to adjudication is sixty (60) calendar days.

### **Results for Employees**

An employee found responsible of violating University policy as it relates to sexual misconduct, sexual assault, dating violence, domestic violence, or stalking face sanctions ranging from formal discipline to termination from the University. In the case of collective bargaining unit employees, progressive discipline steps may be skipped due to the serious and egregious nature of the offenses. All possible sanctions that can be imposed to an employee found responsible for sexual misconduct, sexual assault, dating violence, domestic violence, or stalking include:

- Written Warning- A notice in writing to the employee of the violation of University policy. Written Warnings are placed in the employee personnel files.
- Suspension- An unpaid suspension served by the employee at the convenience of the department. A suspension may range from 1-15 days depending on the seriousness of the event.
- Demotion- An employee is demoted from current position to a reduced rank or status.
- Termination- An employee is immediately separated from employment with the University.
- Discretionary Sanctions Work assignments, training, and service to the community.

The anticipated timeframe from the University receiving notice of a complaint to conclusion of a pre-disciplinary hearing is sixty (60) calendar days.

### Retaliation

No person who files a complaint under this policy or participates in an investigation of a complaint under this policy will suffer any form of retaliation. The University is committed to preventing retaliation and complaints of retaliation will be taken seriously. Retaliation may be found even if the underlying complaint is found to have no merit. Complaints of retaliation are to be reported immediately to the office investigating the original complaint.

In 2014, the University held events and programs recognizing the significance of sexual misconduct, domestic violence, dating violence and stalking and brining education and awareness around the issues. Below is a description of just some of the many events and programs UT conducted in 2014:

January 15<sup>th</sup> Debbie Riddle talk: Debbie Riddle is a freelance graphic designer but became a national speaker on stalking when her youngest sister, Peggy Klinke, was murdered by her stalker in 2003. Her murder led to a congressional briefing and declaration of National Stalking Awareness month that is celebrated every January.

January 30<sup>th</sup> Alcohol, Tobacco, and other Drug Health Fair: The Sexual Assault Education and Prevention Program (SAEPP) had a table display of SAEPP materials to increase awareness about issues of sexual violence.

April 8<sup>th</sup> and 9<sup>th</sup> National Crime Victims Compensation Week: The Sexual Assault Education and Prevention Program (SAEPP) had a table display of SAEPP materials to increase awareness about issues of sexual violence.

April 15<sup>th</sup> Sexual Assault in the LGBTQ Community (Presentation and Discussion)

### Advocacy and Counseling

In addition to prevention and education, SAEPP provides to survivors confidential, pressure-free support and information about sexual assault reporting options, options for medical treatment and evidence collection, campus and community resources, and survivor's rights of sexual assault. SAEPP advocates are available to accompany survivors and provide support during medical visits, law enforcement contacts, and campus judicial hearings. Advocates are available 24 hours per day for students by contacting the SAEPP on-call telephone at (419)530-3431.

The advocate can also assist students with academic and on-campus housing accommodations. All University personnel should refer sexual assault survivors to SAEPP, located in Rocket Hall, room 1810.

### Advocacy and Counseling (continued)

The University Counseling Center provides free and confidential counseling services to enrolled students. Our counselors serve students presenting with a number of emotional concerns including the traumatic effects of having been victimized sexually. Counselors are available Monday through Friday during regular office hours, as well as after-hours for emergency situations. Counselors can provide individual screening for services, on-going individual or group counseling, crisis intervention, and consultation services.

### **Reducing Risk of Sexual Assault**

While you can never completely protect yourself from sexual assault; there are some things you can do to help reduce your risk of being assaulted.

### Avoid Dangerous Situations

- Be aware of your surroundings. Knowing where you are and who is around you may help you to find a way to get out of a bad situation.
- Try to avoid isolated areas. It is more difficult to get help if no one isaround.
- Walk with purpose. Even if you don't know where you are going, act like you do.
- Trust your instincts. If a situation or location feels unsafe or uncomfortable, it probably isn't the best place to be.
- Try not to load yourself down with packages or bags as this can make you appear more vulnerable.
- Make sure your cell phone is with you and charged and that you have cab money.
- Don't allow yourself to be isolated with someone you don't trust or someone you don't know.
- Avoid putting music headphones in both ears so that you can be more aware of your surroundings, especially if you are walking alone.

### *If someone is pressuring you*

- Remember that being in this situation is not your fault. You did not do anything wrong, it is the person who is making you uncomfortable that is to blame.
- Be true to yourself. Don't feel obligated to do anything you don't want to do. "I don't want to" is always a good enough reason. Do what feels right to you and what you are comfortable with.
- Have a code word with your friends or family so that if you don't feel comfortable you can call them and communicate your discomfort without the person you are with knowing. Your friends or family can then come to get you or make up an excuse for you to leave.
- Lie. If you don't want to hurt the person's feelings it is better to lie and make up a reason to leave than to stay and be uncomfortable, scared, or worse. Some excuses you could use are: needing to take care of a friend or family member, not feeling well, having somewhere else that you need to be, etc.
- Try to think of an escape route. How would you try to get out of the room? Where are the doors? Windows? Are there people around who might be able to help you? Is there an emergency phone nearby?

**Reducing Risk of Sexual Assault (continued)** 

*If someone is pressuring you (continued)* 

If you and/or the other person have been drinking, you can say that you would rather wait until you both have your full judgment before doing anything you may regret later.

### At Parties

- Be aware of rape drugs.
- Try not to leave your drink unattended.
- Only drink from un-opened containers or from drinks you have watched being madeand poured.
- Bring a friend(s) and watch out for your friend(s) and have your friend(s) watch out for you.
- Avoid group drinks like punch bowls.
- Cover your drink. It is easy to slip in a small pill even while you are holding your drink. Hold a cup with your hand over the top, or choose drinks that are contained in a bottle and keep your thumb over the nozzle.
- If you feel extremely tired or drunk for no apparent reason, you may have been drugged. Find your friends and ask them to leave with you as soon as possible.
- If you suspect you have been drugged, go to a hospital and ask to betested.
- Keep track of how many drinks you have had.
- Try to come and leave with a group of people you trust.
- Avoid giving out your personal information (phone number, where you live, etc.). If someone asks for your number, take his/her number instead of giving out yours.

What can bystanders do?

If you see someone in danger of being assaulted:

- Step in and offer assistance. Ask if the person needs help. NOTE: Before stepping in, make sure to evaluate the risk. If it means putting yourself in danger, call the police instead.
- Don't leave. If you remain at the scene and are a witness, the perpetrator is less likely to do anything.
- □ If you know the perpetrator, tell the person you do not approve of their actions. Ask the person to leave the potential victim alone.

If someone you know has been assaulted:

- Listen. Be there. Don't be judgmental.
- Be patient. Remember, it will take your friend some time to deal with thecrime.

### **Reducing Risk of Sexual Assault (continued)**

If someone you know has been assaulted (continued):

- Help to empower your friend or family member. Sexual assault is a crime that takes away an individual's power, it is
  important not to compound this experience by putting pressure on your friend or family member to do things that
  they are not ready to do yet.
- Encourage your friend to report the rape to law enforcement. If your friend has questions about the criminal justice process, talking with an advocate.
- Professional help is available through resources outside the University such as the National Sexual Assault Hotline, 1-800-656-HOPE.
- ☐ If your friend is willing to seek medical attention or report the assault, offer to accompany them wherever they need to go (hospital, police station, etc.).
- Encourage him or her to seek help, but realize that only your friend can make the decision to do so.

Get Involved:

- Speak out and educate yourself and others; we can help to decrease the number of sexual assaults.
- Become knowledgeable about the issue and share your knowledge with others. \*Source: From RAINN website

### Warning Signs of Relational Violence

### *If your partner*:

- is overly jealous, possessive, bossy or controlling
- is constantly checking on you
- won't accept breaking up
- constantly accuses you of being unfaithful
- doesn't trust you
- regularly yells at or insults you
- prevents or discourages you from seeing friends and family
- controls how you spend money
- grabs, hits, pushes or shoves you
- brags about mistreating others, loses his temper easily or has a history offighting
- pressures or forces you to have sex

Warning Signs of Relational Violence (continued)

*If your partner:* 

- is overly jealous, possessive, bossy or controlling
- is constantly checking on you
- won't accept breaking up
- constantly accuses you of being unfaithful
- doesn't trust you
- regularly yells at or insults you
- prevents or discourages you from seeing friends and family
- controls how you spend money
- grabs, hits, pushes or shoves you
- brags about mistreating others, loses his temper easily or has a history offighting
- pressures or forces you to have sex
- humiliates you in front of others
- has a history of bad relationships and blames others for his behavior
- destroys your property and things you care about
- abuses alcohol or drugs and may pressure you to do so

- The person continues to appear at unexpected locations
- Being watched from a distance
- Repeated phone calls
- Inappropriate gifts
- Finding yourself in the position of needing to be rescued flat tires, car out offuel
- Using manipulation to continue contact threating to harm oneself if contact isended
- Cyber stalking

University of Toledo Policy on Alcohol, Tobacco, & Drugs

### Policy Statement on Alcohol

The University of Toledo is a dynamic learning environment. Its students, faculty, staff, alumni, and guests interact in a wide variety of intellectual and social activities that extend outside of the classroom. We value and promote an environment of legal and responsible alcohol use and support alcohol-free environments. We recognize alcoholic beverages may be available at some campus activities. Such activities are consistent with the University's values when they foster moderation and safety in alcohol consumption.

The University complies fully with local, state, and federal regulations regarding the sale, possession and consumption of alcoholic beverages. The unlawful manufacture, possession, use or distribution of illicit drugs or controlled substances on University property or as part of University activities is strictly prohibited. All members of the University community are held responsible for their behavior and for respecting the rights of others. The University is committed to providing the community with education as it relates to illicit drug use, the consumption of alcohol in general and as it relates to high risk alcohol use, in particular. We provide programs, support and resources that promote making health-enhancing experiences a priority.

### **Policy Statement on Tobacco**

Students Tailgating on Game Day on the Main Campus

The University of Toledo Health Science Campus was made smoke-free and tobacco-free on January 1, 2008. Smoking and tobacco use is strictly prohibited inside any building and on all grounds of the Health Science Campus including satellite locations. The University of Toledo Main and Scott Park Campuses became smoke-free and tobacco-free on August 15, 2014. Smoking and tobacco use is also prohibited in all University-owned or leased vehicles. ### **Policy Statement on Drugs**

The possession, distribution and/or consumption of illegal drugs is prohibited on The University of Toledo campus. Persons who are discovered to be in possession of illegal drugs can be charged criminally under the applicable state or federal statues, and may also be charged administratively under University of Toledo policies. The University of Toledo is committed to promoting and maintaining a work and academic environment that this free from illegal drug use. The University complies with all federal, state and local laws as well as the Federal Drug Free Schools and campus Safety Regulations.



### University Regulations Governing Alcoholic Beverages

The Ohio Revised Code includes the following statements:

- (1) It is unlawful for a person under 21 years of age to purchase, consume, possess or transport any intoxicating liquor.
- (2) It is unlawful to knowingly and falsely misrepresent one's age to obtain alcoholic beverages or to represent that another is of legal age for such purpose.
- (3) It is unlawful to have in one's possession in a public place an open container of beer or intoxicating liquor.

- (4) It is unlawful to consume any beer or intoxicating liquor in a motor vehicle.
- (5) No person shall furnish or buy or contribute money to the purchase of alcohol for an underage drinker; and it is illegal to use false identification or provide false identification in the purchase of alcoholic beverages.

### (D) Regulations governing alcoholic beverages

The University permits alcoholic beverages on campus as part of the operation of licensed University facilities and for some social events.

### (1) Facilities

Policies and procedures for specific

University facilities may be in place. Such facilities include but are not limited to residence halls, the McComas Village, Student Union, Driscoll Alumni Center, Savage Hall, SeaGate Centre, the Glass Bowl, Libbey Hall, Academic Commons, Radisson Inn, Garden Café, Bryan Student Lounge, Mulford Library and Collier Building. Such policies must be consistent with the University policy.

### (2) Delivery

Delivery of any alcoholic beverages to any University property or facility, other than associated with the University's liquor license and catering operations, is strictly prohibited.

### (3) Independent Contractory / bivie exists Guessts

Where the University is paying for or reimbursing expenses for consultants, contractors, or others doing business for the University, University shall not pay for or reimburse any alcoholic beverage purchases.

### (4) Sponsored Whitersitty Functions

University Regulations Governing Alcoholic Beverages (continued)

The use of alcohol at events held on The University of Toledo campuses is governed by the following rules:

- (a) University funds may not be used to purchase alcoholic beverages.
- (b) Alcoholic beverages will not be served free of charge at a campus event unless the event is approved in advance in writing by the vice president or a designee and the event is otherwise permitted by University policy.
- (c) Unless otherwise approved in writing in advance by the vice president or a designee, alcoholic beverages must be sold by University dining services which are a licensed, insured vendor.
- (d) The sponsoring organization, department, or approved user of facilities will oversee adherence to the alcohol policy, assume responsibility for the event and control and supervise the distribution of alcoholic beverages in accordance with all applicable laws, rules, and policies.
- (e) Institutionally approved security must be present at all times during an event unless determined by the chief of University police to be unnecessary. All security costs will be the responsibility of the sponsoring organization.
- (f) No one under the age of 21 is permitted to possess, serve, or consume any alcoholic beverage. At any event where alcoholic beverages are served and/or sold, approval for the event will be based upon the age of the event participants as well as the nature of the event. For example, an event at which the majority of participants are under the age of 21 will nothave alcoholic beverages available for consumption. However, a designated, physically defined, monitored area may be utilized for those of age if approved in advance.
- (g) All sale/use of alcoholic beverages on University property will be monitored by and subject to inspection by University officials.
- (h) Although no person will possess or be served alcoholic beverages without proof of legal age, state law permits any individual 18 years or over to sell alcohol in a closed container, 19 years or older to serve an open container of alcohol and anyone over 21 to tend bar.
- (i) No servers of alcohol may be permitted to consume alcoholic beverages while serving nor shall they be permitted to serve while intoxicated.
- (j) Intoxicated people will not be served nor permitted to possess alcoholic beverages.
- (k) At all events where alcohol is used, served, and/or sold, non-alcoholic beverages and unsalted foods must be made available in quantity sufficient for the number of guests. All food should be visible and available.
- (I) Alcoholic beverages are not permitted to be sold or used prior to noon. For an event lasting three hours or more, sale or service must stop forty-five minutes prior to the end of the event. At no time may the sale/service of alcohol last more than three consecutivehours.
- (m) The minimum charge for twelve ounces of beer will be \$1.00. A lower price will be charged for the same amount of non-alcoholic beverage. Other alcoholic beverages should be priced so as not to promote excessive consumption.
- Under no circumstances may any alcoholic beverage be permitted to leave the approved area of the event. No alcoholic beverages may be brought into the event by an individual when alcoholic beverages are being served, and/or sold by event organizers.



University Regulations Governing Alcoholic Beverages

(E) Process to obtain permission for University events where alcohol will be served

At events at which alcohol is served and in University facilities in which it is served, operators and event sponsors are responsible for complying with the laws of the state of Ohio, ordinances of the city of Toledo, and all policies of The University of Toledo.

An "F" permit is required for any events that serve alcoholic beverages on University property that are not covered by the University's dining services liquor license. The administration for the Health Science Campus of the University does not review or approve "F" permits under any circumstance. All events must be conducted through the dining services liquor license. The University administration reserves the right in its sole discretion to refuse to sign any "F" permit for any reason whatsoever.

Depending on the associated division of the University, the following is the procedure for seeking approval of an "F" permit:

- (1) Athletics. If an outside person or business would like to hold an athletic related event on University property, an "F" permit needs to be completed and given to the Associate Athletic Director for Development. The Associate Athletic Director for Development with the University's Administrator for Risk Management will determine if the University's insurance will cover such event or the requesting party needs to obtain insurance and provide proof thereof before the "F" permit will be processed any further. Upon verification of insurance coverage for the event, the Vice President/ Director of Athletics will sign the "F" permit. It will then be forwarded to the Chief of Police who will sign that he has seen the "F" permit. The Chief of Police will then forward to the highest officer in finance at the vice presidential level for final sign off. The fully signed "F" permit will then be returned to the Associate Athletic Director for Development.
- (2) Alumni. If an outside person or business would like to hold an alumni event on University property, an "F" permit needs to be completed and given to the Associate Vice President of Alumni Relations. The Associate Vice President of Alumni Relations with the University's Administrator for Risk Management will determine if the University's insurance will cover such event or the requesting party needs to obtain insurance and provide proof thereof before the "F" permit will be processed any further. Upon verification of insurance coverage for the event, the Vice President of Institutional Advancement will sign the "F" permit. It will then be forwarded to the Chief of Police who will sign that he has seen the "F" permit. The Chief of Police will then forward to the highest officer in finance at the vice presidential level for final sign off. The fully signed "F" permit will then be returned to the Associate Vice President of Alumni Relations.
- (3) Student Event. If an outside person or business (or student organization, when applicable) would like to hold an event for students on University property, an "F" permit needs to be completed and given to the Dean of Students. The Dean of Students with the University's Administrator for Risk Management will determine if the University's insurance will cover such event or the requesting party needs to obtain insurance and provide proof thereof before the "F" permit will be processed any further. Upon verification of insurance coverage for the event, the Senior Vice President of the Division of Student Affairs will sign the "F" permit. It will then be forwarded to the Chief of Police who will sign that he has seen the "F" permit. The Chief of Police will then forward to the highest officer in finance at the vice presidential level for signature. The fully signed "F" permit will then be returned to the Office of the Dean of Students.

University Regulations Governing Alcoholic Beverages

- (a) Students and student organization are also required to complete the necessary paperwork to host a social event. This information can be found through the Office of Student Involvement, located in 2525 Student Union.
- (b) The sponsoring organization will be prepared to provide, in writing, information to the purpose of the activity, number of participants, location, and whether the activity is public or private.
- (F) Promotion of University events where alcohol will be served

It is the position of the University that alcohol use will not be promoted. Consistent with this position, the University will neither solicit nor accept any form of alcoholic beverage advertising or sponsorship for any University publication or in/on any University operated facility or property. In addition, the following guidelines shall be adhered to:

- (1) Events where alcoholic beverages are used, served and/or sold shall not have alcohol or the consumption of alcohol as a theme. No element of an event where alcohol will be used, served, and/or sold shall encourage, in any manner, the consumption of alcohol. No event where alcohol is used, served, and/or sold shall be sponsored, in any manner, by an alcohol manufacturer, distributor, or retailer.
- (2) (2) No advertising for events where alcohol is used, served, and/or sold shall refer to alcohol in any manner other than "Legal Beverages Available" or "Beer Available." Advertising for "F" permit events cannot include the sale price of alcoholic beverages nor can it refer to the price advantage or amount available.
- (G) Violations/Sanctions

Violation of University policies may result in disciplinary action. In addition, such matters may be reported by the University to appropriate law enforcement authorities. Violators will be subject to penalties which may include separation from the University or mandatory referral for treatment. The University shall implement and enforce the laws of the State of Ohio as stated in the Ohio Revised Code. It is the responsibility of each student, staff, and faculty member to familiarize him or herself with the appropriate sections of the Ohio Revised Code and the provisions of the policy and to conduct one's self in a responsible and prudent manner.

- (1) Violation of University policies by students will be addressed by the Student Code of Conduct.
- (H) Alcohol and Drug Policy Sanction Guidelines

It is the responsibility of a University to be concerned with the overall development of its students. The emphasis in the administration of student conduct is placed upon treating behavioral problems in a manner that relates to the educational purposes of a University.

### **University Regulations Governing Illicit Drugs**

The unlawful manufacture, possession, use or distribution of illicit drugs or controlled substances on University property or as part of University activities is strictly prohibited. The University of Toledo expects students, faculty, staff, and volunteers, and campus visitors to abide by all applicable local, state, and federal laws regarding illicit drugs and controlled substances.

### **Legal Requirements**

Under local, state, and federal laws, it is a crime to do any of the following.

- A) Underage Drinking
  - 1) Purchase, order, pay for, or share the cost of alcohol if you are under 21.
  - 2) Possess alcohol if you are under 21.
  - 3) Consume alcohol if you are under 21, unless it is provided by and consumed in the presence of your parent, legal guardian, or adult spouse.
  - 4) Sell alcohol to, buy alcohol for, or furnish alcohol to anyone under 21, even if you are the parent, legal guardian or adult spouse in your own home, apartment, or residence hallroom.
  - 5) Allow anyone under 21 who posses or consumes alcohol to remain in your home, apartment, or residence hall, or in other property that you own or occupy.
- B) False Identification
  - 1) Show or give false information about your name, age, or other identification to purchase or obtain alcohol if you are under 21.
  - 2) Provide false information about the name, age, or other identification of another person under 21 to purchase or obtain alcohol for that person.
- C) Open Container
  - 1) Have an open container of alcohol in your possession in any unlicensed publicplace.
  - 2) Have an open container of alcohol in your possession while driving or riding in or on a motor vehicle.
  - 3) Have an open container of alcohol in your possession while in or on a motor vehicle that is parked in or on a highway, street, or other place open to the public for parking.
- D) Transportation
  - 1) If you are under 21, you are considered to be driving under the influence if your blood alcohol level is .02 or higher and .08 at age 21. Refusing an alcohol test results in an immediate administrative license suspension.
  - 2) Consume alcohol while in a motor vehicle.
  - 3) Drive while under the influence of alcohol.
  - 4) Be in physical control of a vehicle while drinking or under the influence of alcohol.

### Legal Requirements (continued)

### E) Disorderly Conduct

(1) Engage in conduct that offends, inconveniences, annoys, or alarms others or that poses a risk of physical harm to yourself, to others, or to property while you are voluntarily intoxicated.

### F) Alcohol Sales

(1) Hold an event where alcohol is sold, or an event where alcohol is provided without charge but there is an entrance fee, cover charge, or other fee without an appropriate permit. Information on how to obtain a temporary liquor permit is available from the Ohio Division of Liquor Control by phone at 614-387-7407 and on the web at <u>http://www.com.ohio.gov/liqr/</u>. You must also have permission to serve alcohol on campus from the appropriate University authorities: <u>University of Toledo Policy on Alcoholic Beverages</u>.

### G) Illicit Drugs

- (1) Selling or offering to sell any controlled substance, or preparing or packaging any controlled substance for sale.
- (2) Distributing any controlled substance.
- (3) Knowingly obtaining, possessing, or using a controlled substance.

### State of Ohio Alcohol and Drug Law Criminal Sanctions

**Underage Drinking:** Ohio Revised Code (O.R.C.) 4301.63 provides that no person under the age of 21 shall purchase beer or intoxicating liquor.

**Penalty for a violation**: A fine of not less than \$25 but not more than \$100 may be imposed. The court may order that the fine be paid by the performance of public work at a reasonable hourly rate established by the court, and may specify the designated time in which the public work shall be completed.

False identification used to purchase alcohol for someone under 21: O.R.C. Section 4301.633 provides that no person shall knowingly furnish any false information as to the name, age, or other identification of any person under 21 years of age for the purpose of obtaining or with the intent to obtain, beer or intoxicating liquor for a person under 21 years of age, by purchase, or as a gift.

*Penalty for a violation:* Violation of O.R.C. section 4301.633 is a misdemeanor of the first degree. The maximum penalty is imprisonment for not more than 6 months and a fine not more than \$1,000.

False identification used to purchase alcohol by someone under 21: O.R.C. Section 4301.634 provides that no person under the age of twenty-one years shall knowingly show or give false information concerning the person's name, age, or other identification for the purpose of purchasing or otherwise obtaining beer or intoxicating liquor in any place in this state where beer or intoxicating liquor is sold under a permit issued by the division of liquor control or sold by the division.

**Penalty for a violation:** Violation of O.R.C. Section 4301.634 is a misdemeanor of the first degree, punishable by up to 6 months imprisonment and fines up to \$1,000. If a false or altered state identification card was used in commission of a violation of O.R.C. Section 4301.634, the punishment is a first degree misdemeanor with a fine of at least \$250 to \$1,000 and up to six months imprisonment.

State of Ohio Alcohol and Drug Law Criminal Sanctions

**Open container in a motor vehicle:** O.R.C. Section 4301.64 prohibits the consumption of beer or intoxicating liquor in a motor vehicle.

**Penalty for violation:** A violation of O.R.C. Section 4301.64 is a misdemeanor of the fourth degree punishable by up to thirty days in jail and a fine up to \$250.

**Furnishing or selling alcohol to someone under 21:** O.R.C. Section 4301.69(A) prohibits any person from selling or furnishing beer or intoxicating liquor to an person under 21 years of age, or buying it for any person under the age of 21.

**Penalty for violation:** Violation of O.R.C. Section 4301.69(A) is a misdemeanor punishable by a fine of at least \$500 but not more than \$1,000, and in addition imprisoned for up to 6 months.

**Underage purchase, possession or consumption of alcohol:** O.R.C. Section 4301.69(E) provides that no underage person shall knowingly order, pay for, share the cost of, attempt to purchase, possess, or consume any beer or intoxicating liquor in any public or private place or knowingly be under the influence of any beer or intoxicating liquor unless he or she is accompanied by a parent, spouse, or legal guardian who is not an underage person, or unless the beer or intoxicating liquor is given for religious purposes or by a physician for medical purposes.

**Penalty for violation:** A violation of O.R.C. Section 4301.69(E) is a misdemeanor of the first degree. The maximum penalty is imprisonment for not more than 6 months and fine up to \$1,000.

**Driving while intoxicated:** O.R.C. Section 4511.19 prohibits any person from driving a motor vehicle while under the influence of alcohol or drugs.

**Penalty for violation:** A violation of O.R.C. Section 4511.19 is misdemeanor of the first degree, the maximum penalty for which is a jail term of up to 6 months and a fine up to \$1,000. In addition, the court may impose additional fines, community rehabilitation or intervention programs, and suspend or revoke the offender's driver's license. Additional penalties exist for repeat offenders of O.R.C. Section 4511.19.

**Selling or distributing illicit drugs:** O.R.C. Section 2925.03 prohibits any person from selling or offering to sell any controlled substance, preparing or packaging any controlled substance for sale, or distributing any controlled substances.

**Penalty for violation:** Anyone who violates this statute is guilty of drug trafficking. Violation of this statute is a felony, the level of which depends on the specific criteria set forth in Section 2925.03(C), including type and weight of drug. The minimum penalty for a fifth degree felony can include 6 to 12 months in jail and/or a fine up to \$2,500. The maximum penalty for a first degree felony can include imprisonment up to 10 years and a fine up to \$20,000.

**Possessing or using illicit drugs:** O.R.C. Section 2925.11 prohibits any person from knowingly obtaining, possessing, or using a controlled substance.

**Penalty for violation:** Violation of this statute is drug abuse, which may be a misdemeanor or a felony depending on the specific criteria set forth in Section misdemeanor, is punishable by imprisonment of up to 30 days and a fine up to \$250. The maximum penalty, a first degree felony, is punishable by up to 10 years in prison and a fine up to \$20,000.

This information is provided as a general summary of the major applicable laws. Laws frequently are amended and reinterpreted, and the application of law to specific situations generally requires an analysis of all of the facts and circumstances. This information should not be substituted for specific legal advice.

State of Ohio Alcohol and Drug Law Criminal Sanctions

If you are charged with a crime it is a good idea to seek advice of an attorney. Legal representation is not permitted for student judiciary processes. Updates to these laws are generally reflected on the websites mentioned here, but individuals are ultimately responsible for knowing the laws. This information should not be substituted for specific legal advice.

The University of Toledo Student Code of Conduct and university policies and rules are campus behavior and safety standards that may result in sanctions, educational outcomes or penalties that are independent of any criminal considerations.

Violation of the laws referenced previously may also be a violation of The University of Toledo's Student Code of Conduct and University policies and rules and could result in University sanctions. It should also be noted that the University's expectations for appropriate behavior are higher than those under the law.

### Federal Drug Laws

Federal law prohibits the trafficking and illegal possession of controlled substances as outlined in 21 United States Code, Sections 841 and 844.

Depending on the amount possessed first offense maximum penalties for trafficking marijuana range from five years' imprisonment with a \$250,000, fine to imprisonment for life with a \$4 million fine for an individual, and from five years' imprisonment with a \$1 million fine to imprisonment for life with a \$20 million fine for more than one offender. Also depending on the amount possessed, first offense maximum penalties for trafficking Class I and Class II controlled substances (methamphetamine, heroin, cocaine, cocaine base, PCP, LSD, fentanyl analogue) range from five years' imprisonment with a \$2 million fine to imprisonment for life and a \$4 million fine for an individual, and from five years' imprisonment with a \$5 million fine to imprisonment for life and a \$4 million fine for more than one offender. First offense penalties for simple possession, 21 USCS §844, range from at most one years' imprisonment or at least a \$1,000, fine, or both; to at most 20 years' imprisonment and at least a \$1,000, fine.

### **Health Effects**

### **Health Effects of Alcohol**

Alcohol is a central nervous system depressant that is rapidly absorbed from the stomach and small intestine into the bloodstream. A standard drink equals 0.6 ounces of pure ethanol, or 12 ounces of beer; 8 ounces of malt liquor; 5 ounces of wine; or 1.5 ounces (a "shot") of 80-proof distilled spirits or liquor (e.g., gin, rum, vodka, or whiskey).

Risks	Possible Health Effects	
Intoxication	Intoxication can impair the brain function and motor skills. Intoxication increases the risk of death from automobile crashes, the leading cause of death of college- aged people.	
Heavy Drinking (Men: More than 4 drinks on any day or more than 14 drinks per week; Women: More than 3 drinks on any given day or more than 7 drinks per week)	Heavy drinkers have a greater risk of liver disease, heart disease, sleep disorders, depression, stroke, bleeding from the stomach, sexually transmitted infections from unsafe sex, and several types of cancer (liver, mouth, throat, larynx and esophagus). They may have problems managing diabetes, high blood pressure, and other conditions.	
Injuries	Drinking too much increases your chances of being injured or even killed. Alcohol is a factor, for example, in about 60% of fatal burn injuries, drowning, and homicides; 50% of severe trauma injuries and sexual assaults; and 40% of fatal motor vehicle crashes, suicides, and fatal falls.	
Birth defects	Drinking during pregnancy can cause brain damage and other serious problems in the baby. Because it is not yet known whether any amount of alcohol is safe for a developing baby, women who are pregnant or may become pregnant should not drink.	
Alcohol use disorders	Alcoholism or alcohol dependence is a diagnosable disease characterized by a strong craving for alcohol, and/or continued use despite harm or personal injury. Alcohol abuse, which can lead to alcoholism, is a pattern of drinking that result in harm to one's health, interpersonal relationships, or ability to work.

### **Anti-Harassment Policy Statement**

The University of Toledo is committed to high standards of professional conduct by all members of the University community, including faculty, students, residents, physicians, volunteers, employees, supervisors, managers and executive officers.

The commitment to high professional standards and conduct includes maintaining an environment that is free from sexual harassment and other forms of harassment to enable all

employees and students to perform to their highest level of potential. Harassment impedes the realization of the University's vision to become a leader among academic institutions and health science centers in education, service and research. The University is committed to creating an educational environment that facilitates the acquisition of both the knowledge and the interpersonal skills needed to provide effective, professional and compassionate care.

The University is also committed to creating and maintaining a hostile free academic and working environment while at the same time protecting freedom of speech and preserving the widest possible dialogue within its instructional and research settings.

Harassing conduct creates a hostile environment and may interfere with or limits a student's ability to participate in or benefit from the school programs. Harassment is usually a series of events however the more severe the conduct, the less need there is to show a repetitive series of incidents to prove a hostile environment. Indeed, a single or isolated incident of sexual harassment may create a hostile environment if the incident is sufficiently severe. A single instance of sexual assault is sufficiently severe to create a hostile environment.

Title IX protects students from sexual harassment in a school's education programs and activities. This means that Title IX protects students in connection with all the academic, educational, extracurricular, athletic, and other programs of the school, whether those programs take place in a school's facilities, on a school bus, at a class or training program. Title IX also prohibits gender-based harassment, which may include acts of verbal, nonverbal, or physical aggression, intimidation, or hostility based on sex or sex-stereotyping, even if those acts do not involve conduct of a sexual nature.

Pursuant to Title IX, the University does not discriminate on the basis of sex in admission to or employment in its education programs or activities. The University has designated the Vice President and Chief Human Resources and Talent Development Officer, Jovita Thomas-Williams as the University's Title IX Coordinator, responsible for coordinating all efforts to comply with and carry out its responsibilities under Title IX. All inquiries concerning the application of Title IX and its implementing regulations may be referred to the Title IX Coordinator.

### Harassment Reporting

The <u>Harassment Complaint Form</u> may be used to initiate a harassment investigation. The form may be downloaded and once completed, delivered to the Human Resources and Talent Development Office, at: Academic Services, suite 1000, on the Scott Park Campus.

The Sexual Harassment and Other Forms of Harassment sets guidelines to create a safe and hospitable environment.

### **Harassment Education**

To ensure that the campus community is knowledgeable about the policy and knows how to take appropriate actions for reporting and resolving complaints of harassment, a mandatory anti-harassment training program has been created.

The program, which includes viewing a 19-minute anti-harassment DVD, reading the harassment policy and taking a short quiz, was created by the Office of Institutional Diversity to make training comprehensive and convenient while fulfilling federal law requirements. The training can be taken online or via DVD and written quiz.

Members of the UT community can use their network username and password to link to the online training from the Monitor Intranet site. Training can take place from any computer connected to the Internet that has speakers and capable of playing Real Media video files. When training is successfully complete, the viewer completes a quiz online.

Additionally, all managers and supervisors can attend in-person Management Training classes on both Health Science Campus and Main Campus where there are classes devoted to training managers to recognize and prevent sexual harassment, other forms of harassment and retaliation.



### **Office of Student Conduct**

The Office of Student Conduct is responsible for the adjudication of cases involving students who are alleged to have violated University rules, regulations, or policies; federal or state laws; and/or municipality ordinances. The University's student conduct-related goals are: Provide students with due process; make students aware of the conduct process; recognize accountability and responsibility for their actions when applicable; and apply sanctions designed to assist students to prevent future occurrences and succeed in their educational endeavors.



The student conduct process is not a legal process and is separate from local, state, and federal court proceedings. Instead, the standard of responsibility is based on a preponderance of the evidence. The Student Code of Conduct applies to the conduct of all students and student organizations on the University premises. The code also applies to the offcampus conduct of students and student organizations in direct connection with:

- Academic course requirements or any credit-bearing experiences, such as internships, clerkships, field trips, study abroad, or student teaching;
- Any activity supporting pursuit of a degree, such as research at another institution or a professional practice assignment;
- Any activity sponsored, conducted, or authorized by the University or by registered student organizations;
- Any activity that causes substantial destruction of property belonging to the University or members of the University community; or causes serious harm to the health or safety of members of the University community; or
- Any activity in which a police report has been filed and a summons or indictment has been issued or an arrest has occurred for a crime of violence.

The Office of Student Conduct works closely with University officials as well as public safety agencies and stakeholders off campus to enforce the Student Code of Conduct. Upon written request, the University will disclose to the victim of a crime of violence or a non-forcible sex offense, the outcome of any disciplinary proceeding conducted by the institution against a student who is the alleged perpetrator of such an offense. If the alleged victim is deceased as a result of the offense, the University will provide the results of the disciplinary hearing to the next of kin, upon request.

### Weapons Restrictions FAQs

- 1. What University policies cover weapons?
  - a. Weapons Restrictions policy 3364-61-03
  - b. The Student Code of Conduct policy 3364-30-04 rule (13)

- 2. What does the Student Code of Conduct prohibit?

Illegal or unauthorized possession, use or unauthorized storage of firearms, fireworks, ammunition, dangerous chemicals, switchblade

knives, knives with blades three (3) inches or more, other weapons, or realistic replicas of weapons on University premises or use of any such item, even if it is legally possessed, in a manner that harms, threatens, or causes fear to others.

### 3. Do the same restrictions apply in a residence hall?

Yes. The Residence Life Living Guide however further restricts knives of *any* kind, with the exception of culinary knives used solely in kitchenette areas for cooking purposes. Weapons such as BB guns, pellet guns, air/CO2 guns, paint or blow guns, martial arts weapons are also expressly restricted in residence halls and should not be shipped, delivered or brought into a residence hall. Stun guns are also not allowed in the residence halls.

4. What rules apply if I have a CCW permit?

Possession of a valid concealed weapon permit authorized by the State of Ohio or any other state <u>is not</u> an exemption under this policy. An individual who has a valid CCW permit when on any UT property must lawfully secure the weapon in a locked vehicle.

### 5. May I carry mace or a "stun gun" for personal protection?

While the University does not endorse carrying mace or stun guns, they are not expressly prohibited from campus (remember stun gun are restricted in the residence halls). Any use of a stun gun or mace must be a bonafide self-defense situation otherwise the user may be found responsible for applicable policy violations resulting in discipline up to and including expulsion and or termination.

### **Office of Residence Life**

The University of Toledo has state of the art living centers known as 'residence halls.' Safety is the first priority for staff and students living, working and learning at UT. Under the Director of Residence Life, each residence hall is led by a Hall Director and Graduate Assistant. Resident Advisors (RAs) provide leadership on the floors of the residence halls and serve as the first line of security. RAs train and work with the Office of Public Safety to identify and address issues a resident may face in a residence hall.

Residence hall security is everyone's responsibility. Students are asked to be vigilant concerning the security of the residence halls. Remember, your residence hall is your home. Never leave doors of any building propped open or allow an unknown person or persons to enter. All guests must register at the information front desk and be escorted by residents of the building at all times. All residence halls have secure and controlled entry requiring a valid Rocket ID Card. Residents must carry their Rocket ID card at all times in order to be able to enter their assigned residence hall.

Never let anyone into your suite or room who you do not know. Suite and room doors should always remain locked, even when you are there. Respecting the privacy and space of others is necessary. It is illegal to enter another person's suite unin-

vited. Individuals who enter a room uninvited may appear as being social or lost but actually may be looking for opportunities to commit crimes. Please report any suspicious incidents immediately to the UTPD at 419.530.2600.

To safeguard and protect the campus community, any lost keys, rocket cards, and any door which is not securing properly should be reported to Residence Life staff immediately. Never lend out or duplicate a key. The number one theft-prevention measure is to keep individuals that do not belong in the residence halls out. Make sure that all guests are signed in and no unfamiliar person follows you into a building. While the social norm is to hold the door for a person entering behind you, building security is compromised when persons enter this way. If an unknown person appears suspicious and waiting for someone to enter in order to gain access, alert Residence Life staff immediately or call the UTPD at 419.530.2600.

Sometimes a student may struggle with a problem that places that student or even others in harm's way. Most often the student is in need of some type of help or assistance. The Student Behavior Review Committee (SBRC) was formed to bring University resources together to address student safety situations and get students in need, the help they need.

Chaired by the Senior Vice President for Student Affairs, the SBRC consists of department heads from across the University including: the UTPD, Residence Life, the Counseling Center, the Provost's Office, the Dean of Students and Office of Student Conduct. The SBRC develops specific action plans and provides student intervention before a situation escalates. The SBRC has helped students suffering from eating disorders, relationship problems, medical and mental health issues, and other areas of need. Beyond practicing safe habits, many UT students participate in a variety of events throughout the academic year. Examples include the Silent Witness initiative aimed at stopping domestic and intimate partner violence and Take Back the Night, a visible way to take a stand against sexual violence, specifically violence against women.

Students have also formed campaigns around fan safety at athletic events and registration for UT's important emergency text message system – UT Alert. Finally, students are the key contributors to important committees focused on safety including the Safety Awareness Committee and Neighborhood Relations Committee. ### **Security and Access to Campus Facilities**

### **Overview**

The University of Toledo academic and administrative buildings are open during business hours to all University students, faculty, staff, and guests. Hours may vary from building to building depending on the buildings function and schedule of activities. Hours of operation may change due to holiday and break periods and semester session. After-hours access to those with permission are provided through the Rocket Card. Residence Halls are secured 24 hours a day and access is provided to residents through the Rocket Card.

Campus lighting plays an important role in deterring crime and creating an environment that feels safe at night. The University of Toledo has upgraded outdoor lighting, using efficient and bright LED lights. All light poles are numbered making it easy to report a light in need of repair or replacement. The University relies on the community to report environmental and facility related safety issues; whether it be lighting, a door that is failing to secure, an uneven sidewalk or other hazards. # **Theft Prevention**

#### Overview

The most frequent crime reported on campus is theft. Theftsare largely crimes of opportunity and preventable. Remember the responsibility to reduce incidents of theft is shared by everyone. The unsafe habits of one person leaving a door open or unsecure may lead to roommates, classmates and others becoming victims. It is imperative that members of the campus community partner with the UTPD to make our campuses safe and conducive for learning. Please be vigilant about security and report suspicious incidents immediately.

#### **Residence Halls**

The once utilitarian "college dorm room" has been transformed into a very modern living and learning environment. Advancements in technology have resulted in the popularity of HD flat screen televisions, portable media devices, smart phones, laptop computers, gaming systems and more. The high cost and easy portability of these items make them desirable to unscrupulous individuals. Please make sure suite doors and room doors are always locked and secured. It only takes a moment for a person to access an unlocked room and take thousands of dollars' worth of merchandise. Nearly all thefts reported to the UTPD involved no forced entry. Please, keep suite and room doors secured.



#### **Student Recreation Center**

The Student Recreation Center encourages you to secure all items in a locked locker. Coin lockers are available in both the men's and women's locker rooms. Wallet lockers are available just outside of the entryway to the women's locker room.

A limited availability of locks may be checked out with a photo ID at the equipment issue desk (located on the lower level of the Recreation Center).

#### **Bicycles**

UT has two campus "bike pads" for members of the campus community located on the east side of the West Ramp and on the east side of Stranahan north. The bike pads provide a secure area to store your bike and helmet and other supplies. The centrally-located bike pads are surrounded by security fencing and surveillance cameras. Lockers are available for 25 cents. The area is accessible with a valid UT Rocket Card.

#### Register Valuables Online at 'myUT'

Students, faculty, and staff may now register their valuables online via the 'myUT' web site. Simply logon to your 'myUT' account, click on the 'personal information' tab and select 'Register Electronic Devices and Bikes.' Here you will be able to record identification information related to your valuables including: Item, color, make, model, serial number, purchase date, and estimated purchase price. Should an item become lost or stolen, this registry will be an important resource when filing a police report and/or insurance claim.

**On-Campus**

Any building or property owned or controlled by The University of Toledo within the same reasonably contiguous geographic area and used by the University in direct support of, or in a manner related to, the University's educational purposes, including residence halls; and

Any building or property that is within or reasonably contiguous to the area identified in the above paragraph that is owned by The University of Toledo but controlled by another person, frequently used by students, that supports institutional purposes.

#### **On-Campus Student Housing (Residence Halls)**

Any student housing facility that is owned or controlled by the institution, or is located on property that is owned or controlled by the institution, and is within the reasonably contiguous geographic area that makes up the campus.

#### **Non-Campus**

Any building or property owned or controlled by a student organization that is officially recognized by The University of Toledo; or

Any building or property owned or controlled by The University of Toledo that is used in direct support of, or in relation to, the University's educational purposes, frequently used by students and is not within the same reasonably contiguous geographic area of the University.

#### **Public Property**

All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus or immediately adjacent to and accessible from campus.

#### **CRIME CLASSFICATIONS**

#### **Aggravated Assault**

An unlawful attack by one person upon another for purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

#### Arson

Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling, house, public building, motor vehicle or aircraft, personal property of another, etc.

#### Burglary

The unlawful entry of a structure or conveyance to intent to commit a crime therein.

#### **Dating Violence**

Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.

#### Destruction / Damage or Vandalism to Property (Hate Crimes Only)

To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of the property.

#### **Domestic Violence**

Crimes of violence committed by a current/former spouse of the victim; person with whom the victim shares a child in common; person who is cohabitating with or has cohabitated with the victim as a spouse; or person similarly situated to a spouse of the victim.

#### **Hate Crimes**

A criminal offense committed against a person or property which is motivated, in whole or in part, by the offenders' bias. **Bias** is a preformed negative opinion or attitude toward a group of persons based on their:

#### Intimidation (Hate Crimes Only)

To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

#### Larceny / Theft (Hate Crimes Only)

The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

#### **Motor Vehicle Theft**

The theft or attempted theft of a motor vehicle. (*Note: Classify as motor vehicle theft all cases where automobiles are taken by persons not having lawful access, even though the vehicles are later abandoned—including joy riding*).

#### Murder / Non-Negligent Manslaughter

The willful (non-negligent) killing of one human being by another. This includes any death caused by injuries received in a fight, argument, quarrel, assault, or commission of a crime. (*Note: Murder/Non-negligent Manslaughter does not in-clude deaths caused by negligence, assaults/attempts to murder, suicides, fetal deaths, traffic fatalities, accidental deaths, or justifiable homicides—defined as and limited to the killing of a felon by a peace officer in the line of duty, or the killing of a felon during the commission of a felony, by a private citizen).* 

#### **Negligent Manslaughter**

The killing of another person through gross negligence (defined as the intentional failure to perform a manifest duty in reckless disregard of the consequences as affecting the life or property of another). (Note: Negligent Manslaughter does not include deaths of persons due to their own negligence, accidental deaths not resulting from gross negligence, or traffic fatalities).

#### Robbery

The taking or attempting to take anything of value from the care, custody, or control of a person by force or threat of force or violence and/or by putting the victim in fear.

#### Sex Offense (Forcible)

Any sexual act directed against another person without the person's consent.

Rape: Penetration or attempted penetration, however slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

Sexual assault: The attempted touching or touching of the intimate parts (sexual organs, anus, groin, breasts or buttocks) of another person.

#### Sex Offense (Non-Forcible)

Any attempted or completed unlawful, but consensual sex act with a person.

Incest: Sexual intercourse between persons who are related to one another within the degrees wherein marriage is prohibited.

Statutory rape: Intercourse with a person who is under the age of consent.

#### Simple Assault (Hate Crimes Only)

An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration or loss of consciousness.

#### Stalking

Engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for his/her safety or the safety of others; or suffer substantial emotional distress.

#### **ARREST / REFERRAL CLASSIFCIATIONS**

#### Weapon Law Violations

The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: Manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; all attempts to commit any of the aforementioned.

#### **Drug Abuse Violations**

Violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: Opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone); and dangerous non-narcotic drugs (barbiturates, Benzedrine)

#### **Liquor Law Violations**

The violation of laws or ordinance prohibiting: The manufacturer, sale, transporting, furnishing, possessing of Intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; all attempts to commit any of the aforementioned. (*Note: Drunkenness and driving under the influence are not included in this definition*).

#### Notes

a. "Public Property" statistics include police reports taken from other municipalities and Toledo Police that are adjacent to the University's campuses, including: Toledo, Lucas County, Sylvania Township, Oregon, and the Village of Ottawa Hills. Every effort has been made to comply with the definitions contained in the Handbook for Campus Crime Reporting, however Public Property statistics provided by municipalities are not independently verified by the University, and may include reports of crimes that occurred in private residences or businesses or in other "non-campus" locations.

b. Municipal police departments provide

statistics for Public Property and Non-Campus according to F.B.I. Uniform Crime Reporting (U.C.R.) requirements. Sex Offenses have been re-categorized pursuant to the Uniform Crime Reporting National Incident Based Reporting System (NIBRS), as required by the Clery Act.

c. The F.B.I. defines "forcible sex offenses" as rape and attempt (including penetration, no matter how slight, of the vagina or anus with any body part of object, or oral penetration by a sex organ of another person, without the consent of the victim); forcible fondling; forcible sodomy and sexual assault with an object. "Non-forcible sex offense" is defined as incest and statutory rape.

d. The City of Toledo includes statistics for incest, if any, in its statistics for forcible sex offenses.

e. Hate crimes are crimes that manifest evidence that the victim was intentionally selected because of the victim's actual or perceived race, religion, national origin, sexual orientation, gender, gender identity, ethnicity or disability. Reportable hate crimes include the offenses of Aggravated Assault, Arson, Burglary, Manslaughter-Negligent, Murder and Non-Negligent Manslaughter, Motor Vehicle Theft, Robbery, Forcible Sex Offenses, Non-Forcible Sex Offenses, and other hate crimes involving bodily injury. Effective in 2009, reportable hate crimes include all of the offenses listed above as well as Larceny-Theft, and Simple Assault.

f. Public property statistics, if any, for alcohol arrests provided by other law enforcement agencies may also include statistics for driving while intoxicated (which are not a reportable offense in accordance with the Department of Education guidelines).

g. "Campus," "Non-Campus" and "Public Property" statistics are provided by local municipalities, and these statistics reflect the most current data provided to the University. To the extent any of the crime statistics differ from previous reports, the figures in this year's report reflect the most current data provided to the University.

h. Some reporting jurisdictions may not provide or are unable to provide the University with statistics broken down specific to the Clery Act geographic areas.

i. Some reporting jurisdictions may fail to respond to requests from the University for applicable statistical information.

### **Crime Statistics**

#### Daily Case / Fire Log

The UTPD assembles a 'Case and Fire Log' in an effort to provide the campus community with general information as it relates to incidents reported on and about The University of Toledo campuses. Because the UTPD takes reports of noncriminal incidents as well, the UTPD 'Daily Case and Fire Log' contains both Clery required statistics as well as nonrequired statistics. This log may be found on the UTPD website: <u>Daily Case and Fire Log</u>. This log provides UTPD activity beyond what is required pursuant to The Student Right to Know and Campus Security Act of 1990.

#### Overview

The "Jeanne Clery Disclosure of Campus Security Policy and the Campus Crime Statistics Act of 1998," commonly referred to as the "Clery Act," requires institutions of higher education receiving federal financial aid to report specified crime statistics on college campuses and to provide other safety and crime information to members of the campus community.

The Higher Education Opportunity Act (HEOA) of 2008 and the Violence Against Women Act of 2013 made several changes to the Clery Act and are hereby incorporated as part of The University of Toledo policy. This policy was prepared as part of the University's commitment to security and safety on campus and to meet the requirements of the Student Right to Know and Campus Security Act of 1990 (amended November 1998 and renamed the Clery Act and further amended by the Higher Education Opportunity Act of 2008). This act requires colleges and universities to prepare, publish, and distribute to all prospective students, current students and employees information pertaining to the University's security policies, procedures, and programs.

In July 2015, The University of Toledo hired a full-time dedicated Clery Act Compliance Officer whose primary responsibilities include but are not limited to: coordinating, monitoring and working collaboratively with various departments at UT to ensure compliance with the Clery Act and associated regulations. The Clery Act Compliance Officer reports to the Internal Audit and Compliance Office.

The University publishes crime statistics every year. The annual report is a summation of the crime statistics for the past three years. The Crime Statistics are listed below and can also be found archived at the University Police web site: <u>Crime Statistics</u>.

# Life Safety / Fire Safety

The University of Toledo Fire and Life Safety Program operates out of the Facilities Maintenance and Construction department. Within this department there are six full-time State Certified Fire and Life safety technicians that are assigned to various buildings across the campuses of the University of Toledo. The life safety technicians ensure that all fire code violations are corrected in a timely manner. They maintain all suppression systems throughout the University campus. These include: fire pumps, fire extinguishers, chemical suppression hoods, halon or inergen systems and sprinkler systems.

They also oversee the work of any outside contractors that modify or repair University fire systems. In addition, the life safety technicians maintain all the University's fire detection systems to code. These include: fire alarms, smoke detectors, pull stations, horns and strobes and also adjust the time settings campus wide for all of the University's automatic electric clocks (from daylight savings to eastern standard and back) and make any repairs to the clocks as necessary.

The Fire and Life Safety Technicians with assistance from Environmental Health and Radiation Safety staff provide review of fire protection engineering plans along with capital projects. The fire and life safety techs also perform acceptance tests of new fire protection systems to allow for occupation of new built and renovated spaces.

Code compliance consultation also is a major function of life and fire safety staff and they are constantly serving as a liaison with local, state and federal regulatory agencies. Additionally, the Fire and Life Safety Technicians are responsible for the continued operation of proprietary fire alarm monitoring stations across our campuses. The Fire Safety Inspection Program is a joint effort between the Fire and Life Safety Technicians University Police, and the Safety and Health Staff members. These inspections consist of regular inspections of existing buildings conducted with the local and state fire authorities and by UT staff members. These are in the form of routine inspections and fire watches when fire systems may be impaired.

Environmental Health and Radiation Safety staff works with the state fire marshal and industrial commission to preinspect tents at all home football games and special events. In addition, staff from Environmental Health and Radiation Safety attend all home games and monitor all special event location for fire and life safety.

Residence Life staff receive annual intensive training in the areas of Life Safety and Fire Safety through the Office of Environmental Health and Radiation Safety. Plans are in place in advance to accommodate students with special needs. The training includes the operation of fire extinguishers. Each residence hall is equipped with fire suppression system and four full scale fire drills are conducted annually in each residence hall.

#### Fire Alarm Activation: What to Do

When the fire alarm is activated, all residents and guests must immediately leave the building using the nearest stairs and exits. Do not use the elevators. Follow the directions of the residence hall staff, police, safety and health, or fire department personnel. Rooms may be checked in order to confirm evacuation of all occupants.

Anyone who intentionally activates the fire alarm system when there is no fire is subject to prosecution through the criminal court system and/or disciplinary action through the University judicial system. The expected sanction for such a violation is suspension from the University for a minimum of one semester and remuneration of costs incurred.

Anyone who tampers with fire safety equipment or removes it from its proper location, other than for proper use, is subject to disciplinary action. The minimum University sanction for a first time violation is a \$50 fine and may result in termination of the resident's housing contract. #### R.A.C.E.

If you are involved in a fire, remember R.A.C.E. acronym to help you respond safely and correctly:

#### R = RESCUE

anyone in immediate danger from the fire, if it does not endanger your life **A = ALARM** sound the alarm by calling "2600" (on-campus locations only) and activating a pull station alarm box **C = CONFINE** the fire by closing all doors and windows **E = EXTINGUISH** the fire with a fire extinguisher, or EVACUATE the area if the fire is too large for a fire extinguisher

#### Proper Use of Fire Extinguishers (P.A.S.S.)

To use fire extinguishers correctly, remember the P.A.S.S. acronym:

P = PULL
the pin on the fire extinguisher
A = AIM
the extinguisher nozzle at the base of the fire
S = SQUEEZE
or press the handle
S = SWEEP
from side to side until the fire appears to be out

#### **Fire Extinguisher Selection**

Virtually all fires are small at first and might easily be contained if the correct type of extinguisher is readily available and properly used. Use the information provided in the Fire Extinguisher Selection guide to insure that the type of extinguisher you choose is appropriate for the area and materials you are trying to protect.

#### **Student and Employee Guide to Portable Fire Extinguishers**

When to Fight a Fire ...

Fight the fire only if all of the following are true:

- Everyone has left or is leaving the building
- The Fire Department or Campus Police is being called
- The fire is small and confined to the immediate area where it started (waste basket, cushion, small appliance, etc.)
- You can fight the fire with your back to a safe escape route
- Your extinguisher is rated for the type of fire you are fighting
- You know you can effectively operate a fire extinguisher

#### Remember ...

A portable fire extinguisher can put out a small fire or contain it until the Fire Department arrives. Portable fire extinguishers are not designed to fight a large or spreading fire. Even against small fires they are useful only under the right conditions.

- An extinguisher must be large enough for the fire at hand. It must be fully charged and in working order - The operator must know how to use the extinguisher quickly without taking time to read the directions

#### When NOT to Fight a Fire ...

There are times when you should not fight a fire with a portable extinguisher:

- If the fire is spreading beyond the immediate area where it started, or is already alarger fire
- If the fire could block your escape route
- If you are unsure of how to properly operate the extinguisher
- If you are in doubt whether the extinguisher is proper for the type of fireat hand

If any one of these conditions is true, leave immediately. Close off the area and leave the fire to the Fire Department.

#### Protect Yourself at All Times ...

- Stay low to the ground and position yourself between six and eight feet away from the fire

- Avoid breathing the heated smoke and fumes or the extinguishing agent

If the fire starts to spread or threatens your escape route, get out immediately
Make it a point to notice the locations of the fire extinguishers in your area
Pick up a fire extinguisher in a non-emergency situation, look at it, know its weight, and know the type of fire it will extinguish

# Higher Education Opportunity Act Definitions

Cause of Fire:

The factor or factors that give rise to a fire. The causal factor may be, but is not limited to, the result of an intentional or unintentional action, mechanical failure, or act of nature (324 C.F.R. 6688.449 (67)).

Fire:

Any instance of open flame or other burning in a place not intended to contain the burning or in an uncontrolled manner (394 C.F.R. 6668.499 (a)).

#### Fire Drill:

A supervised practice of a mandatory evacuation of a building for a fire (34 C.F.R. 668.49 (a)).

### **Higher Education Opportunity Act Definitions**

#### Fire Log:

(1) An institution that maintains on-campus student housing facilities must maintain a written, easily understood fire log that records, by the date that the fire was reported, any fire that occurred in an on campus student housing facility. This log must include the nature, date, time, and general location of each fire. (2) An institution must make an entry or an addition to an entry to the log within two business days, as defined under §668.46(a), of the receipt of the information.(3) An institution must make the fire log for the most recent 60-day period open to public inspection during normal business hours. The institution must make any portion of the log older than 60 days available within two business days of a request for public inspection. (4) An institution must make an annual report to the campus community on the fires recorded in the fire log. This requirement may be satisfied by the annual fire safety report described in paragraph (b) of this section (*34 C.F.R. 668.49(d*)).

#### Fire-Related Death:

Any instance in which a person— (1) Is killed as a result of a fire, including death resulting from a natural or accidental cause while involved in fire control, attempting rescue, or escaping from the dangers of a fire; or (2) Dies within one year of injuries sustained as a result of the fire (34 C.F.R. 668.49 (a)).

#### Fire-Related Injury:

Any instance in which a person is injured as a result of a fire, including an injury sustained from a natural or accidental cause, while involved in fire control, attempting rescue, or escaping from the dangers of the fire. The term "person" may include students, employees, visitors, firefighters, or any other individuals.

#### Fire Safety System:

Any mechanism or system related to the detection of a fire, the warning resulting from a fire, or the control of a fire. This may include sprinkler systems or other fire extinguishing systems, fire detection devices, stand-alone smoke alarms, devices that alert one to the presence of a fire, such as horns, bells, or strobe lights; smoke-control and reduction mechanisms; and fire doors and walls that reduce the spread of a fire (*34 C.F.R. 668.49 (a)*).

#### **Fire Statistics:**

(1) An institution must report statistics for each on-campus student housing facility, for the three most recent calendar years for which data are available, concerning— (i) The number of fires and the cause of each fire;(ii) The number of persons who received fire-related injuries that resulted in treatment at a medical facility, including at an on-campus health center; (iii) The number of deaths related to a fire; and (iv) The value of property damage caused by a fire. (2) An institution is required to submit a copy of the fire statistics in paragraph (c) (1) of this section to the Secretary on an annual basis (*34 C.F.R. 668.49 (c)*).

#### Value of Property Damage:

The estimated value of the loss of the structure and contents, in terms of the cost of replacement in like kind and quantity. This estimate should include contents damaged by fire, and related damages caused by smoke, water, and overhaul; however, it does not include indirect loss, such as business interruption (*34 C.F.R. 668.49 (a*)).

### Campus Security 2015 Annual Security Report

The information and statistics contained in this publication are being presented in compliance with The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act. Lorain County Community College's Campus Security Office publishes this information to inform members of the campus community and other interested parties of incidents of crime and to educate them in effective crime prevention and safety measures so that they can make informed decisions relative to their safety. The crime statistics reflect incidents that occurred on any LCCC campus or on public property adjacent to the campuses. Lorain County Community College does not provide residential dormitories or facilities for on campus student housing. The Campus Security Office has primary responsibility for categorizing, disseminating and publishing crime statistics collected on campus and includes statistics obtained from various local law enforcement entities including Elyria, Wellington, Lorain, and Brunswick Police Departments.

The Campus Security office is located on the first floor of the Library/Community Resource Center, across from the North Branch of the Elyria Public Library and can be reached from anywhere on campus by calling 440-366-4053 or TDD 440-366-4136. For on campus emergencies, dial 4444 from a regular college telephone or 440-366-4444 from a cellular phone. For emergencies necessitating an immediate police, fire or EMS response, please call 9-1-1. Visit **www.lorainccc.edu/ security** to view emergency procedures.

Campus security is provided by the office of Campus Security, which has officers on duty 24 hours a day, seven days per week. Eighteen full-time and part-time officers maintain a visible security presence and patrol the campus roadways, walkways, parking areas and buildings. Specific elements of the Campus Security mission include: accident investigation; crime prevention; vehicle assists; incident investigation; parking and traffic enforcement; emergency response; and disastercoordination.

Campus Security officers are a proprietary security force responsible for maintaining public order on campus. The approach to this responsibility is with professionalism and discretion and with the understanding that service to the campus community is paramount.

Campus Security officers are non-commissioned security personnel who are experienced in: cardiopulmonary resuscitation; accident investigation; patrol procedures; traffic control; report writing; human interaction; and enforcement of the Code of Conduct (<u>www.lorainccc.edu/conduct</u>). The Campus Security officers do not carry firearms and do not have arrest powers.

Additionally, Campus Security officers are required to have a high school diploma and at least one year of experience in police, security and/or military environment. All officers are encouraged to further their professional development through the tuition-waiver program. Periodic, office-sponsored training sessions are offered, dealing with basic campus safety, domestic violence, sexual assault prevention, unarmed self-defense and other in-service training relating to specific needs.

To carry out the security patrol mission, Campus Security operates marked campus security vehicles. In addition Campus Security maintains a vast CCTV system, supervised by the officers that will monitor many interior public areas, labs, and high-risk areas as well as most exterior parking lots.

Campus Security is responsible for ensuring campus buildings are secured after hours and for unlocking facilities at the start of each day as part of the 24-hour-per-day on-campus security presence.

Campus Security personnel provide assistance to the campus community in the following areas: vehicle assistance (jump starts, unlocks, tire inflation); emergency response and CPR; information and directions; escorts to and from parking areas and classrooms; investigation of incidents/crimes occurring on campus; and patrol of campus roadways, walkways, parking areas and buildings. In addition, the department conducts or sponsors informational sessions addressing substance abuse, personal protection, crime prevention and sexual assault and domestic violence awareness and emergency preparedness. In situations requiring assistance from community-based services Campus Security promptly summons help from local first responders.

LCCC encourages students and employees to promptly report crimes on campus to Campus Security officers and local law enforcement agencies on a voluntary basis. Normally, crimes should be reported to Campus Security or by dialing 9-1-1 from a cellular phone or campus phone to make contact with the local law enforcement authority having jurisdiction. Elyria Police (9-1-1) which has primary jurisdiction for investigation of crimes at the Elyria campus, the Lorain County Sheriff (Growth Partnership), Lorain Police (Lorain Learning Center), North Ridgeville Police (University Partnership Ridge Campus), Wellington Police

(Wellington), and Brunswick Police (Midpoint) maintain jurisdiction at the other campuses. Report crimes in person by coming to the first floor of the Library/Community Resource Center, LC 106, by calling extension 4444 or 4053 from a campus phone, or (440) 366-4444/ (440) 366-4053 via cell phone or use one of the emergency phones located in building hallways to make immediate contact with a Lorain County 911 operator who will notify local first responders and Campus Security if applicable. To report crimes in progress at the other campuses, simply dial 9-1-1.

Furnish all pertinent information when reporting an incident. Campus Security working in conjunction with the local law enforcement agency will conduct the appropriate investigation and file the necessary report(s). Follow-up pursuits will include efforts to identify responsible parties, recover stolen property, pursue code of conduct action with the coordinator for code of conduct and encourage restitution when feasible.

Campus Security maintains an excellent working relationship with the Elyria, Lorain, Wellington, North Ridgeville and Brunswick Police Departments, as well as the Lorain County Sheriff's Office and assistance is provided in a prompt and professional manner when requested. The law enforcement organizations regularly provide current information and data concerning criminal activity in and around the LCCC campuses and any LCCC off campus event where such crimes may present an ongoing threat to the health and safety of our campus community members.

<u>Crimes may also be reported to any Campus Security Authority</u> - defined as any official of the College who has significant responsibility for student and campus activities. Campus Security Authorities include Selina Gaddis, Manager, Student Life (440-366-7648), athletic team coaches and advisors to student clubs and organizations. The law requires that all crimes reported to any Campus Security Authority be included in the College's statistics and evaluated relative to its timely warning policy. Professional mental health counselors are excluded from this requirement, however, the College encourages such mental health professionals to, when they believe it appropriate, inform the person being counseled of procedures to report crimes on a voluntary, confidential basis for inclusion in the annual report.

### Timely Warnings Policy Statement

Campus Security maintains and reports yearly crime statistics available at <u>www.lorainccc.edu/crimestats</u> and, when appropriate, will issue **timely warnings** to the campus community relative to potential criminal activity.

LCCC strives to provide safe and secure campus environments. Occasionally an incident may take place on our campuses or information is received from a local law enforcement agency regarding an incident that occurred in the immediate vicinity of one of the campuses which is considered potentially threatening. If any member of the campus community knows of a crime or other serious incident should report that incident as soon as possible to the Campus Security office or call 9-1-1 so that a timely warning can be issued. When we are made aware of such information, we will issue **timely warnings** via e-mail, text alerts and placed on the College's website– www.lorainccc.edu. The Campus Security office also maintains a daily crime log which is made available for public viewing during regular business hours (8:30am-7:30pm) in LC 106 or you can review the log by visiting <u>www.lorainccc.edu/security</u> and click on "daily crime log."

### Emergency Response and Evacuation

LCCC has implemented a comprehensive Emergency Notification System that can alert and inform campus community members in the event of an imminent threat to health and safety (e.g. tornado, active shooter, hazardous material spill, etc.).

Upon confirmation from a Campus Security officer or College official regarding a significant emergency or dangerous situation involving an immediate threat to the health and safety of campus community members, emergency notifications will be disseminated without delay to campus community members via text message and email alerts, internal public address system and an external siren (where applicable). The director or manager of campus security, working in conjunction with other College officials will determine the content of the emergency notification, select the most appropriate method(s) for disseminating the information as quickly as possible, and initiate the notification system. The director or manager of campus security, campus security officers and authorized College personnel have responsibility for issuing notifications via the College's Emergency Notification System. The text message system LCCC Alerts (www.lorainccc.edu/alerts) is a free service that students and staff can subscribe to in order to receive information directly to their text enabled mobile phone in the event of an emergency or campus closure. The external siren is capable of producing audible and voice commands to the campus community in the event of an emergency. When you hear the audible alert tone, you will immediately be instructed on what steps to take next to ensure your health and safety which could include seek shelter inside immediately, stay inside until further notice or evacuate the campus immediately. Other emergency notification methods the College emplovs can include fliers posted at entryways, the College's homepage (www.lorainccc.edu), digital displays, electronic marguis and broadcast television alerts. A special emergency hotline, 440-366-4911,

has been established to furnish emergency information to the larger community. Additional information can also be found on the College's web site as well as local radio and television stations.

Emergency evacuation routes are conspicuously posted in each classroom on our campuses. Additionally, various procedures for responding to emergencies can also be found on the College's homepage by visiting <u>www.lorainccc.edu/security</u> and click on "emergency procedures". College officials will conduct annual tests and exercises of emergency response and evacuation procedures in order to ensure an orderly response to incidents necessitating such measures and to continuously assess the readiness of our emergency response and recovery capabilities. Tests will be announced in advance via email, the College's homepage, and other available methods.

### Access to Campus Facilities

For security purposes, campus buildings are secured when classes and activities have finished each day. Facilities are kept secured during periods when college sanctioned functions are not being conducted. All persons required to be on campus when facilities are closed are requested to contact Campus Security in the Library/Community Resource Center, room LC 106, (ext. 4053) or 366-4053 or contact the appropriate coordinator at our Learning Centers.

College facilities are generally open from 7am-10:00pm, Monday through Thursday, and from 7am-7pm on weekends, unless otherwise specified by College officials. Persons requesting access to college facilities after hours will be required to show appropriate identification and state the reason for being on campus. On a need basis, and with proper authorization, students, faculty and staff may be provided with access codes to those facilities which are operated with electronic access controls.

Students desiring to be on campus after hours for a legitimate educational interest are to be in the company of a faculty or staff member, or provide written permission from an appropriate College official.

### Crime Prevention Education

Campus Security provides 24 hour-a-day security presence. As a regular part of their routine mobile and foot patrols, officers are alert for any deficiencies including broken door locks; inoperative lights; overgrown shrubs and trees; and broken sidewalks, steps and handrails and other conditions which might detract from the safety and security of the campus environment. Anyone encountering a condition affecting campus safety and security should report it promptly to the Campus Security Office or to Physical Plant Services. Each semester, the Campus Security office, working in conjunction with the Student Life and the Student Senate, sponsors a Campus Security Crime Prevention and Emergency Preparedness informational session. ### Basic Crime Prevention Steps

Effective crime prevention begins with personal involvement and responsibility. By taking a few moments to think before acting, we can all make ourselves less likely to become a victim or a statistic. The following is a list of DOs and DON'Ts to help you in protecting your personal property and yourself. DO lock your car at all times - when parked and when driving; DO use the lighted walkways going to and from the parking lots; DO report all crimes and/or suspicious activities to Campus Security promptly; DO mark your valuable possessions (books, calculators, recorders, etc.) i.e. with your driver's license number; DO call Campus Security (440-366-4053) if you desire an escort; DO treat all personal property as you do cash; DO ask a friend to walk with you to the parking lot; DON'T leave valuables in plain sight in your vehicle (iPods, GPS devices, books). DON'T leave books, handbags, book bags, wallets, etc. unattended in the library, cafeteria, restrooms or study areas; DON'T leave your locker unlocked; DON'T leave your purse or other valuables in an unlocked desk or file cabinet; DON'T walk through dark areas without an escort; DON'T leave cash or checks in your unlocked desk or file cabinet. Crime prevention is everyone's job. With some effort and forethought we can maintain a safe campus environment.

#### Substance Abuse Policy

Lorain County Community College does not condone the possession, use, manufacture or distribution of illegal substances or drug paraphernalia of any kind in any amount. Campus Community members in violation of this policy may be jeopardizing their own well-being as well as the well-being of the campus community.

Lorain County Community College is committed to providing a drug-free, safe environment for students, faculty, and staff. Toward this end, LCCC maintains "dry" campuses with the use of alcohol restricted. LCCC clearly states it is unlawful for individuals to manufacture, possess, use and/or distribute illicit drugs and alcohol on any of our campuses. Individuals who violate LCCC regulations and local, state and federal laws will be subject to disciplinary action, dismissal from LCCC and/or prosecution under applicable federal, state and/or local statutes.

### Sexual Misconduct & Dating Violence

LCCC is committed to a consistent effort in maintaining an environment free of sexual misconduct (including sexual harassment and sexual assault/rape) and all forms of sexual intimidation, exploitation and dating violence including stalking and domestic violence. In its goal to create an environment for all students, employees and visitors which is fair and free of coercion, the College has adopted a sexual harassment policy with accompanying procedures as the basis for community education and complaint resolution.

Sexual misconduct cannot and will not be tolerated at LCCC. Sexual misconduct is a form of discrimination in violation of College policy and Title VII of the Federal Civil Rights Act of 1964 (as amended), Title IX of the 1972 Educational Amendments and Section 4112 of the Ohio Revised Code.

Students, staff and visitors at Lorain County Community College have a right to an environment free of sexual misconduct, not only by persons in positions of power, but by any LCCC employee, student or visitor. Sexual misconduct constitutes a serious threat to the free interaction and exchange necessary for educational and personal development. Sexual misconduct is not only a clear violation of College policy; it is a form of discrimination and is illegal.

**Consent** is defined as voluntary, positive agreement between participants to engage in specific sexual activity.

**Sexual assault/rape** is defined as penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

Sexual harassment is defined as unwanted sexual attention such as staring, leering, ogling, sexual teasing, jokes, gestures, inappropriate touching, pressures for a date or sex, forced sexual relations or suggestions that sex can be exchanged for grades or a promotion. It can happen to both men and women, but women are more often the victims.

**Domestic Violence** is defined as a pattern of abusive behavior in any relationship that is used by one partner to gain or maintain power and control over another intimate partner. Domestic violence can be physical, sexual, emotional, economic, or psychological actions or threats of actions that influence another person. This includes any behaviors that intimidate, manipulate, humiliate, isolate, frighten, terrorize, coerce, threaten, blame, hurt, injure, or wound someone.

**Dating Violence** is defined as violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on consideration of the following factors: the length of the relationship; the type of relationship; and the frequency of interaction between the persons involved.

**Stalking** is defined as a pattern of repeated and unwanted attention, harassment, contact, or any other course of conduct directed at a specific person that would cause a reasonable person to feel fear for his/her safety or for the safety of those around him/her or suffer substantial emotional distress.

Sexual Harassment may occur when a person in a position of control or influence over a person's grades, academic career, or job uses authority and power to gain sexual advantages and threatens or punishes for refusal. Another form of sexual harassment is peer harassment (by other students), and

includes any of the above unwanted actions (except suggestions that can be exchanged for grade or promotions). Sexual harassment committed by students is a serious offense which could lead to dismissal from the college.

If an individual is the victim of sexual misconduct he/she is strongly encouraged to report such incidents promptly to the Title IX Coordinators, Keith Brown (kbrown@lorainccc.edu), located in the Library/Community Resource Center (room LC 106), ext. 7738 (440-366-7738), or Mona Atley (matley@lorainccc.edu), located in the College Center (room CC 209) ext. 4886 (440-366-4886). College officials will help individuals obtain counseling and file formal reports with the Title IX Coordinator.

If an individual is the victim of a sexual assault, formal charges alleging sexual assault occurring on any campus may be lodged with the Campus Security office which will make immediate contact with the local law enforcement agency in order to ensure a prompt and thorough investigation of the occurrence. If the victim is uncertain about reporting an instance of sexual misconduct, College officials strongly encourage victims to talk to someone about it. The College's crisis counselors are licensed mental health professionals and any conversation had with them is considered a privileged and confidential communication. They are not required to report any information about the incident to College officials. Similar to crisis counselors, campus advocates in Women's Link are able to talk with victims without triggering an investigation. These advocates are able to notify College officials without disclosing any personally identifiable information about the victim.

**Bystander Intervention Options** any campus community member that observes or is made aware of an incidence of dating violence, domestic violence, sexual assault, or stalking occurring on campus is strongly encouraged to report the matter immediately to the Campus Security Office at (440) 366-4053 or (440) 366-4444 (Emergency Line). If the situation necessitates and immediate police presence, please call 9-1-1. Some other safe intervention options can include:

Notifying a College official Avoiding use violence Being honest and direct when trying to diffuse the situation Recruiting the assistance of others around you Keeping yourself safe at all times

#### What to Do If You Are Sexually Assaulted: In the case of a sexual assault, it is extremely important that physical evidence be preserved.

Find a safe environment away from your attacker and call 9-1-1 immediately! If possible, ask a trusted friend to stay with you. And, remember, it's not your fault you were attacked.

Write down everything you can remember about the incident and assailant (physical description, location of the attack, etc.)

Preserve evidence of the attack. Though you may want to, do not bathe or brush your teeth. Do not wash or get rid of any of the clothing that you were wearing. If possible, take pictures of any visible bruises or injuries you may have.

If the incident occurred on any campus, immediately report the information to any College official, contact Campus Security at 366-4444, or dial 9-1-1. Information can also be shared with a campus advocate in Women's Link (440) 366-4035 or with a crisis counselor in Counseling (440) 366-4033. Any information shared with Women's Link or Counseling will be kept confidential unless the victim is willing to file a report with Campus Security or the local law enforcement authority having jurisdiction. College officials will assist the victim in notifying the local law enforcement agency and navigating the reporting process.

Seek medical attention. Even if you don't think you're injured, it's important to test for STDs and pregnancy. Ask the hospital to conduct a rape kit exam and, if you think that you have been drugged, collect a urine sample for analysis by a lab.

#### Institutional Protective Measures

College officials will assist survivors of sexual misconduct and dating violence with any class schedule adjustment(s) deemed necessary. In addition, College officials will also enforce On-Campus No Contact Orders prohibiting communication (in person, via telephone, text message, social media, etc.) amongst all parties. For survivors requiring additional measures, the Campus Security Office will provide parking accommodations in a designated parking lot, safety escorts to and from class and facilitate changes in working conditions as it relates to on-campus employment.

#### Primary Prevention and Awareness

Each semester, the Campus Security office, working in conjunction with Student Life, Student Senate, Genesis House and Lorain County Rape Crisis sponsors a Sexual Assault and Domestic Violence Awareness session that is designed to educate campus community members on responding to, preventing, recovering from, reporting and assisting survivors of sexual misconduct and dating violence. ### Disciplinary Process (Code of Conduct)

Complaints alleging infractions of any of the above prohibited behaviors by any campus community member or visitor are to be reported within fourteen (14) days after the charging party becomes aware of the alleged offense. These complaints will be investigated by the appropriate College official, including but not limited to, the Campus Security Office, the Coordinator for Code of Conduct and the College's Title IX Coordinators.

The accuser and accused are given timely notice of disciplinary meetings via telephone and electronic mail communication.

Disciplinary meetings shall be conducted within a reasonably prompt timeframe of when the allegation was reported to College officials.

The accuser and accused are entitled to the same opportunities to have others present during a campus disciplinary proceeding, including the advisor of their choice when the violation concerns an allegation of sexual misconduct.

Both the accuser and accused shall be informed in writing of the outcome of any campus disciplinary proceeding and available appeal procedures.

The accuser and the accused will be treated with dignity, courtesy and professionalism.

Incident reports regarding allegations of sexual misconduct will be submitted to the appropriate College official for investigation and resolution. Any campus community member found in violation of the College's Code of Conduct and Ohio law are subject to disciplinary sanctions up to and including suspensions, probation, dismissal, expulsions, termination and prosecution. Additional stipulations are the prerogative of the Provost/Vice President Academic and Learner Services, Dean of Enrollment, Career & Financial Services, Coordinator of Code of Conduct or Student Conduct Committee. The options that may be considered are as follows:

Warning/Reprimand Counseling Mandatory Psychological Evaluation and Treatment Fine/Monetary Restitution Restitution for damages Work/Service Restitution Attendance at workshops Educative/rehabilitative program referral; Behavior Contract; On Campus No Contact Order Involuntary Medical Withdrawal
