STATEMENT OF SELECTIVE SERVICE REGISTRATION COMPLIANCE



In August 1986, the Ohio General Assembly passed House Bill 845 which requires that all male students between the ages of 18-26 and who are Ohio residents must register with the Selective Service System and file a statement of their selective service status, or must be charged the tuition surcharge for non-Ohio residents for attendance at any state college or university.

The University of Toledo and its eligible male students are required to verify selective service status; please do so by checking the appropriate statement, completing the requested information, and signing below.

	I am on full-time active duty in the United States military. (This does include being in the Ohio National Guard or military reserves.)		
	I am a female.		
	I am an Ohio resident under the age of eighteen (18) years old and am therefore not currently required to register with the Selective Service. (I understand on my birthday I must register for Selective Service and provide the registration number to The University of Toledo.)		
	I am an Ohio resident over the age of twenty-six (26) years old and am therefore not required to register with the Selective Service System.		
	I am not a resident of the State of Ohio and am therefore not covered by Ohio law. Please note that if you receive reciprocity, you are required to register with Selective Service or you will be charged the out-of-state surcharge.		
	I am a non-immigrant lawfully in the United States and am not required to register.		
	I am a veteran.
