NABP Update from Dean Early

In September 2017, the National Association of Boards of Pharmacy (NABP) sent a memo providing initial information on a new, upgraded online system to be launched on April 2, 2018. Once implemented, the system will serve the schools and colleges of pharmacy as they utilize NABP programs and services. This new system will enable the Association to automate and streamline current processes for some of the programs used by the schools and colleges of pharmacy.

In addition to providing the schools and colleges of pharmacy with more services and automation, a new interface for individual pharmacists, technicians, and students registering for NABP programs is being launched on April 2. In preparation for the launch of the new customer interface, NABP has begun publishing information on its website regarding important deadlines and other changes that will affect those applying for licensure transfer and registering for examinations. This information will be disseminated through various NABP communications over the next few months. Key information affecting students includes:

• NABP systems will be shut down from March 20, 2018, at 5 PM Central Time (CT) until approximately April 2, 2018, at 12 PM CT when the new system is launched. During this time NABP testing applications, score reports, practice tests, licensure transfer applications, CPE Monitor, and publication ordering will not be available.

o Note to Deans: The system shutdown will provide for complete and accurate transfer of data from NABP's current system to the new system, as well as a smoother transition between program processes.

NAPLEX and MPJE

• When the new system is launched on April 2, 2018, the registration process for the North American Pharmacist Licensure Examination (NAPLEX) and the Multistate Pharmacy Jurisprudence Examination (MPJE) will change to a two-step process – (1) apply for examination and (2) register for examination.

• Candidates who cannot wait until after April 2, 2018 to take the NAPLEX or MPJE should be aware of the following dates:

o March 20, 2018 - Candidates must register for the exam, be granted eligibility, receive their ATT, and schedule and take the exam by 5 PM CT on this date. All jurisdiction changes and applicable score transfers also must be completed on this date. Candidates will not receive refunds for missed appointments or resitting fees.

o March 20, 2018, at 5 PM CT to April 2, 2018 at 12 PM CT - NAPLEX and MPJE registrations will be closed. No exams will be scheduled at Pearson VUE during this time.

• Candidates who register and/or receive an ATT before March 20, but are unable to take the exam, will have their registration rolled over into the new system. Those candidates may schedule their exam with Pearson VUE after April 2.

• Students graduating in 2018 should wait until after April 2 to register for their examinations so that they register through the new process.

• Candidates who choose Colorado, Maine, Oregon, or Utah as their primary state of eligibility are encouraged to wait until after April 2 to apply for the NAPLEX and/or MPJE when the process moves online and paper forms are eliminated.
