(A) Policy statement

Primary and immediate medical and mental health services will be provided to students enrolled at the University of Toledo College of Medicine and Life Sciences.

(B) Purpose of policy

To outline services provided by the University of Toledo for College of Medicine and Life Sciences students.

(C) Scope

This policy is for student health services for College of Medicine and Life Sciences students.

(D) Procedure

Health services for students are provided at several sites from which the students may choose. They include:

- The Student Health and Wellness Center on the Health Science Campus located in the garden level of the Ruppert Center, room 0013. suite 1650, Medical Pavilion (near Health Science Campus Pharmacy) 1125 Hospital Drive, Toledo, OH 43614 Students may receive preventive services such as routine physicals, well woman exams, Tuberculosis screening, immunizations, and other primary care services. Phone: (419) 383-37775000
- (2) Main Campus Medical Center student services. Services are the same as those provided in the Student Health and Wellness Center on the Health Science Campus. Phone: (419) 530-3451. Main Campus Medical Center is closed during summer sessions and breaks

Costs of services are covered by the student and the students' health insurance company. Student health clinics on both campuses are subsidized by general fees.

Student Health Insurance

College of Medicine and Life Sciences students who participate in patient care are required to have health insurance either through the available student health insurance or their own policy. These include the following programs: -Medical Degree, Physician Assistant Studies, Pathology Assistant, Medical Physics, Medical Science, Paramedic, Human Donation Science and Oral Biology.

Emergency Care for Students

In the event of a medical emergency, students should go to the nearest Emergency Department or call the telephone operator, on campus 77(419) 383 2600, off campus 911, and report the need for assistance.

Students will be billed for all visits to an Emergency Department. Students and/or insurance carriers are responsible for all charges incurred regardless of whether the student or a physician initiated the visit.

Lab/Radiology Test Services Benefits

The University will cover certain laboratory and radiological services for health professions students which include:

<u>Initial care for Occupational exposure testing - -If the hospital does not cover the cost, then the University of Toledo College of Medicine will cover the student's out-of-pocket costs up to a maximum of \$1000. (Medical insurance should be billed first. Any out-of-pocket cost, such as co-pays, will be paid by UTCOMLS up to \$1,000.00. Student must promptly present all medical bills to office of student affairs who will connect with COMLS finance for payment/reimbursement.) and immediate follow-up care
</u>

If a student would ever receive a bill for said services, they are to bring it immediately to the hospital billing department. The University does not pay for any pre-matriculation health requirements. For other healthcare costs, the student or their insurance is responsible.

Prescription Medication

Prescriptions for students and their families may be filled at the University of Toledo Outpatient Pharmacy Phone (419) 383-3898) or the Main Campus Medical Center Phone: (419) 530-3471. A three-month maximum supply of medication is permitted unless restricted by law or University policy.

Treatment of Medical Problems While Rotating at Affiliated Hospitals or AHEC Sites

Students participating in clerkships at University of Toledo affiliated hospitals or at AHEC sites should seek non-emergency medical care through university sites. Expenses incurred for treatment at other sites <u>becomesbecome</u> the responsibility of students and/or their insurance carriers, unless

the care is related to an occupational exposure. Some AHEC hospitals provide health services for medical students.

Dental Services

University of Toledo, Division of Dentistry will provide dental care services to enrolled students. 24 hour dental service is additionally available to spouses/dependents of medical/graduate school students. To arrange an appointment Monday through Friday, 9:00 a.m. - 5:00 p.m., call (419) 383-3805. In the case of an emergency at other times, students should call the Operator at (419) 383-4000 and contact the Dental Resident on duty. The Dental Service is located on the second floor of the outpatient clinic in the University of Toledo Medical Center.

Counseling Services

Counseling services are available at the Counseling Center located in the Main Campus Medical Center by appointment. Use of mental health services is strictly confidential and is not reported outside the Center.

Psychiatric/Mental Health Services

Mental Health services are provided at the Health Science and Main Campuses by counselors. In addition, student psychiatry services are provided on the Health Science Campus by board certified psychiatrists for mental health and medication management needs.
