<b>Start:</b>	<b>Estimated End:</b>	<b>Sanitation Guidelines</b>  <input type="checkbox"/> <b>Biohazard Cage Cleaning inside the BSC:</b> Empty hazardous bedding into an autoclavable hazard bag in the BSC. The empty hazardous enclosures is bagged and with Hazardous sticker. Spray outside of bag with disinfectant before removing from BSC/room and transport to the autoclave and autoclave.  <input type="checkbox"/> <b>Chemical hazard Cage Cleaning inside the BSC:</b> Empty hazardous bedding into an autoclavable hazard bag in the BSC. Seal the bag and place in hazardous bin. The empty hazardous enclosures are sprayed with disinfectant before covering and transporting to cage wash.  • <b>Equipment, surfaces and supplies:</b> Spray with disinfectant prior to removal from room to go to cage wash. • <b>Water Disposal:</b> Pour into bedding to be absorbed. • <b>Euthanasia &amp; Carcass Disposal:</b> Euthanized in room, placed in hazard bag, label with hazardous sticker. Seal closed and spray with disinfectant to remove from room. Carcasses are place in hazard box on the left side of the walk in cooler in Rm 91. • <b>Room Cleaning:</b> Clean room as outlined in DLAR SOP with appropriate disinfectants.
