This agreement, made and entered into this ___ day of _____, is by and between THE UNIVERSITY OF TOLEDO STUDENT UNION, Toledo, Ohio (hereafter referred to as the "University" and _____ (hereafter referred to as the "Vendor").

In consideration of mutual benefits to be received, the parties mutually agree with each of the following:

- 1. The University will provide Table(s) to the Vendor in the Student Union Concourse or Scott Park Concourse (hereafter referred to as the "Premise") on the following dates. Sales will occur during the hours of 9:00am to 5:00 pm.

- 2. The "User" shall pay in advance to "The University Of Toledo" by check, cash, Master Card or Visa as acceptance of this agreement, the sum of \$ _____ by _____.
3. The Vendor warrants that it is in compliance with all applicable trademarks and copyright laws covering the merchandise displayed and offered for sale.
4. The Vendor is responsible for, and shall obtain all permits and licenses, which are required by University Policy, State, City and Federal Law.
5. The Vendor agrees to sell only the following merchandise: _____.
6. All furnishings, equipment, merchandise and other personal property at the time located upon the Premise shall be kept and maintained by the Vendor as its sole risk, and Vendor shall hold harmless the University against all loss, cost and the expense by reason of any damages to or destruction of any such furnishings, equipment, and/or merchandise on the Premise.
7. Vendor shall indemnify and hold harmless the University, its Board of Trustees, Officers, Employees, Agents, and students from and against any and all claims, damages or liability of any nature or character arising out of or by reason of the execution or performance of the rights, duties and obligations arising out of or incidental to the display of or sale of any merchandise on the Premise.
8. Upon the expiration of this Agreement, or its termination in any way, the Vendor shall surrender and deliver up the Premise provided to the Vendor hereunder broom clean and in as good order and condition as the same shall have been at the commencement of this Agreement.
9. The Vendor agrees to pay any and all taxes that may be due on the sale of any merchandise. It is expressly agreed that the University is not responsible for the payment of any taxes, and the Vendor shall indemnify the University for any such taxes assessed against the University by reason of the Vendor's sale of such merchandise.
10. The University may terminate this agreement at any time by giving written notice to the Vendor. Upon receipt of termination notice, the Vendor shall immediately cease all operations and shall immediately discharge all outstanding obligations (fiscal and/or otherwise), which are incurred prior to any such notice.
11. No extension cords shall be strung across doorways or corridors. All audio/visual and extension cords, which are requested, will be charged at current university rental rates.
12. Only provided tables shall be used for the display of goods and services. A \$ _____ (tax included) surcharge will be assessed to all individuals who use racks or display items in addition to provided table space.
