Student Eligibility:

Only law students are eligible to participate in the Patent Law Interview Program. It is not required that students be patent bar eligible to register for the program; however, many employers require patent bar eligibility as a qualification for bidding on interviews, and most employers strongly prefer patent bar eligible students. - JD students graduating in December 2019/January 2020 (rising 2Ls)

- Students in Intellectual Property LLM programs with anticipated graduation dates in 2019 and 2020

Students who will graduate before the program is held in July 2018 and students who plan to graduate after May/June 2020 are not eligible for the 2018 Patent Law Interview Program.
