## Professional Development Program

### ***Purpose of the Professional Development Program***

The College of Law designed the Professional Development Program to help you build your professional identity and network throughout your legal education career. Each year you will be required to complete certain mandatory activities. Additionally, throughout law school you will be required to attend networking and skills events, complete pro bono awareness tasks, and participate in career exploration activities. Inside your designated reporting cycle folder will include the activity categories and numbers of activities required for each reporting cycle. The Professional Development Program is a floor, not a ceiling; OPD encourages you participate in as many of the activities as your schedule allows.

### ***How it works***

Reporting cycles are based on the number of credits you have earned at the end of the semester. For example, you must have completed all activities listed in the “0 – 30 Credits Reporting Cycle” between the time you start law school and the semester in which you earned your 30th credit. For the “31 – 60 Credit Reporting Cycle” complete all activities listed between the semester you earned your 31st credit and your 60th credit. And for the “61+ Credits Reporting Cycle” between the semester you earned your 61st credit and the semester that you graduate. For some students, cycles may overlap. You may begin working on the next reporting cycle once you’ve completed the last one if your semester bridges the reporting cycle. I.e. you start a semester with 27 credits and end it with 42 credits, you can finish the 0 – 30 reporting cycle, then start working on the 31 – 60

reporting cycle activities.

**Mandatory Activities:** Mandatory activities include class level specific programming required by the Office of Professional Development. These meetings will be announced in the OPD newsletter, emails sent by OPD staff, and/or on TLCN. Activities may be web-based or in-person if safety standards allow. Additionally, many of these activities require pre- or post-work such as updating application documents or certify completion of an on-demand video.

**Networking and Skills Events:** These events are often sponsored or co-sponsored by the Office of Professional Development, Alumni Affairs, or a Bar Association. They are designed to help you build your networking skills. Events can take place virtually or in person (when allowed).

**Professional Exploration:** Professional exploration tasks will aid in determining your professional identity and long-term career path. Exploring the profession can be done on a large scale, by attending an in-person or virtual legal conference, for example. Or on a smaller scale, such as a one-on-one informational interview. It is your responsibility to find outside events related to your areas of interest, set up informational interviews, or arrange observation of a legal proceeding. OPD is happy to help in your search.

**Pro Bono Awareness Tasks:** Ohio, along with many other states, encourages pro bono work as part of a lawyer's professional duties to the public and justice system. Therefore, these tasks are not only a resume builder, but they will help kick-start a commitment to your professional duty as lawyers. The Ohio Supreme court states in the Preamble to the Ohio Rules of Professional Conduct: "...[A]ll lawyers should devote professional time and resources and use civic influence to ensure equal access to our system of justice for those who because of economic or social barrier cannot afford or secure legal counsel." ***It is your responsibility to find pro bono clinics and volunteer to help, or find an attorney to work with or shadow. OPD is happy to help in your search but will not be responsible for placement in these opportunities. OPD may advertise pro bono projects and other opportunities via the newsletter or emails.*** Students in the 0 – 30 credit reporting cycle are not required to complete a Pro Bono Awareness Task. Students in the 31 – 60, or 61+ reporting cycle may report participation in one of the listed legal clinics.

The Toledo Bar Association offers a variety of pro bono opportunities. The following clinics are currently available for law students:

## Clinics

1. **Juvenile Clinic**- you will observe attorneys assisting individuals who are filling out court documents in Juvenile Court to file pro se. If you are comfortable after observing, you may have the opportunity to assist with educational information only. This clinic is held the first and third Thursday of each month at the Lucas Co Juvenile Court from 11:00-1:00. You will need to arrive 15 minutes early so we can go over the forms with you.
2. **Pro Se Divorce Clinic**- this is an opportunity for you to observe a volunteer attorney assisting folks who are filing for divorce pro se. This clinic is normally held twice a month on Friday afternoons from 1:30-3:30 at the Law Library (905 Jackson St.). Again, you will need to arrive 15 minutes early so we can go over the forms with you.
3. **VA Brief Advice Clinic**- law students will be paired with an attorney to observe providing brief advice on a variety of legal topics. This clinic is held on the first Thursday of the month at the Toledo VA (1200 S. Detroit) from 8:30-11:00.
4. **Justice Bus Brief Advice Clinics**: law students will be paired with an attorney to observe providing brief advice. These clinics will be on specific topics, and will be held at Toledo Lucas County Public Library locations.

## **Job Fairs**

Loyola University Chicago School of Law is hosting the 2022 Patent Law Interview Program on **Thursday and Friday, July 21-22**. This nationwide interview program targets patent law employers and rising 2L and 3L students. The 2022 Patent Law Interview Program will be held IN PERSON\* at the Embassy Suites Chicago – Downtown/Lakefront. **In person interviews will still take place on Thursday and Friday, July 21-22, and virtual interviews will now take place on Monday, July 25.**

Last year roughly 150 employers, 190 law schools, and 1,300 law students from across the country participated in the program. The program is entirely pre-selected, which means that students submit application materials to apply to interviews with the employers they are interested in, and employers then review their materials and select the students they wish to interview at the program. Last year, approximately half of the participating students were selected for interviews.

Students with undergraduate or graduate degrees in engineering or a technical science should consider registering for the program. You do not need to be patent bar eligible to register, although the vast majority of employers participating in the program are seeking patent bar eligible students.

## Islamic Scholarship Fund Congressional Policy Fellowship

The ISF Congressional Policy Fellowship is a highly selective, nonpartisan program devoted to promoting and encouraging diversity and inclusion on Capitol Hill. Through a 9 month fellowship, fellows will gain real-world experience working on legislative and public policy issues. Fellows of this program will not only have access to Congressional members and staff within the halls of power, they will have the opportunity to work as a full-time staffer for 9 months conducting tasks such as policy research, meeting with special interest groups, drafting bills/speeches, and preparing the member for hearings, etc. Upon arrival in D.C., participants will attend a one-day preparatory orientation. Typically fellows will work 40-45 hours a week and will be expected to participate in all ISF-sponsored activities including professional development events. As participants will be representing ISF, they should work to meet ISF's work performance and ethics.

## 2022 Affordable Housing & Community Development Law Student Legal Writing Competition

### Official Rules

#### Description:

This writing competition ("Competition") is sponsored by the **Forum on Affordable Housing and Community Development Law** ("Forum") of the American Bar Association ("ABA"), 321 N. Clark Street, Chicago, IL 60654 (the "Sponsor").

The goal of the competition is to encourage law students to become involved in the Forum. It is also intended to attract students to the affordable housing, community development or pro bono practice fields, and to encourage scholarship in these areas. Each entrant must follow the rules of the competition detailed herein.

#### Eligibility:

Open to all law students who are at the time of entry, (a) enrolled in a law school at the time of entry, ABA Accredited, (b) member of the ABA and the Forum, (c) 21 years old, and (d) U.S. citizens or legal permanent residents. Employees of the ABA, its respective affiliates, and immediate family or household members of such employees are not eligible for the Competition.

#### Topic:

Entries should address any legal issue regarding affordable housing, fair housing and/or community development law.

## USLAW NETWORK Law School Diversity Scholarship Program

Costs associated with law school may derail accomplished and highly motivated students applying to law school or completing their Juris Doctor. Recent studies show that one out of ten minority law students had to abandon a lifetime dream of becoming a lawyer and the field lost 10% of its potential diverse talent pool.

The USLAW NETWORK Law School Diversity Scholarship Program was created as part of the organization's commitment to helping diverse law students who are in need of financial assistance achieve their academic and professional dreams.

In order to be considered for the scholarship, the student must be a member of an ethnic, racial, or other minority, or demonstrate a commitment to issues of diversity within their community.

The USLAW NETWORK Law School Diversity Scholarship Program will award \$5,000 to 10 students selected by our scholarship selection committee. Applications may be submitted starting February 1, 2022 with a deadline for applications by April 1, 2022.

### **Law School Diversity Scholarship Eligibility Requirements**

Applicants must meet the following criteria:

- Recipient is a member of an ethnic or racial minority or any individual who demonstrates a defined commitment to issues of diversity within their academic community.
- Recipient is a U.S. citizen or permanent resident currently attending an accredited law school within the United States.
- Academic achievement as reflected by a minimum 3.0 GPA at an accredited law school currently enrolled or a cumulative 3.0 GPA for the recipient's undergraduate years.
