Biographical Sketch

Dr. Marvin L. Michael Kay was born in New York on Sept. 13, 1927. He served in the U.S. Marines from August 1945 to August 1946. After his military service, Dr. Kay attended Marysville College where he received his B.A. in 1950 and met his future wife Elizabeth (Betty) Ruth Bryan in 1952. They married in 1953 and together they had five children. While raising his family, Kay continued his education, and received a Ph.D. in American History from the University of Minnesota in 1962.

Dr. Kay was employed at San Jose State College as an Assistant Professor from 1959 to 1962. When he received his Ph.D., he became a lecturer in Australia at the University of Queensland from 1962 to 1966. In 1966, Kay returned to the U.S. and taught at Alfred University (NY) until 1968, and at West Chester State College (PA) from 1968 to 1970 as an Associate Professor before arriving at The University of Toledo in 1971. He remained an Associate Professor until 1979 when he earned the rank of Professor in History.

During his career, Dr. Kay published many scholarly works in different journals, including *The William and Mary Quarterly*, and in 1995 published a book with fellow UT history professor Lorin Lee Cary, *Slavery in North Carolina*, 1748-1775, through the University of North Carolina Press. He was active in the AFT (American Federation of Teachers), the AAUP (American Association of University Professors), the AHA (American Historical Association), Columbia Seminar for Early Americans, and the OAH (Organization of American Historians). Dr. Kay also attended many conventions, conferences, and symposiums during his career. He retired on June 12, 1992, although his papers indicate that he still had affiliations here at UT until as late as 1998.

Dr. Marvin L. Michael Kay passed away May 31, 2014 while a resident at the Kendal at Oberlin retirement home.

Scope and Content Note

The papers of Dr. M.L. Michael Kay document his professional career as a historian, from his early years at San Jose State College to his more-than twenty-five years at the University of Toledo. Included are many published works researched and written by Dr. Kay, including extensive files on the collaborative research of Dr. Kay and Dr. Lorin Cary, also of the UT Department of History. Correspondence with friends, colleagues, publishers, and research institutions follow. A large part of the collection consists of exams, lecture notes, and readings for at least four of the courses Dr. Kay taught at UT. Materials from the Faculty Senate and the teachers unions in which Dr. Kay was involved comprise the next series, followed by legal documentation of a case filed while he was a professor at West Chester State College. Miscellaneous materials that do not pertain largely to any other category include mailing lists and personal documents. Personnel records illustrate Dr. Kay's efforts at obtaining promotion, and include sabbatical leave requests, certificates of appointment, research grant requests, and salary recommendations, as well as his curriculum vitae. Finally, there are a few folders of published material not authored by Dr. Kay and include newspaper clippings, magazine articles, off prints of essays, and newsletters.

Arranged alphabetically within subseries

Series contains articles, essays, and books written by Dr. Kay. It is broken down into three subseries: Kay only, Kay and Cary, and Kay and Price.

S2 Correspondence

1970s-2000, .25 linear foot

Arranged chronologically within subseries

Series contains several pieces of correspondence, including memos, written by and to Dr. Kay, and is divided by incoming, outgoing, and UT-related.

S3 Course Materials

1956-1999, 2 linear feet

Arranged alphabetically within subseries

Series contains assigned readings, lecture notes, and exams of four courses taught by Dr. Kay at UT, as well as off-campus lectures, graduate exams, and copies of papers he wrote as a student.

S4 Faculty Organizations

1971-1998, 1 linear foot

Arranged alphabetically and then chronologically within subseries

Series contains documents relating to Dr. Kay's involvement in the Faculty Senate, the American Association of University Professors (AAUP), the American Federation of Teachers (AFT), the Department of History, and the Student and Faculty Commission on Peace.

S5 Legal Documents

1968-1977, 3 folders

Arranged chronologically

Series pertains largely to a case of wrongful termination of Dr. Kay while an Association Professor at West Chester State College.

S6 Miscellaneous

1975-2000, 4 folders

Arranged alphabetically by type of material

Series contains items that don't fit in the other series and includes mailing lists and personal documents.

S7 Personnel Documents

1968-1995, .25 linear foot

Arranged alphabetically

Series contains records relating to appointments, salary, and promotion.

S8 Published Material

1964-1995, .25 linear foot

Arranged chronologically

Series contains printed materials not written or published by Dr. Kay and include newspaper clippings, newsletters, off-prints of essays, and magazines.
