Welcome and Check-In: Holly Monsos opened the meeting at 2:00pm.

#### **Special Guests:**

First Destination Survey-Shelly Drouillard, Director of Career Services and Deidre Jones, Neff COBI-Director of the Edward H. Schmidt School of Professional Sales shared the newly launched First Destination Survey dashboard.

*Program Review*-Heather Huntley, Director of University Accreditation and Program Review, and Scott Molitor, Chair-UAPRC provided an overview of the current academic program review process, and summarized the most recent annual report.

<u>Office Report:</u> Alana Malik has been working with Cathy Zimmer, Provost Office, Brian Kuhn, Registrar's Office, and Heather Huntley from the Provost Office to align the programs listed in the assessment tracking tool with the programs listed in the university catalog, and those that participate in program review. Approximately 60% of the programs are already aligned. For those programs that do not match, it's important for us to understand and be able to articulate the rationale behind the misalignment between the three lists.

The co-curriculur service unit list is finalized. Attached is a copy of the list.

Alana Malik provided a spring update to the Board of Trustees. The list as of spring 2021 of academic programs that have not aligned their learning outcomes to the institutional learning outcomes will be used to measure the strategic plan related to student learning. Any programs that were added to the CIM system after the spring will continue to be added to the assessment tracking tool, but will not be included in the calculation of meeting the 100% compliance with program/institutional ISLO target by 2022. Otherwise, we will never reach 100% compliance with the continued addition of new programs. The 22 programs listed as not aligned need to submit new program plans by the deadline of September 15<sup>th</sup>.

New guides and rubrics for the plan and report templates are now available on the website.

The Core curriculum committee identified a gap in our institutional learning outcomes. The civic and global understanding outcome does not directly address issues of diversity, equity and inclusion. They recommended that the UAC revise the ISLOs in the fall. This will also tie with the Ohio State Transfer 36 recertification, and their newly published DEI outcome statements. Alana will reach out to Willie McKether to see if his office is willing to partner on leading this discussion next fall.

Alana is also working to update the website to include more information related to the institutional student learning outcomes and to highlight some of the co-curricular learning such as student employment, and the results from the first destination survey. Academic Support Services also probably has relevant data to share as well.

The committee is not planning to meet in June or July. Please look for an email with committee updates, and we will also send out the HLC assurance argument draft when it becomes available to review. We especially appreciate feedback on section 4B.
