**The College Credit Plus Program** (CCP) is a state-funded program that allows high school students to earn college and high school credit simultaneously at no cost to students or families.

Created to provide Ohio high school students the opportunity to pursue higher education and reduce the cost of doing so, the Ohio Department of Higher Education, the Ohio Department of Education, and the Ohio legislature collaborated with universities and community colleges throughout the state to combine several existing programs.

CCP combines the previous Post-Secondary Enrollment Option (PSEO), Dual Enrollment programs, and Tech Prep.




