## VI. Dean's Report: Dean Charlene Gilbert

Reported on Day of Giving, already raised \$10,700+, number of donors increasing as well, about 75% to goal, grateful for funds being given; reported Midterm grading closes October 18; discussed new university teaching resource on peer observation, visit website and click on guide; reported recruitment for CAL is going well, currently up 14.2% in applications; reported

university enrollment is down which could impact budgets, administration stated not expecting budget cuts; reported Undergraduate Research Exhibition scheduled for December 2, proposals accepted until November 8; discussed the Good Idea Campaign, will be open until October 18; discussed general research funding and encouraged folks to pursue/look outward for opportunities (research, grants and scholarships)

## VII. Old Business

a) CAL Mission Statement drafts previously sent out via email, suggestion was made to vote anonymously via cards in order to narrow down selections to two, question raised about whether final line on draft page was last option, yes, last line on page should be choice #6, motion to narrow down/proceed, second. Vote - Approve 30, Not Approved 0, Abstain 0.

Vote 1 taken, top two choices were #1 and #5, extra cards were found sitting on table so another vote had to be taken, motion to proceed/vote again, second. Vote - Approve 30, Not Approved 0, Abstain 0.

Vote 2 taken, top choices were #1 and a tie between #4 and #5, motion to proceed/vote again for final choice, second. Vote - Approve 30, Not Approved 0, Abstain 0.

Vote 3 taken, resulted in another tie between #1 and #5. Discussed moving final vote with full council present, motion to table for full council, second. Vote - Approve 30, Not Approved 0, Abstain 0.
