Committee **recommends** a limited trial of the Touch CMC I Prosthesis. Tyler will work with the clinical champion(s) to determine an acceptable trial duration. After trial phase the clinical champion(s) will provide a debrief to the committee concerning its use in procedures and recommendation for permanent adoption.

- Request for Review
 - Procedural Item: Pounce Thrombectomy System
 - Clinical Champion(s): Dr. Cuddy & Dr. Nazzal
 - Vendor: Surmodics (New Vendor)
 - Used for specific thrombectomy cases involving extirpations requiring a mechanical approach
 - Used in place of: Penumbra or AngioJet for certain cases.

Committee **recommends** permanent adoption of the Pounce System due to a gap in care for patients that require a mechanical arterial thrombectomy system where the Penumbra suction and AngioJet are ill suited. Tyler will work with Dr. Cuddy, purchasing, and the vendor to bring the system to UTMC.
