- k. An ability to use the techniques, skills, and modern engineering tools necessary for engineering practice

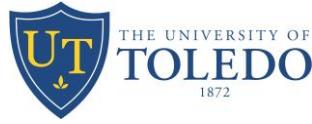
Student learning outcomes will be assessed through an employer evaluation completed at the end of the semester. This evaluation must be submitted in order for the student to receive passing credit.
