When you arrive on campus, you are required to bring <u>original</u> documentation of your citizenship status to Rocket Solution Central for authentication. Acceptable documentation is listed below. Your financial aid will not disburse to your student account until your <u>original</u> documentation has been received and reviewed.

- ► If you are a U.S. citizen, present one of the following <u>original</u> documents to Rocket Solution Central in person:
 - U.S. Birth Certificate if born in U.S., not foreign-born
 - Certificate of Naturalization
 - Consular Report of Birth Abroad (Form FS-240)
 - Certification of Report of Birth (DS-1350)
 - U.S. Passport
 - Certificate of Citizenship
 - Certification of birth issued by a foreign service post (Form FS-545)
- ► If you are an eligible non-citizen, present one of the following <u>original</u> documents to Rocket Solution Central in person:
 - Permanent Resident Card (I-551). If expired, you must also present Form I-797 Notice of Action that notes the extension period.
 - Resident Alien Card (I-551)
 - Arrival/Departure Record (I-94 or I-94A) stamped with "Processed for I-551" with expiration
 - Arrival/Departure Record (I-94) stamped with "Temporary Form I-551" with appropriate information filled in
 - Arrival/Departure Record (I-94) with designation of Refugee, Asylum Granted, Parolee, or Cuban-Haitian Entrant
 - Foreign-issued passport with DHS/CBP admission stamp with SQ1, SQ2, or SQ3 class of admission or CQ1, CQ2, or CQ3 class of admission (for Special Immigrant Conditional Permanent Residents and Non-SI Parolees)
