

- If your parents are separated or divorced, answer about the parent who provides you with the most financial support, even if you do not live with that parent. If that parent is remarried, both that parent and the stepparent should provide information on the FAFSA.
- If your parent is widowed and remarried, both your parent and your stepparent should provide information on the FAFSA.
