The Office of Student Financial Aid is required to resolve conflicting information reported on the Free Application for Federal Student Aid (FAFSA). Processing of your federal aid application cannot continue due to conflicting information; therefore, you must complete and return this worksheet.

**IMPORTANT: Read Part A to determine the parent(s) whose information should be reported in Parts B and C.**

**Part A - Which parent should include information on your FAFSA?**

For federal student aid purposes, "parent" refers to biological or adoptive parent and stepparent married to biological or adoptive parent.

- If your parent was never married and does not live with your other legal parent, or if your parent is widowed and not remarried, your parent should provide only their own information on the FAFSA.
- If your parents are separated or divorced, answer about the parent who provided you with the most financial support over the 12 months prior to when you submitted your 2025-26 FAFSA, even if you do not live with that parent. If both parents provided an exact equal amount of financial support or if neither supports you financially, the parent with the greater income and assets should complete FAFSA and answer questions in Part B. If that parent is remarried, both that parent and the stepparent should provide information on the FAFSA.
- If your parent is widowed and remarried, both your parent and the stepparent should provide information on the FAFSA.

Same-sex couples must report their marital status as married if they were legally married in a state or other jurisdiction (foreign country) that permits same-sex marriage.

Never are grandparents, foster parents, legal guardians, older siblings, aunts, or uncles considered parents for federal student aid purposes, unless they have legally adopted you.

A stepparent who is separated or divorced from your parent is not considered a parent for federal student aid purposes.
