

2026-27 IRS FEDERAL TAX INFORMATION (FTI), TAX RETURN, TAX RETURN TRANSCRIPT, AND VERIFICATION OF NON-FILING INSTRUCTIONS

If a student (or spouse or parent, if applicable) has consented to the disclosure of information and affirmatively approved the receipt and use of Federal Tax Information (FTI) on the student's 2026-27 FAFSA, but 2024 Federal Tax Information for that individual was not available or could not be used for FAFSA, provide the Office of Student Financial Aid with that individual's complete, **signed copy of the 2024 federal tax return**. If unable to provide a copy of the 2024 federal tax return, submit instead a copy of that individual's **2024 IRS Tax Return Transcript**.

Student name and Rocket Number must be on all documentation submitted to Office of Student Financial Aid or Rocket Solution Central.

2024 FEDERAL TAX RETURN TRANSCRIPT

If you cannot provide a complete, signed copy of a required 2024 federal tax return (IRS Form 1040) as requested by the Office of Student Financial Aid, please provide a copy of that individual's 2024 Tax Return Transcript received from IRS.gov.

Go to: irs.gov/transcript.

If the individual requesting a transcript has a credit card (not debit), auto loan, mortgage, home equity loan, or home equity line of credit **AND** a mobile phone billed to that individual's name:

- 1. Select "Get Transcript Online."
- 2. Register/Create account.
- 3. Select reason for transcript request and tax year requested (2024). Make sure to request the "Tax Return Transcript" and NOT the "Account Transcript."

If the individual requesting a transcript is unable to use "Get Transcript Online," he or she will need to use one of the following methods:

Get Transcript by MAIL

- 1. Go to: irs.gov/transcript.
- 2. Select "Get Transcript by Mail."
- 3. For Married Filing Jointly Tax Return Transcripts, the taxpayer (not the spouse on the return) must make the request.
- 4. Enter personal data and the address used on the tax return submitted to the IRS.
- 5. Select "Return Transcript" and tax year "2024."

Get Transcript by PHONE

- 1. Call the IRS at 800.908.9946 to order a 2024 Tax Return Transcript.
- 2. For Married Filing Jointly Tax Return Transcripts, the taxpayer (not the spouse on the return) must make the request.

IMPORTANT:

When you receive the Tax Return Transcript, <u>you must write the student's name and Rocket Number on the document</u> prior to submitting it to the Office of Student Financial Aid.

2024 VERIFICATION OF NON-FILING LETTER

Go to: irs.gov/transcript.

If the individual requesting a Non-Filing Letter has a credit card (not debit), auto loan, mortgage, home equity loan, or home equity line of credit **AND** a mobile phone billed to that individual's name:

- 1. Select "Get Transcript Online."
- Register/Create account.
- 3. Select reason for transcript request and tax year requested (2024). Make sure to request the "IRS Verification of Non-Filing."

If the individual requesting a Non-Filing Letter is unable to use "Get Transcript Online" he or she will need to complete the **IRS Form 4506-T** "Request for Transcript of Tax Return":

Go to: irs.gov/forms-pubs.

- 1. Select "Form 4506-T."
- 2. Complete lines 1a-1b.
- 3. Complete lines 3-4.
- 4. Check the box for line 7 "Verification of Nonfiling".
- 5. Enter "12/31/2024" for line 9.
- 6. Check the box (above the signature line) that reads: Signatory attests that he/she has read the attestation clause and upon so reading declares that he/she has the authority to sign the Form 4506-T.
- 7. Complete the "Sign Here" section with your signature, the date, and your phone number.
- 8. Mail the completed/signed Form 4506-T to the applicable address provided in the "Chart for all other transcripts" on page 2 of the Form 4506-T. Do NOT send or upload Form 4506-T to the Office of Student Financial Aid.

IMPORTANT:

When you receive the Verification of Non-Filing Letter from IRS, <u>you must write the student's name and Rocket Number on the document</u> prior to submitting it to the Office of Student Financial Aid.

WHAT IF YOU ARE UNABLE TO OBTAIN THE VERIFICATION OF NON-FILING LETTER?

If an individual is unable to get the Verification of Non-Filing Letter using either of the methods above, he or she may submit a signed and dated statement affirming that he or she attempted to obtain the 2024 Verification of Non-Filing Letter but was unable to obtain it.
