Scholarship Terms and Conditions for UT Achievement Award and Phi Theta Kappa Award

- 1. The awarded scholarship begins in the semester the student is accepted (unless that is summer semester; then the student will need to complete a summer aid application, otherwise, the scholarship will begin in the fall semester). Students must be enrolled and attend on a full-time basis each semester the award is used (although see below for renewal requirements). The award must be used for consecutive semesters.
- 2. The maximum length of this scholarship is determined by the Semesters of Scholarship Eligibility Grid after all official transcripts have been received and does not exceed five consecutive calendar years or the completion of a baccalaureate degree, whichever comes first.

- 3. One-half of the yearly award will be applied to the student's bill each fall and spring semester to help pay for full-time tuition and general fee (up to 18 credit hours per semester). This a ward is subject to the availability of funds. Additional a wards of other grants, scholarships, or benefits restricted to tuition and general fee may reduce the amount of this scholarship or may a llow this scholarship to be applied to University room and board charges. This scholarship is considered non-refundable except for institutionally approved expenses including but not limited to study a broad.
- 4. This scholarship will be used toward the payment of costs incurred at The University of Toledo and is not transferable to any other college or university.
- 5. This scholarship could be adjusted or rescinded if the student is a recipient of an athletic scholarship.
- 6. Please note the amount and continuation of your scholarship is subject to change. If any such changes are necessary, you will be notified in writing via your UToledo email address.
- 7. Academic year requirements for scholarship recipients enrolled in degree programs that require a mandatory co-op or internship experience will be a djusted as needed. Students will need to contact the Scholarship Office at *Financialaidscholarship@utoledo.edu*.

8. Renewal Process:

- The a cademic year begins with the summer semester and ends with the spring semester. Annual review for renewal will be at the end of each spring term, unless placed on a term by term review.
- Scholarships are automatically renewed if the student maintains a 2.75 cumulative GPA and earns 27 UT credit hours within two semesters of the academic year.
- Students on an approved co-op/internship during two semesters of the academic year are required to maintain a 2.75 cumulative GPA and earn 12 UT credit hours during their one semester of coursework.
- Students who do not meet the automatic renewal criteria outlined above but who earn at least a 2.3 cumulative GPA and 22 UT credit hours within two semesters of the academic year will receive a reduction in their scholarship. Scholarships will not be renewed for students who are unable to earn at least a 2.3 cumulative GPA or 22 UT credit hours within two semesters of the academic year.
- Students who have their scholarship reduced will have the opportunity to submit a scholarship reinstatement request after spring grades post each year to earn scholarship funds back if they are able to earn 27 UT credit hours within two semesters of the a cademic year and a 2.75 academic year GPA.
- Students with extenuating documentable circumstances can appeal by submitting an email to *Financialaidscholarship@utoledo.edu*.
