CATALOG/COURSE DESCRIPTION

Students will continue to develop the ability to critque research and will be introduced to developing research methods to address a clinically question related to sports medicine.

COURSE STATEMENT

This course will continue to provide the students an appreciation for the importance and need for quality research in the athletic training profession. Building upon the development of a research question and literature review covered in KINE 6910, students will be exposed to the concepts of study design, conducting sports medicine research, statistical considerations, and regulations and focus of the institutional review board related to research. Students will develop knowledge into the components of a research article, such as introduction and methods sections and explore how to develop these components relative to their thesis projects. Students will complete documents related to the submission of their research project through the university institutional review board.

Objective 4: Students will develop a research presentation of a unique athletic training/sports medicine research question and development of an appropriate study design to answer their question.

COURSE EXPECTATIONS

Professional Behavior:

During this course student will be required to submit assignments related to the development an introduction and method section of a manuscript relative to their individual research questions. Students will also be required to develop documents required to the submission of the University of Toledo Institutional Review Board to conduct their designed project. Finally, students will be required to present a thesis proposal that demonstrates their ability to develop an athletic training/sports medicine research question, appropriate study design and methods to conduct the proposed project.
