## Research and Sponsored Programs Update

#### **Information and Discussion Items**

<u>Undergraduate Research/Graduate Program Collaborations and Competitive Awards Opportunities—Dr. Jonathan Bossenbroek, Director of the Office of Undergraduate Research and Competitive Awards</u>
Dr. Bossenbroek brought forward discussion of collaboration across disciplines and getting undergraduates involved with graduate student research. In order to collaborate, you need to know what research is going on across campus and meet faculty in other disciplines. President Gaber has been talking about competitive awards. Dr. Bossenbroek, who is housed in in the Honors College has worked with Dean Appel to hire a full-time program coordinator and also a director of competitive awards. Most faculty are familiar with Fulbright Scholarships, which spans students (including graduate students), faculty and administrators. All run through this office. There are a lot of awards for students and faculty. There are a lot of fellowships as well. Our goal is to identify them and make students aware and help to support competitive packages to obtain awards, which can be substantial.

We have high caliber amazing students who can compete for awards and we want to help prepare them to apply. Announcements will be forthcoming including one a Fulbright workshop in a couple of weeks.

Dr. Connie Schall said that she and Dr. Bossenbroek will meet to discuss avoiding any confusion with the proposal process. We want to make sure websites are correct so proper guidance is given. Extramural research goes through the Office of Research and the budget process. Dr. Schall pointed out that the fellowships Dr. Bossenbroek referenced generally go to the recipient and faculty. He added that there is a process of faculty receiving award availability and notification.

Summer undergraduate research is one of the things we are pushing in getting more engaged in. For some summer is not good time to pursue research and for others it may be suitable. We hope to have ten awards each semester.

# <u>University Academic Program Review Committee Report 2017-2018—Ms. Heather Johnson Huntley,</u> Director of University Accreditation and Program Review

Ms. Heather Johnson Huntley thanked Council Chair, Dr. Jerry Van Hoy for inviting her to provide a summary of the 2017-2018 University Academic Program Review Committee (UAPRC) Annual Report and to give areas of importance to think about. First she outlined the UAPRC membership, its purpose, and showed a diagram of its structure (PowerPoint presentation attached).

In spring 2017 Provost Hsu sought to close the feedback loop in the program review process. We wanted to show what was coming out of the process, include feedback and make the process more meaningful. The University Academic Program Review Committee consists of six faculty representatives, one of which serves as chair, currently Dr. Scott Molitor, and ex-officio members of Office of Assessment, Accreditation and Program Review. It is charged with summarizing the external report and program's response for the Provost. And secondly, it monitors follow-up on action items after review. Programs will be reviewed once every seven years as is required for graduate programs. The most current cycle began 2012-2013. The process starts with a program completing a self-study, external reviewers read the self-study, visit campus, and provide a final report. The program and the college dean respond to the external report. The UAPRC synthesizes the external report and program's response into a short document for the Provost.

The Provost and UAPRC leadership then meet with program leadership and appropriate college deans to determine a list of agreed-upon action items and a timeline for implementation. A written agreement formalizes these next steps, and the UAPRC then checks in at years one, three and six years to confirm actions are being completed as agreed upon.

The 2017-2018 report was distributed. The proposed action items came up with common themes:

Accreditation Faculty Students Identify issues
