Adjunct membership may be held by visiting and part- time faculty, part-time clinical or visiting appointees, and fellows, and For those professionals who would make a significant contribution to graduate education, research, and service. 	 May teach graduate level courses (excluding thesis/dissertation research); May serve on, but may not chair, Scholarly Project, Masters or Doctoral advisory committees and comprehensive examination committees. However, only Graduate Faculty members with doctoral degrees may serve on Doctoral advisory committees. Exceptions to this provision may be addressed with Special Membership status; but May not vote in elections pertaining to Graduate Council or graduate education matters.
