*recently granted 10 years continued accreditation by the Commission on the Accreditation of Athletic Training Education (CAATE)

*strong tradition of AT education



Impetus for Change

*May 2015- CAATE mandated the entry-level degree to be at the Master's degree level

*undergraduate programs are having a harder and harder time adequately preparing students for a rapidly evolving profession and healthcare environment

*the MAT presents an opportunity to build upon our foundation while also addressing short comings and barriers related to baccalaureate health profession education




Proposed Degree

School of Exercise and Rehabilitation Sciences in the College of Health and Human Service

*54 credits across 6 academic semesters *22 months to complete

*results in the granting of a Masters in Athletic Training (MAT)





MAT Program- Didactic Component

*foundational sciences will be completed prior to enrollment, thus students will be able to build upon these concepts

*opportunity for increased depth and breadth of clinical skills and knowledge







MAT Program- Clinical Education Component

*increased flexibility and opportunity for clinical education

*requirement for 2 periods of clinical immersion (16 weeks total)







MAT Program- Scholarly Project

*provides exposure to contemporary sports medicine research

*provides improved translation from laboratory to the clinical setting and potentially increase opportunity research at the point of care
