# **Academic Program Review at UT**

## **Purpose:**


- Preparation for external accreditations
- Provost steering committee for guidance for program review process
- Commitment to continuous improvement
- Expectation of the Higher Learning Commission
- Required by ODHE Chancellor's Council on Graduate Studies

#### Structure:

- Seven year cycle of review
- Programs prepare and complete a self-study
- External review of self-study
- Program response/action items



### **Process – Provost's New Vision**



# The charge to the UAPRC is to:

1. Develop and implement a process following external program review that will Generate a summary of the external review team's report and the program director's response and action plan. UAPRC works to collaborate with the program director and dean to establish action plan priorities to maintain program and HLC accreditation, continuous improvement, relevance to UT Strategic Plan.

Following this,

The UAPRC Chair will facilitate a meeting of the provost, program director, and dean at which the Committee's results for the program will be shared and a final decision will be made on action items and resources.

- 2. Develop and implement a process that will follow-up and document the status of the agreed upon action items at multiple points in time over the next six years and prior to the next scheduled program review.
  - Document status at years 1, 3 and 6
  - Provide feedback regarding the status of action items to the Provost, program director and dean.

## **Summary of UAPRC Role**

UAPRC role is limited to ensuring that the results of program review process are disseminated to and discussed by the appropriate parties. We review the information we are provided, which consists of the external reviewer report and the program's responses to this external review report. We distill this information down for our report to the Provost to discuss with the Program Director and Dean
