Force Platforms are used to record the forces that the body exerts against the ground during any type of activity when an individual is on his/her feet. When this is done independently from other types of analysis, the software that is used is the BioAnalysis software that comes from the force plate manufacturer. This type of analysis is commonly done for class lab activities as well as a part of student research. Presently we have one license for this software which is located on a computer in HH1412. We have recently started to use HH 1406 for many of the lab activities that utilize this system. Thus, at present, every time the system needs to be used in 1406 we have to move the computer that has the software from 1412 to 1406. This request is for a license for this software so that we can install it on a computer in HH 1406 for use by students in that location. **Thus, it will increase opportunities for students in lab classes and engaged in student research to use the force platform for studying human movement.**
