Impact on student learning:

The University of Toledo's Fast Track program (on-line program) serves students who are practicing preschool teachers who have obtained an Associates Degree and are completing the course work for a Bachelor's Degree in Early Childhood Education. Throughout the Fast Track course of study, students are required to video tape their teaching in order to share with one another their classroom practice, reflect on their own practice, and to collaborate in lesson studies. It is essential that Fast Track students have access to video cameras to complete their course work and ultimately to learn about their own and others' teaching practices in early childhood. Most importantly, this technology helps them to improve their classroom practice and therefore impacts not only their teaching but also the lives of the children and families they serve.

Included in each of the learning modules (courses) is a significant focus on field-based assignments that have been created specifically to help pre-school teachers translate what they learn into what they do as early childhood teachers in the classroom.

There is extensive evidence to suggest that field experiences enhance the quality of early childhood teacher education (Whitebook, Gomby, Belm, Sakai, & Kipnis, 2009). However, field experiences are difficult for non-traditional students to complete and prohibit many early childhood professionals from completing a traditional bachelor degree program. One of the key dimensions of the field experience is the ability to teach and receive high-quality performance feedback about one's teaching (Whitebook et al., 2009). The EC Fast-track program has integrated field-based experiences into the program in the form of job-embedded professional development. In this program, each semester students complete 7-semester hours of field-based assignments. Students are supervised by faculty via videotaped assignments that provide documentation of their teaching practices. Faculty assigned to teaching the module will provide specific and detailed performance feedback for each field-based assignment. Videotaped assignments are consistent across learning modules, permitting faculty to track changes in student performance and allowing students to learn via familiar requirements, thereby increasing their comfort and confidence levels.
