The RIDE program is a subscription based service, so an annual purchase would be necessary. Each license can only be used by one user who will be provided a log-in and password that will be their's alone. The licenses can be used by anyone that needs the program, no need for them to be teachers, administrators or other school professionals. If the graduate students can make use of the program for their internships, that is great. The annual fee for a 20 user license is \$720.95, or individual licenses can be purchased for \$82.49.
