Provide a brief description of the technology requested*: Otoscope and Ophthalmoscope attachments are used during the evaluation of ear, eye, nose and/or facial injuries. Both are interchangeable attachments to be used with rechargeable handles. Vacuum splints are used to immobilize/stabilize a suspected fracture or injured extremity so that the patient may be transported. They work by forming a moldable but rigid splint around the injured area when the air is removed using a manual air pump.

Briefly describe how the technology will be used (function)*: All three pieces of equipment which are now mandatory skills which are needed for students enrolled in our Athletic Training Education Program. Our accreditation standards require that students are instructed on the proper use of such equipment as well as provided the opportunity to practice with actual equipment during their classes. All three items are consistent with equipment used in current athletic training practice, therefore our students will be exposed to and given the opportunity to work with equipment that they will encounter and use during actual clinical practice.

Provide a rationale that Tech Fee funds are appropriate for this request*: These items are in the category of capital equipment and will be used in a variety of classes over the entire ATEP curriculum. Per CAATE accreditation requirements, AT laboratory equipment should be working and up to date with current athletic training practices so that students are given real-life experience. These experiences will keep our UT students competitive for jobs in the current healthcare environment.
