Many of the classrooms in the HHS Building are mediated and functioning well. However, the courtroom was initially outfitted in 2004 and there is a desperate need for a more-up-to-date technology infrastructure in the courtroom before it becomes obsolete.					
Briefly describe how the technology will be used (function)*:					
A new infrastructure would: (a) allow images from separate sources to be displayed, for example, showing an image or power point for classroom instruction, showing an image from the evidence camera, showing a video or still photograph from a laptop, a limiting instruction in PowerPoint from the judge's computer; and so on (b) facilitate conversion from analog to digital equipment, (c) reduce future overhead and maintenance costs, (d) provides UT with a competitive advantage and allow students to receive the proper training needed to compete in the marketplace, (e) allow students to bring their own devices such as iPads, cellphones, laptops, and other electronic devices into the McQuade Courtroom.					

Provide a rationale that Tech Fee funds are appropriate for this request*:

As stated above, an up-to-date technology infrastructure in the courtroom would benefit many students across curricula. This is the type of technology that students want to see their tech fee dollars utilized for.
