This request is to put in place the Echo360, equipment specifically tailored to capture classroom lectures and student presentations for secure, flexible viewing from internet platforms such as Black Board in the primary classroom of the Criminal Justice Department. The request includes necessary hardware and software licensing.

Briefly describe how the technology will be used (function)*: This system will be used to simulate real life forensic interviews and interrogation situations in multiple environments. They will be used to teach required investigative skills, and provide imperative practical experience. Additionally, the students will use the and engage in evidence collection. The field of Crime Scene Investigation and Reconstruction is an ever evolving field of the criminal justice system. These Forensic bodies are an essential piece in the utilization of the current and future criminal justice technology.

Provide a rationale that Tech Fee funds are appropriate for this request*:

The Echo360 technology system is a valuable learning tool for students outside the classroom. This system allows students to gain access to lecture captures at any time, helping accommodate many students' different learning styles. There are several advantages of having this in the classroom (in addition to faculty offices): students can review lectures they attended, clarifying what is in their notes or re-listening to concepts they didn't catch the first time around. Furthermore, instructors can record lectures for students to view in preparation for in-class learning activities (flipping) making use of a "live audience" or guest speakers that can't be accommodated in the personal capture approach. In either case, students can review lectures when studying to reinforce concepts, Students can use the system to record presentations for class projects, allowing greater flexibility in formats to demonstrate their learning. Therefore, this makes the classroom environment more accessible and beneficial.

Provide a rationale that Tech Fee funds are appropriate for this request*:

The equipment will be used for student instruction and student projects. Its installation will impacts all students enrolled in the Criminal Justice program. The submission of the request stems directly from student feedback.
