Notes: Students must complete at least one course from area 4 and one course from area 5. Students must also complete at least three semester hours in each area. Total number of semester hours from clinical areas 1 through 5 should equal a minimum of 20. Students will note that some courses are cross-listed under both areas 4 and 5. Students need to understand that they must take a course that is clearly used to meet area 4 and a separate course that is clearly used to meet area 5. Students are prohibited from taking a single course and using it to meet both area 4 and area 5.

Counseling Internship credit hours must be in addition to the eight (8) Counseling Internship credit hours that are required as part of the Master's Degree. Some courses listed above may be offered more frequently through UT's Distance Learning program. Please check with the Distance Learning folks at http://www.utoledo.edu/dl/. The Department reserves the right to alter, change, or amend this schedule as necessary and appropriate.

After completing the required courses, individuals may apply to sit for the licensure examination. Upon successfully passing the examination the individual receives the Professional Counselor license. If the individual then works for two years in a clinical setting diagnosing and treating mental and emotional disorder under the supervision of person acceptable to the Board, the individual can receive the Professional Clinical Counselor license.
