DISPUTE RESOLUTION CLINIC (indicate 2 or 4 credit hours)

This is a (2) _____ or (4) _____ credit-hour course in which students serve as mediators in a variety of cases in the Lucas County Juvenile and Toledo Municipal Courts. This fieldwork experience provides the students with actual hands-on training in the rapidly expanding field of Alternative Dispute Resolution. Students in the clinic are educated in both theory and practical skills through coursework, classroom discussion, and exposure to practitioners in the field of mediation. The weekly classroom component focuses on listening and communication skills, mediation and negotiation techniques, and the role of the parties in Alternative Dispute Resolution.

Students taking the course for (2) credits are required to spend (4) hours per week in court. Students taking the course for (4) credits are required to spend (8) hours per week in court. Students are required to attend class twice per week for the first half of the semester. Classes will meet only periodically during the second half. Students are not required to be certified as legal interns. The clinic is open to all second and third year law students.

NOTE: Students are required to attend and participate in up to 4 days of mandatory mediation training PRIOR to the start of semester. Students interested in the Fall 2019 term MUST BE AVAILABLE for MANDATORY TRAINING APRIL 12-13, 2019.

ADVANCED DISPUTE RESOLUTION CLINIC

The Advanced Dispute Resolution Clinic is a (2) credit-hour course available to students who have successfully completed and excelled in the Dispute Resolution Clinic and wish to further their exposure to ADR. Students will observe and mediate in more complex cases in various courts throughout Northwest Ohio.

PLEASE NOTE: Enrollment in the clinic offerings is limited. Acceptance is determined by the clinical faculty on a case by case basis.
