

Rebecca Zietlow Named Associate Dean for Academic Affairs

Professor Rebecca Zietlow began her tenure as associate dean for academic affairs on Jan. 1, 2022. Zietlow joined the College of Law faculty in 1995. She is a Distinguished University Professor and the Charles W. Fornoff Professor of Law and Values. She teaches in the areas of constitutional law, federal courts, and constitutional litigation.

Zietlow is a leading expert on constitutional theory, examining constitutional interpretation outside the courts, and is an acclaimed author with books that span the intersection of law and history. In her most recent book, "The Forgotten Emancipator: James Mitchell Ashley and the Ideological Origins of Reconstruction," she uses Ashley's life as a unique lens to explore the ideological origins of Reconstruction and the constitutional changes of this era.

In 2020, Zietlow was elected a fellow of the American Bar Foundation. She received the University's Creative and Scholarly Activity Award in 2018 and the UToledo Outstanding Faculty Research and Scholarship Award in 2012. She formerly served as chair of the Association of American Law Schools' Section on Constitutional Law and its Section on Women and Legal Education.

"I'm so happy to have this opportunity to work with the faculty and staff at the College of Law and help enhance our educational program and the students' experience with us," Zietlow says.

Zietlow earned her B.A. in political science, summa cum laude, from Barnard College and her J.D. from Yale Law School.

Ken Kilbert to Retire in December 2022

Professor Kenneth Kilbert is retiring at the end of this year. To celebrate his contributions to Toledo Law and the community, the College of Law hosted a retirement party for Kilbert in May.

In 2006, Kilbert joined the College of Law faculty. He served as associate dean for academic affairs from 2012 to 2015, received the University's Edith Rathbun Outreach and Engagement Excellence Award in 2018, and the College of Law's Outstanding Professor Award in 2022. He has taught in the areas of environmental law, natural resources law, administrative law, civil procedure, conflict of laws, and water law.

Kilbert has served as the director of the Legal Institute of the Great Lakes (LIGL), a multi-disciplinary research center within the College of Law. Every fall, the College of Law hosts the Great Lakes Water Conference (GLWC) in conjunction with the LIGL. Since 2006, Kilbert has organized and run this major event, which annually attracts hundreds of attendees. This year, Kilbert will continue to serve as director of the LIGL and will organize and host the 22nd annual GLWC before officially retiring.

Prior to joining the faculty at Toledo Law, Kilbert was in private practice for more than 20 years, focusing primarily on environmental litigation. Kilbert is former chair of the Pennsylvania Bar Association's Civil Litigation Section and its Environmental Litigation Committee. He taught as an adjunct professor at the University of Pittsburgh School of Law from 2001 to 2006.

Kilbert earned his B.A., summa cum laude, from Bethany College and his J.D., magna cum laude, from the University of Pittsburgh.

Students and Alum Take Action to Support Ukraine

Alona Matchenko, an international law student from Ukraine, was moved to do whatever she could to help those back home. Alona and fellow student Hope Luther founded the non-profit Toledo Helps Ukraine (THU).

Alona and Hope made significant strides with THU to reach their goals: 1) raise awareness, funds, and supplies to help Ukrainians, 2) welcome Ukrainians to northwest Ohio, and 3) directly assist in rebuilding. Andrea Young '16 was inspired to help when she met Alona. Andrea helped turn her office into a donations drop-off site and invited Alona to speak about THU on the Charles Boyk Law Office podcast, "Boyk Brief."

THU collected over \$100,000 in humanitarian aid for Ukraine, partnered with Feed My Starving Children to prepare over 163,000 meals, coordinated 10 donation sites throughout northwest Ohio, met with Ohio Governor Mike Dewine, attended the Ohio Summit on Ukrainian Refugees, and more.

In May, THU partnered with Block Communications to embark on a 3-week humanitarian trip to Ukraine and surrounding border countries. From purchasing supplies to walking across the border to distribute them, the trip was harrowing. "The aide went to families whose husbands or adult males were drafted and sent to the frontlines," says Alona. "Many other supplies were distributed to military bases. Also, our medical supplies were delivered to military hospitals."

"The war seems far from over. So much of Ukraine needs rebuilt," Alona says. "With the courage, generosity, and good will of people like you, we believe a brighter future will be coming to Ukraine. Thank you."

Launch into Law Provides Opportunity

Toledo Law hosted its fourth cohort in its pipeline program that helps historically underrepresented and minority students prepare for law school. The weeklong immersive program consists of test-taking strategies for the LSAT, enhancing legal writing skills, enhancing legal analysis skills, and connecting directly with student and professional mentors to explore legal career paths.

"Programs providing a pipeline to law school are critically important in addressing educational opportunity gaps and increasing the diversity of the legal profession to better reflect our multifaceted communities," said Amber Chuhy, assistant dean for admissions. "They provide individuals from a variety of backgrounds with access to a legal career."

The 2022 cohort represented a diverse group of students including participants from Ohio, Michigan, Indiana, and the Democratic Republic of Congo. Some participants have careers and are considering a new path and others are looking to attend law school following their undergraduate studies.

While there are several benefits to participating in Launch Into Law, one of the easiest to measure is the students' LSAT scores. This year, students' scores increased by an average of 6 points, with some achieving as much as a 9-point increase. Students who complete Launch Into Law are also granted a one-time \$1,000 scholarship to Toledo Law.

"At the end of the week, one student told me that he never thought law school was a place he could belong but by the end of the week, he felt completely empowered that there was a place for him in law school and that this was a journey he should complete. That is what this is all about: breaking down barriers and empowering students to understand that they are capable and to provide them with some tools to start or continue their journey to law school and the legal profession," said Brandy Brown, assistant director of law admissions.

Toledo Law held an in-person commencement celebration on May 8 in Savage Arena, where 70 law candidates and graduates were recognized.

Kelly Goldstein '07 was the commencement speaker and delivered remarks. Goldstein worked in private practice at Snell & Wilmer's Phoenix office for over 14 years, including over six years as a partner at the firm and



recently transitioned to a new position as bar counsel for the State Bar of Arizona. She was the valedictorian of her law graduating class and served as editor-in-chief of The University of Toledo Law Review.

UToledo Trustee **Stephen P. Ciucci** conferred degrees.

Daniel Roy and **Brigitte Schultz** received the Valedictorian Award and served as student speakers.

Roy served as executive editor of Law Review, was vice president and treasurer of Sports Law Association, and was secretary of Labor and Employment Law Association. Schultz graduated with a J.D./M.B.A. joint degree. She served as articles editor of Law Review, was a class representative of the Student Bar Association, and was a member of Delta Theta Phi.



Maria Zirbel received the Dean's Award, which honors the graduate who has made the most significant contribution to the college while maintaining high academic performance.

Zirbel was a contributing articles editor of Law Review, vice president of the National Lawyers Guild, and a member of the Animal Legal Defense Fund Student Chapter and Women's Law Student Association. She was a public interest law fellowship recipient and received the Student Bar Association Involvement Award.

Professor **Ken Kilbert**, who is retiring, was honored during the event and delivered the faculty welcome.

The graduating students selected professor Ken Kilbert as the recipient of the Outstanding Professor Award for Dedication to Legal Education and professor Eric Chaffee received the Beth Eisler First Year Teaching Award, which is chosen by the first-year class.














THE YEAR IN REVIEW



Former professor's passion inspires \$1 MILLION SCHOLARSHIP GIFT



Professor Emeritus Michael Kadens (1976-2000) isn't shy about expressing the most meaningful destination for his philanthropic support — The University of Toledo College of Law. Though many worthy institutions have played important roles in his life, when thinking about the countless opportunities the college afforded him throughout his career and where his philanthropic dollars can make the greatest difference, Toledo Law is his clear priority.

"I am very thankful for the quality education and legal training I received for my undergraduate degree and law school," Michael remarked, "but if I give to my alma maters, my gifts would be tiny drops in very large buckets. I feel like my gifts to The University of Toledo College of Law have a much larger relative impact. I can't overstate how much

Toledo Law gave me over three decades — a wonderful career teaching students, rewarding relationships with colleagues, and the opportunity to support the college's overall success."

While Michael was serving the College of Law, the lives of the four Kadens children were also being shaped in ways that were imperceptible at the time, but have proven to be profound. Michael and his wife Judith's youngest son, Peter, recounts how UToledo was a major part of his childhood, attending nearly every basketball game with his parents at Savage Arena, participating in College of Law softball games, and attending moot court competitions. He also recalls encounters with history-makers such Sandra Day O'Conner when she spoke at the University, and Robert F. Kennedy Jr., who he was tasked with picking up from the airport for a speaking engagement when he was only 17.

"The University of Toledo College of Law gave me great exposure and my parents ensured that I participated in events that could open up my aperture to see the world in a different light," Peter explained. "In 1985, the College of Law granted my father a six-month academic sabbatical that forever changed me. While my father did his research, our family traveled to many countries. I saw the world through such a unique lens after that journey. My little eight-year-old brain was on fire with revelations about poverty, alternate political regimes, and the squalor and splendor of the world outside of my little bubble in Toledo. I have absolutely no doubt that without that journey I would be a shell of the person I am today."

Foundational experiences like these, in concert with Michael and Judith's investments of mentoring and education, have yielded significant and varied fruit in the next generation of their family. For Peter, this has meant a family of his own and recurring entrepreneurial success in startup ventures, including SoCore Energy, which he sold to Edison International, and GreenThumb Industries, which is now the second largest cannabis company in the world.

True to the values Michael and Judith instilled in their children, Peter is now turning this financial resource back into opportunities for others through major philanthropic investments in higher education for students and their families in at-risk school districts in Chicago and Toledo. As the pandemic held its grip on the world, he also sought a way to honor his parents for empowering him and his siblings to succeed in life and make a difference in the world.

Given Michael's enduring affection for The University of Toledo College of Law and the opportunities his career afforded their family, it was a natural partner. In the summer of 2021, Peter approached The University of Toledo Foundation about setting up a 10-year scholarship to advance social, economic and cultural diversity at the College of Law. The result is a \$1 million gift stablishing the Michael and Judith Kadens Scholarship for Diversity in Legal Practice Fund, which focuses on first-generation college and law students who have financial need. Special preference is given to graduates of Toledo-area high schools.




Clifton Porter Washington D.C.

NEW DONOR **FUNDS**

New Funds

Alumni and friends of Toledo Law established new ways to invest in the education of future lawyers. Many funds honor people who have been Difference Makers in the Toledo Law community and others seek to better meet the needs of students. All are committed to enhancing the educational experience at Toledo Law.

Newly established funds this year include:

Professor Benjamin Davis Black Law Student Association Guest Speaker Fund

Provides resources for the Black Law Student Association to bring in speakers on the topic of racial justice. Initially established by an anonymous donor, the fund already supported its first guest speaker. Because the event was successful, the founding donor was inspired to provide an additional matching gift, which was fully redeemed by a group of 21 additional donors.

Facility Improvement Fund

Established through the contributions of two individual donors to provide the Dean with resources to refresh the physical learning environment of the college. A portion of the funds are being deployed to complete minor classroom upgrades.

Dean Phillip J. Closius Law Scholarship

A group of alumni honored former Dean Closius by supporting future students in his name. All the donors who contributed have shared stories about how Dean Closius personally invested in their success and significantly impacted their lives. This fund was established with the intent to endow and is approximately halfway toward the \$25,000 minimum endowment threshold at the time of publication.

Newly Endowed Fund

Endowed funds are a special category of fund that benefits students and the college by their growth, rather than through direct contributions. Endowed donations become protected from expenditure, making them perpetual assets that produce earnings to support our mission year after year. Over the past year, one fund was newly endowed at the time of publication.

Toledo Women's Bar Association Scholarship

Established to further advance the participation and flourishing of women within the legal profession. The Toledo Women's Bar Association conducted a campaign among its members and within the legal community to reach the \$25,000 minimum endowment threshold, which they achieved in May 2022. A check was presented to Dean D. Benjamin Barros at TWBA's annual meeting.
