**Penelope (Penny) Andrews**, professor of law and co-director, Racial Justice Project, New York Law School

PENELOPE ANDREWS joined New York Law School in January 2019 and teaches comparative and international law courses and serves as co-director of New York Law School's Racial Justice Project, focusing on international and South African issues. She taught at La Trobe University in Australia, CUNY School of Law, and as visiting appointments at U.S. and abroad law schools. Andrews was the first Black dean at the University of Cape Town Faculty of Law and first female dean of Albany Law School. She is the editor of several journals, published several books and articles and received many awards. Andrews served on law school committees, boards of public interest and human rights organizations, and is the president of the Law and Society Association.

#### **Hiro N. Aragaki**, professor of law, Loyola Law School Los Angeles

HIRO N. ARAGAKI is a professor of law at Loyola Law School Los Angeles and a professorial research associate at SOAS School of Law in London. In addition to his work as a neutral and a scholar, Professor Aragaki has frequently been called upon to provide ADR training and reform advice in Asia and Africa. He holds degrees from Yale, Stanford, and Cambridge, and is dual qualified in the U.S. and U.K.

**Attila Bado**, professor of law, director of the Institute of Comparative Law and Legal Theory, University of Szeged, Hungary

His main areas of research are comparative law, judicial independence, and the administration of justice. Professor Bado has been the recipient of many distinctions, including the Pro Scientia Gold Medal, awarded by the Hungarian Academy of Sciences for excellence in mentorship and commitment to undergraduate research activities, and he also received the French honorary title of Officer of the Order of Academic Palms (Ordre des Palmes Academiques) for his contributions to academics and education.

Previously, she was a professor at The University of Toledo College of Law, an associate professor at the University of Kansas School of Law, and visiting associate professor at the University of Michigan Law School. She teaches constitutional law, criminal law, criminal procedure, sentencing, and race and American law, and has also taught comparative criminal procedure. Professor Exum writes mainly in the areas of federal sentencing and policing reform, with a focus on racial justice.

Formerly an AUSA in the U.S. Attorney's Office for the District of Columbia and a corporate and securities associate with Shearman & Sterling in NYC. Elected member of the American Law Institute, executive committee of the Civil Rights Section of the Association of American Law Schools, and the Board of Governors of the Society of American Law Teachers. Farley's recent work has appeared in Duke, Cambridge, Cornell, Carolina, and the New Press anthologies and elsewhere.

#### **James P. George**, professor of law, Texas A&M University School of Law

PAUL GEORGE is a faculty member at Texas A&M University School of Law in Fort Worth, Texas, where he teaches civil procedure, conflict of laws, and international litigation. #### Dr. Jeremy I. Levitt, Distinguished Professor of International Law, FAMU College of Law

JEREMY LEVITT was the first Black male law dean in Canada, first African-American dean in any discipline. Founder and president of the Stono Institute for Freedom, Justice and Security. Dr. Levitt is a pioneering internationally recognized public intellectual, legal scholar, international lawyer, political scientist and global administrator with a rare combination of experiential and theoretical training and experiences. Author and editor of six books and numerous scholarly works. Fulbright scholar (University of Ottawa). Appointed Head of the International Technical Advisory Committee (ITAC) (2009-2010) of the Truth and Reconciliation Commission of the Republic of Liberia (TRC) by Ellen Johnson-Sirleaf, President of the Republic of Liberia and Africa's first elected female president. Visiting fellow, Lauterpacht Center for International Law at Cambridge University. Elected Member, American Law Institute. Executive Council, American Society of International Law.

## **Terry Lodge**, Ohio lawyer and activist

TERRY LODGE has 50 years' experience as an activist and civil and environmental rights litigator. As a field attorney for the Community Environmental Legal Defense Fund since 2014, he's worked to gain ballot access for grassroots initiatives proposing controversial local laws such as the rights of nature and control of the commons. He's opposed nuclear power and weapons, corporate welfare, mountaintop removal mining, fracking, and has supported free speech and diversity in the workplace. He's been recognized by the Alliance for Nuclear Accountability, received an Access to Justice Award, and is a past Ohio Civil Liberties Union Champion.

**Beth Lyon,** clinical professor of law, associate aean for experiential education, and clinical program director, Cornell Law School

Dr. Mittal was formerly Dean In-charge of the Unitedworld School of Law, India and a former faculty of law in the National Law University Odisha, India. He has also worked with the Hon'ble Chief Justice of India in the Supreme Court of India on invitation. He completed his Ph.D. from NLUO in the field of access to justice for the rural poor. Dr. Mittal has worked in more than 150 villages of India as part of several research and empowerment programs for women, children and disadvantaged groups and indigenous population. Dr. Mittal has delivered lectures and presented paper on Access to Justice in Miami Dade College Florida (USA); Georgia State University, College of Law (USA) and Barry University, Orlando. Dr. Mittal has also spoken in Loyola University of Chicago School of Law; Atlanta International Arbitration Society, Georgia; Northwestern University School of Law, Chicago; and Toledo University College of Law, Ohio.

## **Todd D. Rakoff**, professor of administrative law, Harvard Law School

TODD RAKOFF graduated from Harvard Law School in 1975, and joined the faculty in 1979 after clerking for Hon. Henry Friendly and practicing in Boston. He teaches contracts and administrative law, has been Dean of the J.D. Program, and is presently the Byrne Professor of Administrative Law. Since the mid-1980s he has been one of the editors of Gellhorn and Byse's Administrative Law.

Professor Rakoff has been actively involved in many of Harvard's educational experiments and reforms of the last quarter century, including the experimental integrated curriculum of the 1980s, the move to smaller first year sections in the late 1990s, and more recently the development of first-year experiential courses. He has also organized programs for teachers around the country, through the Association of American Law Schools, and internationally, through the parallel international association.

**Geoffrey Rapp**, senior associate dean for academic affairs and Harold A. Anderson Professor of Law and Values, University of Toledo College of Law

GEOFFREY RAPP joined the College of Law in 2004 and serves as Harold A. Anderson Professor of Law and Values and senior associate dean for academic affairs. He was named 2013 Outstanding Faculty Member by the College of Law alumni association. In 2016, he was one of three faculty members from across the University to receive the Outstanding Faculty Research and Scholarship Award. Professor Rapp teaches and writes in the areas of corporate law, torts, and the sports industry. His recent papers include publications in the North Carolina Law Review, Washington University Law Review, Georgia Law Review, Washington and Lee Law Review, BYU Law Review, and the Boston University Law Review. He wrote a Torts casebook published by Wolters Kluwerin 2020. In 2011, Professor Rapp testified before the U.S. Congress on the topic of Dodd-Frank whistleblower bounties.

DR. LINDA ROUILLARD, Ph.D. is the Chair of the Department of World Languages and Cultures and a Professor of French at the University of Toledo. She has published widely on medieval, renaissance, and nineteenth-century French literature, on images of race and gender, and has made numerous conference presentations in Europe and the Americas.

IRMA RUSSELL joined the faculty at UMKC in the fall of 2015 as the Edward A. Smith/ Missouri Endowed Chair in Law, the Constitution, and Society. Dean of The University of Montana School of Law (from 2009 to 2014) and as the NELPI Professor and Director of the National Energy-Environment Law & Policy Institute at the University of Tulsa College of Law. Former chair of the ABA Section of Environment, Energy and Resources, the AALS Section of Natural Resources and Energy Law, and ABA

Section of Professional Responsibility. Liaison of the ABA Section of Environment, Energy and Resources to the Center for Professional Responsibility.
