Scope and Content Note

All of the material in this collection was generated by Edward C. Ames's activity as a member of the Ohio State Board of Education. He did work concurrently as public relations director for Owens-Illinois, but nothing in the collection reflects that activity. The material in this collection, nevertheless, covers broad ground; virtually every subject which reached the Board's attention between 1957 and 1972 is documented through Board minutes, reports, publications, and news clippings.

In 1955, the 101st General Assembly enacted House Bill #272 which provided for an elected State Board of Education with twenty-three members. Each member was to represent one congressional district and would run for election on a non-partisan ticket. A Superintendent of Public Instruction, appointed by the Board, would act in a full-time administrative capacity. During Ames's tenure on the Board, Edward E. Holt and Martin W. Essex served as superintendents. Ames became the second member from the Ninth Congressional District in 1957, being responsible to his constituents in that Northwest Ohio district. He, thus, took a special interest in affairs there.

Although Ames, as a Board member, studied and voted on matters of statewide interest, researchers will probably find material relating to Northwest Ohio issues of greatest interest. One of the more enduring was that of the Spencer-Sharples School District. A poor, predominantly black district west of Toledo, it was for years barely capable of functioning. Eventually it was added to the Toledo School District, but not without legal problems. During this period, urban areas sprawled rapidly, and the annexation of the Washington Township School District by that of Toledo reflected this trend locally. Another issue was vocational education. One local development, well documented here, was the PENTA-County Technical School and PENTA Skill Center for Vocational Rehabilitation. Certain constituent mail and Toledo newspaper clippings document other issues of local interest.

The largest part of this collection consists of an almost complete run of the minutes of the State Board of Education. Meetings were held eleven times a year. The minutes of each meeting are kept within a folder together with the agenda for the following meeting and with the reports and recommendations of the State Superintendent of Public Instruction; each bearing the date of the following meeting. Frequently attached to the minutes and reports are resolutions and reports from local districts and miscellaneous other items. The Superintendent also passed memoranda to Board members, and these are fairly complete for 1968 to 1972. Correspondence includes both incoming and outgoing letters -- the most significant correspondents being Edward E. Holt and Martin W. Essex. Other correspondents are state officials and local school officials. The only major block of constituent mail is that from 1969 dealing with sex education.

The topical files consist mainly of mimeographed and photocopied reports written by the Board and by local school officials. If one can use bulk as a criterion for

significance, the most significant topical material deals with the reorganization of school districts, followed by the budget and then educational standards. Other important topics are vocational education, transportation to school, special education, urban education and minorities, and student rights. Finally, the clippings and publications in the collection, mostly of Toledo origin, document issues of particular concern to Toledo and Northwest Ohio.
